HOW ONE MAN TOLD THE TRUTH AND SAVED A COMMUNITY



Tony Mattivi was a federal prosecutor for more than 20 years and was the lead prosecutor on the capital case against the al Qaeda operative who masterminded the bombing of the USS COLE in Yemen in 2000. As the Assistant U.S. Attorney, he prosecuted the case of three southwest Kansas men who plotted to bomb an apartment complex in Garden City where Somali immigrants were living.

hat would you do if you knew about a plot to murder innocent people in your community? Especially if you knew that sharing this information with authorities could endanger your life?

Today's speaker, former Assistant U.S. Attorney Tony Mattivi, told how in 2016 Dan Day reported to law enforcement that three men were plotting to set off a car bomb at an apartment complex in Garden City where Muslims from Somali lived and worshiped. The men were members of a militia group who were upset with what they felt was an increase in "homegrown violence" in the U.S. The trio of Patrick Stein, Curtis Allen, and Gavin Wright began calling themselves the Crusaders. They decided that the Somalis were part of the

homegrown violence and began developing a plan to make and/or obtain explosives to carry out their plan. Their plan had become more focused, definite, and dangerous.

Building a case against the trio required more help from Day, specifically, as a confidential informant who would wear a hidden recording device while discussing the plot. With militia meetings taking place in remote locations such as farm fields or inside Wright's mobile home business with loud music in the background, agents couldn't be located nearby to monitor the conversations in real time. Day knew that if the trio learned he was an informant, they would likely kill him.

During the next few months the men made plans to manufacture a homemade explosive using ammonium nitrate, which is used widely in agriculture as a high-nitrogen fertilizer. They attempted to purchase hand grenades, mortars, blasting caps, and C-4.

Dan Day introduced them to "Brian," an FBI undercover employee who offered to provide the Crusaders with automatic weapons and explosive devices. The caveat was this: "Don't plant ideas," Mattivi said. "We don't create bad guys—if there's a crime we want to let them do it."

In October 2016 the men were arrested after a controlled delivery of 300 lbs of urea fertilizer was made. The trio were charged and, in 2018, a jury returned a guilty verdict against all three. And what about Dan Day? He testified for five straight days. He still has horrible PTSD. But he's a hero for taking a risk that ultimately saved many lives.
