We are especially committed to promoting clean water and sanitation, vaccination and disease control, mother's and children's medical services, economic development, literacy and education and peace everywhere in the world. Donations are made to non-profit groups for specific projects rather than general support of an organization. RCLA and it's Foundation have established guiding principles when considering requests for donations. The following is a list of those principles:

- Such projects must be non-political and non-sectarian
- Funds are not granted to organizations that practice any form discrimination
- Funds are not granted for salaries
- Funds are not granted to meet normal operating expenses (rentals, office supplies, vendor or legal fees, entertainment, transportation, staff meals, etc.)
- Funds are not granted to benefit individuals except for scholarships, which must be designated as awarded by RCLA either solely or in partnership with another grantor
- For international projects, wherever possible, RCLA partners with a local Rotary club to administer contributions
- No continuing grants are made. Annual contributions must be applied for and approved separately.
- Please indicate how the Rotary Club of Lake Arrowhead will be acknowledged during your project.
