Guest Speaker:

Introduction by PP Tony Williams (pictured on the right).

Mr Beale gave a wide ranging presentation on the challenges facing Barbados

and the possible solutions to alleviate the problems.

He cautioned that there were no "quick fixes."

In the context of Independence in 1966 he posited that we were all "drunk on the emotion of being independent which was also mirrored in the UK with getting rid of another colony which was not as economically viable as in the past."

Challenges:

We are small in size and because of our Gross National Income we have graduated from the "usual" concessional financing from the international financial institutions such as the World Bank.

As part of the OAS, we are linked with Latin and South America who have much larger economies and populations. We therefore have only a small share of the financing to the region.

Debt Forgiveness and Refinancing.

Over the past two years the government was able to negotiate new financing arrangement with its local and external creditors. This situation arises because of "over borrowing." This is only a short term fix. These payments are still to be paid over the long term.

Blacklisting by the EU

Other countries may deserve to be sanctioned because of their economic activities. However due to "lack of power" Barbados may be seen to be "unfaired".

We are aware of the requirements to satisfy the OECD and the EC. In their view, we have not complied in all areas.

Solutions:

The Twelve Month Welcome Stamp

This is a Tourism-led initiative which will go in some way to alleviate some of our foreign exchange problems. To date some 2,000 persons have applied and 1,500 have been approved Where possible we should mount initiatives to promote the benefits of the Welcome Stamp Programme.

The Barbados Yacht Club will be mounting such an initiative.

Education

Promote the speaking of Spanish and Portuguese to compete in Latin and South America.

CARICOM – Leadership structure

Prime Ministerial leadership changes every six months. This does not appear to augur well for continuity.
