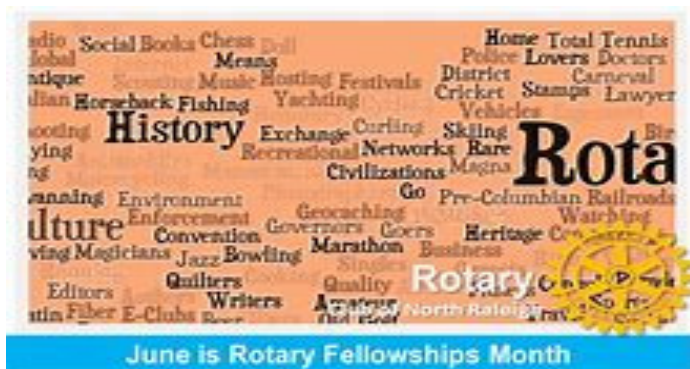

RECAP OF JUNE 13 2019– FELLOWSHIP MEETING

Last week's meeting was a fellowship meeting which turned out to be bigger than expected. Several members were abroad, and the scene was set for a small group however many more Rotarians and guests turned up, leading the Hilton staff to be forced to make additional preparations. The Club was visited by one of its former members, Annie Bertrand, as a guest speaker. She addressed the Club and presented information related to a collaboration between Compete Caribbean and the IDB.

She spoke about a facility which is looking to provide support to cluster initiatives.

The clusters need to be comprised of at least three private sector firms collaborating to increase competitiveness on the regional or international market. Cluster projects can include other entities such as educational, research or government agencies.

She indicated that Compete Caribbean will grant technical assistance for the selected cluster project(s) to a maximum of USD\$300,000 which must not exceed 80% of the total budget. The cluster must contribute a counterpart of 10% in cash and 10% in-kind. If short-listed, a professional consultant and market research will be accessible to support the project development process over a 3-month period.

This Cluster Development Plan (CDP) will be submitted to the Investment Panel who will select the projects on a competitive basis.

RECAP OF JUNE 13, 2019—FELLOWSHIP MEETING, CONT'D

The grant funds will cover consultancy services such as cluster management, training, market research, business development, process reengineering, research and development, etc. Grants will be allocated on a competitive basis and will require approval by an independent Investment Panel and by the IDB.

CALL FOR CLUSTER PROPOSALS

Open May-June 2019

Quick Fact Sheet

- What?** A cluster initiative worth US\$375,000 designed with the support of a professional consultant involving technical assistance grants of up to a maximum of US\$300,000. All applicants must submit the Application Form – Call for Cluster Proposals.
- Why?** To increase global competitiveness and positioning of products and services sold by private Caribbean firms.
- Who?** A minimum of three formal private sector firms collaborating with each other to expand exports.
- Where?** Antigua & Barbuda; The Bahamas; Barbados; Belize; Dominica; Grenada; Guyana; Jamaica; St. Kitts & Nevis; St. Lucia; St. Vincent & the Grenadines; Suriname; Trinidad & Tobago.
- How much?** Compete Caribbean will grant technical assistance for the selected cluster project(s) to a maximum of USD\$300,000 which must not exceed 80% of the total budget. The cluster must contribute a counterpart of 10% in cash and 10% in-kind. If short-listed, a professional consultant and market research will be accessible to support the project development process over a 3-month period. This Cluster Development Plan (CDP) will be submitted to the Investment Panel who will select the projects on a competitive basis.
- How?** The lead firm or BSO must fill and sign the Application Form – Call for Cluster Proposals, which must be submitted online www.competecaribbean.org. Sign-up to the newsletter to stay informed about next steps.

New Committee Structure

Our new district committee structure takes effect 1 July. So as you prepare for the new Rotary year, work with your district leaders to adapt your training plans to this structure.

Here's a summary of the changes:

- **COMBINED:** The following committees are being merged:
 - District membership attracting and engagement committee become the district membership committee
 - Vocational service, youth service, Rotary Community Corps, and Rotary Fellowships become the community service committee
- **ELIMINATED:** The member benefit and district club service committees are eliminated.
- **REQUIRED:** The following district committees and subcommittees are now required:
 - Finance
 - Membership
 - Public image
 - Rotary Foundation
 - Grants
 - Stewardship
 - PolioPlus
 - Fundraising
 - Rotary Peace Fellows
 - Training

OBJECT OF ROTARY

The Object of Rotary is to encourage and foster the ideal of service as a basis of worthy enterprise and in particular to encourage and foster:

FIRST: The development of acquaintance as an opportunity of service;

SECOND: High ethical standards in business and professions, the recognition and the worthiness of all useful occupations, and the dignifying of each Rotarian's occupation as an opportunity to serve society;

THIRD: The application of the ideal of service in each Rotarian's personal, business and community life; and
