

Senator Alphea Wiggins is a graduate of UWI, gaining BSc Hons in Management Studies. She worked in the private sector in managerial and consultancy positions and at times served as Director on the Boards of CBC, Transport Board, and is currently on the YMCA Board. She was appointed Deputy High Commissioner to the UK 2014 to 2018. Appointed to the Senate by the Governor General in 2018 as an Independent Senator, and recently appointed as the Prime Minister's Special Envoy to Suriname; a lady whose background and experience gives credence to her invitation here today as Guest Speaker.

Fellow Rotarians, ladies and gentlemen, I invite Senator Alphea Wiggins to address us. The topic will be "The importance of her assignment to Suriname and opportunities for cultural and economic cooperation with Suriname."

RTN. JAMELLA CLASSIFICATION TALK

Property Manager of Margate Gardens Condominiums, a 44 unit complex located in Hastings, Christ Church, means having numerous responsibilities. These include but are not limited to, property maintenance, budget preparation, cost controlling, sales and marketing, rentals management, human resources, interior decorating, pool maintenance and project management; just to name a few. I've been in this field for approximately 6 years, before this, I was at the Barbados Hotel and Tourism Association where I was their Membership Relations and Research Officer. Apart from being responsible for the membership of the organisation, which included membership growth and retention, I was also responsible for niche market committees, that were referred to as product clubs. Two of those clubs in particular, were Romance and MICE (meetings, incentives, conferences and events), and being involved in them and planning their activities led to me getting internationally certified as a wedding planner by the Wedding Planners Institute of Canada (WPIC) and event

Further to the above, I've been in the wedding planning industry for approximately 7 years either working alone or as a subcontractor. I've been involved in planning and managing other events from my BHTA days and continue to do so; one of the events that I'm involved in every year is Mahalia's Corner which is hosted by the band 2 Mile Hill previously known as Nexcyx.

My background is in Tourism Management but wedding planning and events allow me to dive into my creative side. I enjoy both fields because there's never a dull day and I hate monotony. I'm someone that gets bored quickly.

With that being said, some of the challenges experienced in the wedding planning and events fields are the lack of appreciation for planners and persons wanting to undervalue your services because they don't understand the time, effort and money that goes into you as a planner being effective and efficient in executing your job. Unfortunately the lack of appreciation does not only come from clients but from persons in the industry. To give a quick example, we had a decorator in the industry charging persons \$50 to plan a wedding and she could not understand the damage she was causing by doing this. Another challenge I've encountered is that Barbados usually is 1-2 years behind in the trends and when we have destination brides, they tend to expect what's trending in North America and some of our suppliers can't always fill the order.

On a personal note, I was born in Barbados but I have Trini and Lucian roots, I have no biological children but I have 3 God children, 3 boys!!!! They keep me busy!!

I love children and love working with them.

I'm a naturally creative person but my passion is concept designing and decorating, anything decor related and I'm there!! So interior decorating, events, arts, anything along those lines, so it only made sense for me to do it as a profession. So, along with the others mentioned, I also do wedding and events decor, concept designing and interior decorating.

I love to travel and hopefully I get to go all the places on my bucket list sometime in the near future!

I love the sea but cannot swim! I'm probably excellent at drowning..... but I don't think I would like to find out if I am.

And last but not least, I joined Rotary because I had the urge to give back and to be a part of something that endeavoured to make the world a better place. I was involved with community groups in the past, I was parish ambassador for St. Michael a few years ago and I wanted to continue to be involved. So after researching, visiting some clubs and talking to persons, the stars lined up and I met Director Makonem. We started to talk and...... Here I Am! Thus far, I'm enjoying it and I appreciate the members granting me the opportunity to be a part of the organisation. I look forward to making my contribution.
