

# **Summary of the RCOB Meeting Held on November 17th, 2022**

President Tracy called the meeting to order at 12.35p.m.

SAA Randy welcomed the guests who were at the Hilton and online.

Pres. Tracey spoke on the Paul Harris Fellows by giving an introduction to what Paul Harris Fellow Awards are about after welcoming those Paul Harris Fellows who were present and online.

The Rotary Foundation acknowledges individuals who contribute or who have contributions made in their name of US \$1000 to the Rotary Foundation. Rotary established the recognition in 1957 to encourage and show appreciation for substantial contributions to what was then the foundations only program. Past Paul Harris Fellows included past area director Alison Brush who served during the 1937 to 38, longtime Rotary International Treasurer Rufus F. Chapin for donations made in 1946. Ms. Aiden Vargas was the first woman to receive the recognition for a gift made in 1953. Mrs. Harry L Jones was the second and one of only five people recognized for our country for our contributions actually made in that inaugural year.

President Tracey listed many other fine examples of Paul Harris Fellowship Awardees including a donation in the name of Mother Teresa in 1980 and U.S. President Jimmy Carter. President Tracey asked the club to salute our Paul Harris Fellows and invite them to please stand to be recognized for their contributions to the work of Rotary.

President Tracey announced that will now be served buffet style we will please allow the head table to go first.

President Tracey asked PP David Antrobus to give us a talk on the aspect of the Rotary Foundation that we don't hear a lot about and it's something that she finds very interesting. The talk was on the Cadre of technical advisors and those are the volunteer Rotarians who assist with the evaluation of grants. It was a very informative talk and included a discussion on how he came to perform the role and his experience. The cadre are a group of volunteer Rotarians who volunteer their services possessing the professional expertise in the Rotary's areas of focus. Rotary has a group of cadres who are financial advisors who assist the Rotary Foundation with the evaluation of Rotary grants.

These technical advisors strengthen the impact of Rotary grants by assisting Rotarians planning projects and safeguarding Foundation funds.

Cadre are to take courses on the Learning Center to keep up to date and if the Cadre do not keep up to date, they do not keep them any longer as active.

President Tracey requested a round of applause for PP David Antrobus stepping up to the plate.

President Tracey asked the SAA to discipline the club. The SAA used the opportunity to ask a series of questions around Paul Harris Fellows and Society.

# Bio For our Guest Speaker Dr. Leo Brewster

Dr. Brewster is the Director of the Coastal Zone Management Unit (CZMU), Ministry Environment and National Beautification. He possesses a Ph.D. in Integrated Coastal Zone Management from Cardiff

University, Wales, U.K. With over 30 years of experience, he is very familiar with the development of management strategies and strategic planning for small Island Integrated Coastal Zone Management as well as rapid assessment

techniques for coastal impacts. He was recently elected (2021), Vice Chair of the IOC - UNESCO Intergovernmental Oceanographic Commission - Sub-Commission for the Caribbean and Adjacent Regions (IOC-IOCARIBE). He has a strong interest in projects related to climate change, impact on the ocean, ocean science, coastal resilience, coastal adaptation designs and new investment projects of interest to Barbados with a blue economy approach and defined focus. He is currently the Barbados Lead representative on several of the Commonwealth Secretariat Blue Charter Action Groups.


