### Awards for 2023 – a few interesting Stats

Here is a brief summary of the TBM awards for 2023. First, as always, every Rotarian commends all students that applied and interviewed last March. We realize the value of the time each student takes out of their busy work schedule to attend these in-person interviews. Rotarians are "blown away" by the amazing young people they speak to and we all look forward to following the recipients in their career.

The facts: Scholarships totaling of \$243,500 were awarded to 68 individuals; 50 of the recipients attend Florida International University Herbert Wertheim College of Medicine; 19 of this year's recipients received support for the first time; and finally, over 60% of the recipients were women.
