Hot Stove Luncheon

Matt Williams, Gil Heredia and Bob Gebhard

Following a two-year stint as manager of the Washington Nationals, Matt Williams was re-hired by the Diamondbacks as their third-base coach in November of 2015. Williams guided the Nationals to a 179-145 record in two seasons, including a 2014 playoff appearance which helped him in earning NL Manager of the Year. His coaching career began in 2010 when he was tabbed as Arizona's first-base coach. He was then re-assigned to the third-base coaches box from 2011-13. Williams starred on the diamond and gridiron at Carson High School in Carson City, NV. He later played baseball at the University of Nevada, Las Vegas before being selected by the San Francisco Giants as the third overall pick in the 1986 amateur draft. Williams spent 17 years in Major League Baseball, totaling 378 home runs and 1,218 RBIs in 1,866 games played. Williams' accolades include being a five-time National League All-Star, four-time Gold Glove Award winner, four-time Silver Slugger Award winner and World Series Champion with the D-backs in 2001.

In 2016, the Aces will feature a new pitching coach for the first time in franchise history with former pitching coach Mike Parrott being assigned to Short-Season A Hillsboro. Gil Heredia was officially named as Reno's pitching coach on January 5, 2016. This year will mark Heredia's first at the Triple-A level and eighth overall in the Diamondbacks organization. He held the same role with Short-Season A Yakima (2009), Rookie-Advanced Missoula (2010-12) and Single-A Advanced Visalia (2013-15) the previous seven years. Heredia pitched collegiately at the University of Arizona from 1986-87 and was a teammate of Arizona manager Chip Hale on the 1986 Wildcats' National Championship team. He was selected in the ninth round of the 1987 amateur draft by the San Francisco Giants and was teammates with Williams from 1991-92. Heredia earned 57 wins over 10 Major League

seasons, including a career-high 15 with the Oakland Athletics in 2000.

Bob Gebhard enters his 12th season with the Diamondbacks in 2016 as the Vice President & Special Assistant to the General Manager. In 2012, Gebhard received the Roland Hermond Award from the Society of American Baseball Research (SABR) in recognition of his contributions to the community of professional scouts. In 2011, he was named the recipient of the Sheldon "Chief" Bender Award, as announced by Minor League Baseball. The award recognizes an individual with distinguished service who has been instrumental in player development, has established good relationships with their organization's affiliates and is well respected in the baseball community. Gebhard joined the D-backs prior to the 2005 season after a five-year stint in a similar role with the St. Louis Cardinals. Gebhard had an 11-year playing career as a pitcher that included big league stints with the Minnesota Twins and Montreal Expos. A native of Lambertton, Minn., Gebhard starred at the University of Iowa where he played baseball and basketball.

Rotary's conflict-of-interest policy related to individuals receiving grant funds requires that the applicant does not fit in any of the categories below:

Rotarian, including honorary Rotarian, employee of a club, district, or other Rotary entity, or of Rotary International; spouse, lineal descendant (child or grandchild by blood, legal adoption, or marriage without adoption); spouse of lineal descendants; or ancestor (parent or grandparent by blood) of person(s); employee of an agency, organization, or institution that partners with The Rotary Foundation or Rotary International; former Rotarian or honorary Rotarian who has terminated membership within the preceeding 36 months; person who is ineligible based on family relationship to a former Rotarian or honorary Rotarian, for a period of 36 months after termination of family member's membership.

PROFILE OF THE IDEAL SCHOLARSHIP CANDIDATE

In order to assist Rotary club and district selection committees in selecting outstanding Global and District Scholarship candidates, the Rotary Foundation has identified the following traits (in no particular order) that should be considered standard for any Rotary “ambassador of goodwill”. Each candidate does not need to possess all of the traits below to be a successful scholar, but those who possess more of the traits than other candidates are likely to be more successful “ambassadors”.

The ideal Global and District Scholar candidate:

- Possesses excellent leadership skills and potential
- Understands his/her award obligations, especially speeches to Rotary and non-Rotary audiences
- Has a proven record of success in his/her academics and/or vocation
- Is articulate and possesses good proficiency in the study country language
- Is well-groomed and has a professional appearance
- Has demonstrated a personal commitment to community service
- Is willing to participate in an outbound orientation seminar provided by the club or district
- Is interested in participating in and possibly identifying Rotary service projects while abroad
- Has well-defined and realistic goals
- Possesses maturity and seriousness of purpose
- Is an excellent public speaker, skilled with presentations to both small and large audiences
- Knows the history, culture, and politics of both his/her home community and study country
- Is diplomatic and articulate when discussing world affairs and sensitive topics
- Has concrete ideas as to how he/she will improve international understanding and world peace
- Has thoroughly researched his/her preferred study institution including alternative locations
- Is willing to study in a country that typically does not host international students
- Is interested in a study field that has a direct impact on the humanitarian needs of the world
- Intends to dedicate part or all of their personal or professional life to ideals of Rotary
- Is flexible and possesses a good sense of humor
- Is sincere about maintaining a lifelong relationship with Rotary after his/her scholarship period
