**Dr. Peter Reed**

*Director of the Sanford Center for Aging*

### **Aging in Nevada; Challenges and Resources**

Dr. Peter Reed is the Director of the Sanford Center for Aging and Professor of Community Health Sciences at the University of Nevada, Reno. Dr. Reed received his Ph.D. and MPH degrees in Health Behavior and Health Education from the School of Public Health at the University of North Carolina at Chapel Hill, and his BS in Sociology from the University of Kentucky, receiving a Bachelor of Science in Sociology.

Prior to joining the University of Nevada in 2014, Dr. Reed served as Chief Executive Officer of the Pioneer Network, an international non-profit organization, dedicated to promoting a culture of aging that is life-affirming, satisfying, humane and meaningful. He also served as President and CEO of the Center for Health Improvement, a national health policy research center, and as Senior Director of Programs for the Alzheimer's Association National Office, where he led the Association's Program Division in developing and delivering a wide range of care and support programs for people living with Alzheimer's in communities nationwide.

Dr. Reed is committed to contributing to the larger knowledge base in the field of aging, as well as to community service at all levels. As a frequent author and public speaker, Dr. Reed has published over 50 papers, monographs and book chapters in peer-reviewed and


