Venue Committee Report

President Bill asked me to give a report on behalf of the committee he assembled, which includes Bill, myself, Marlene Olsen, Debe Fennell, Kurt Mische, Harvey Fennell, Carl Fuetsch and Phil Mahoney, to enlighten the membership about where the process is today.

WHY: For at least 4 years or so, different Presidents of this club, along with a committee of different members have been exploring options for an alternative place to hold our weekly meetings in case Harrah's ceased to be available to us, which was precipitated by the company filing Ch. 11 bankruptcy. This action was also inspired by feedback that came out of Visioning workshops with club leadership and committee chairs beginning in 2010, including the leadership retreat last year. It was agreed that the issue of venue would be resolved this year, one way or another.

Many members are concerned about the declining state of our venue and that our membership numbers are falling, in part due to our present meeting location. While other properties have been investing heavily in remodeling their convention space, hotel rooms and casinos, Harrah's has not done any significant improvements for many years and does not have any firm plans to do so in the near future.

ACTION: Starting in August of last year, the committee began looking in to other locations that might be a viable option for the Club. The criteria included: be downtown, could accommodate up to 150 attendees, have adequate parking, (preferably covered), have a meal service that could accommodate us, stay under \$25 and have alternative meeting locations if the facility was booked.

If the property met the criteria, a club meeting was scheduled there. The first venue explored was the newly opened Renaissance Hotel. We held a meeting there on July 31st and sent out a survey afterwards to get membership feedback. The feedback was mixed and ultimately deemed not a viable option.

- 63 of the 88 members present answered the survey
- 60% gave the experience a 4 or 5 rating - 5 being best rating
- 8% gave the meal a 4 or 5 rating
- 42% said they would pay \$25-27 for that meal

The Eldorado was the second hotel property that appeared to meet the criteria and the Eldorado and the club committee negotiated for several months, with the Eldorado making many concessions to arrive at a mutual and agreeable package, thus a meeting was held there on January 8, 2018 and a survey went out to those who attended.

- 66 of the 80 members present answered the survey
- 65% gave the experience a 4 or 5 rating
- 57% gave the meal a 4 or 5 rating
- 64.% said they would be willing to pay \$25 for a similar experience

Other locations explored were the National Auto Museum, NV Museum of Art, Whitney Peak, McKinley Arts Center and Elm Estate, all of which either did not meet our criteria or didn't have the same viability as the Eldorado, and consideration of these venues has ceased. The committee has exhausted all possible locations and are at a point that a decision should be made.

COMMENTS FROM MEMBERS: The comments that have come out of the surveys, both for and against leaving Harrah's include:

For Staying:

Staff is friendly; Harrah's has been accommodating to the club's needs; no charge for AV; stores files for the club; food price is low; piano on site at each meeting; more than 40 years at this facility.

For Leaving:

Food is so-so (80% of attending members choose the salad option); convention center hasn't been renovated in more than 20 years, leading to widespread concern that with Reno becoming less of a casino town, Harrah's won't be investing in the property to any significant degree in the foreseeable future; shrinking membership; lack of attendance and lack of new members is a huge concern; we're not attracting executives and leaders in the community; parking garage is in disrepair; stairwell needs cleaning; smoke from casino is strong in convention center.
