Achievement Beyond Obstacles

Achievement Beyond Obstacles is a joint youth program with several Area 8 Rotary Clubs. High School counselors select seniors who have faced enormous challenges in their life, yet find a path to graduation. These students spend a leadership weekend with facilitators Dean and Rochelle Whellams obtaining financial aid education and help figuring out what their next step in life is.

Rotary scholarships to college or vocational school for selected students range from \$500 to \$2,500. This ABO luncheon is one of two Rotary luncheons honoring students from Washoe County schools from all different socio-economic backgrounds who have achieved success despite the obstacles in their way.

Every nominated student is invited to attend and bring a guest and we will hear a 3 minute speech from some of them about where they have been and where they are going. You won't want to miss hearing from these students and the impact Rotary is having in their lives.

She currently serves as the Executive Director of Seniors in Service, a private non-profit organization which sponsors and administers the Foster Grandparent and Senior Companion Programs of Northern Nevada as well as the Seniors in Service Respite Voucher Program. She has more than 15 years of experience working with intergenerational programs in Northern Nevada and 25 years of experience in the non-profit field. Mary was appointed to the Sparks Planning Commission in January 2017.

Mary holds a Bachelor's Degree in Business Administration from Montreat College (Montreat, NC) and a Master's in Justice Management from the University of Nevada, Reno. She has served as adjunct faculty at the University of Nevada, Reno, where she co-instructed a graduate course on Elders and Aging Populations in Corrections.

Ron Baumgarten

Ron Was born in Chicago on May 13, 1942. He graduated from the University of Illinois in 1964 with a BA degree in philosophy with minors in political science and finance and from the U of I Law School in 1966 with a JD degree. After graduation he married Aloha Herman and they left for California on their wedding night. There they had and raised 4 children who have been gainfully employed since they graduated college. Aloha and Ron celebrated their 52nd anniversary last year, shortly before she died from cancer.

After running his family retail and real estate development businesses for five years, Ron formed his own law firm in Los Angeles and practiced business/entrepreneurial/real estate law for approximately 45 years. He retired and moved to Reno approximately 5 years ago to help one of his sons start a manufacturing business. Upon their son returning to California, Ron and Aloha decided to remain in Reno as their permanent home.

While he was living in CA, Ron was introduced to a Rotary Club and joined the Auburn Downtown Club in approximately 2003. Upon moving to Reno and making up at many of the Reno Clubs, Ron chose to join our club. He has been very happy with the friendships he has made in the club and with the various activities he has assisted in. He has been a member of the TRF Committee since he joined our club and a co- chair of Mardi Gras for four years. He sat on the Board of Variety Boys and Girls Club, in the barrio in East Los Angeles for 27 years and served as its President for 8 years. He subsequently served on the Board of Directors of the Auburn Boys and Girls clubs for an additional 5 years before coming to Reno.

Ron is running to become a trustee of the RRF because he believes he can be beneficial to the Foundation both in increasing its basis and in assisting with its annual gifts. He was instrumental in the formation and operation of a similar Foundation for the Variety Boys and Girls Club in East Los Angeles. Dan Lofrese

Dan Lofrese was born and raised in Orange County, NY. He graduated from Fordham University in 1999, and has worked for Gabelli Asset Management Company (GAMCO), a diversified global financial services company with assets under management of \$34 billion, since 1998.

For 17 years back in Rye, New York, Dan had helped to coordinate the firm's Reno, NV and Palm Beach, FL offices. In 2015, he was asked to move to Reno to help continue to expand GAMCO's presence in the area (succeeding former Rotarian Jim Webster). He also spends several months of the year based out of the firm's Palm Beach office.

Dan and his wife, Camellia, were married last August. She is in medical school and is about to start her clinical rotations back east. However, upon completion, she is hoping to be placed for residency back in Reno.

Dan's hobbies include reading at home, reading at the office, and reading while exercising. On occasion, you may find him trying to squeeze in 9 holes at Montreux.

In addition to being a Rotarian, he is an Advisory Board Member for the College of Liberal Arts at UNR, a TMCC Foundation Board Member, and a Professional Advisor Council Member for the Community Foundation of Western Nevada.

Mike Reed

Mike grew up on a farm in California's Central Valley. After high school, he left the 110 cows and the 6,200 almond trees behind and went on to junior college. He subsequently earned a degree in economics at San Jose State and pursued his Ph.D. in economics at the University of Utah.

With an offer from the Economics Department at the University of Nevada, he joined the faculty in 1972. In 1983 he was named chair of the department. In 1992, he was named Dean of the business college at Nevada, a position he held until 2006 when he joined the Chancellor's staff as the Vice Chancellor of Finance for the Nevada System of Higher Education. In 2010, he retired from NSHE.

During his time at the university, Mike found time to be involved in northern Nevada. Over the years, he served as a member of the Reno Rodeo Foundation Board. He also served on the EDawn Board, and became president of Western Industrial Nevada and chair of the Board of the Greater Reno Sparks Chamber of Commerce.

He has been a member of Reno Rotary since 1994 and previously served on the Board. He has been a Rotary Reader at Lemelson Stem Academy since the program's inception. One of his proudest accomplishments is the period he served as a Big Brother, first meeting his Little in 2003 at what was then Sierra Vista Elementary School, now the Lemelson Stem Academy.

Kevin Carman

Kevin Carman was appointed as the Executive Vice President and Provost at the University of Nevada, Reno, on February 1, 2013. Dr. Carman oversees the university's eight academic colleges or schools, the Graduate School, the Division of Extended Studies, and University Libraries. He also has responsibility for the Office of Innovation and for Information Technology. In his role as Executive Vice President, he serves as the university's chief executive officer when the President is away.

Over the last six years, enrollment at the University has increased from 19,000 to ~22,000 students, with student diversity increasing each year. UNR has over 1,000 academic faculty employees, over 900 professional employees, and over 1,000 classified staff, in addition to several hundred other employee types such as graduate assistants, post docs, and letter of appointment employees. It has a total annual budget of approximately \$600M. With the growth of students, Dr. Carman has implemented bottom-up competitive opportunities for distributing 250 new faculty lines over the past five years. In addition, 135 new graduate assistantships, as well as several administrative staff and academic-advisor positions have been added.

Shortly after his arrival in 2013, Provost Carman established five-day academic "boot camps" (NevadaFIT) for incoming freshmen. The pilot program, led by the Dean of the College of Science, consisted of 48 students in Biology. NevadaFIT has expanded dramatically since then. Participation exceeded 1600 student in the fall of 2018 (~half of the freshman class) and now includes programs for all majors at UNR. NevadaFIT was recognized by the APLU in 2018 as one of five finalists for its "Degree Completion Award".

Carman has contributed to improving academics by leading a comprehensive revision of the undergraduate core curriculum, and establishing a UTeach replication program (NevadaTeach) for middle and secondary math and science teachers and launching online Master of Social Work, Community Health Science, Business Analytics, Accounting, and Cybersecurity programs.

In 2014 Provost Carman led a collaborative process to update the comprehensive Master Plan and Strategic Plan for UNR that included explicit partnerships with the city of Reno and the Regional Transportation Commission to bring the university and Northern Nevada community together. The Strategic Plan included goals and activities that are guiding the University's evolution over the coming years as well as metrics by which it will measure progress. Included in the plan is a strategy for moving UNR toward Carnegie R1 classification, which was realized in December, 2018. The R1 designation places UNR among the nation's premier research universities.

Carman is married to Dr. Susan Welsh and has two children, Glenn Carman and Sarah Carman.

Carman serves as chair of the City of Reno Sustainability & Climate Advisory Committee. He is a Fellow of the American Association for the Advancement of Science.

Leslie Farias

Leslie Farias is, a native Nevadan, graduated from the University of Nevada Reno with a master's degree in Speech Communication and just six years ago completed her second master's in Adult Education.

Leslie has specialized in various aspects of communications, beginning with a 10-year career teaching high school English writing and literature at Reno High School. After moving to Dallas, Texas in 1988, she founded Farias Business Communication where her focus turned to facilitating workshops in teambuilding and staff relations, presentation skills, business writing, business protocol, and adult training methodologies in the corporate arena. She is also known for her business writing workshops and coaching.

Leslie has also applied her significant knowledge of communication models to training judges throughout the U.S. and Canada in effective listening, gender differences in communication, and communication in the courtroom. Through her work with the National Judicial College here in Reno, she has also assisted in the design, development and training of judges who have become instructors of other judges in their respective states.

As the Director of Development for the National Council of Juvenile and Family Court Judges, she expanded her work and fundraising experience with the judiciary.

Leslie has been a keynote speaker for organizations such as Toastmasters, the Professional Saleswomen of Nevada, Texas Women's Bar Association, Dallas Women in Business, The Canadian Supreme Court Annual Conference, and the Businesswomen of Atlanta, to name a few.

Gayle Sherman

Gayle learned about Rotary as a small child in Kansas because her dad attended Rotary dinner meetings every Thursday night. In 1998, Gayle's high school daughter, Heidi, went to Sweden as a Rotary exchange student. Gayle's family has had the pleasure of hosting two international exchange students.

Gayle has been a licensed architect for over 30 years. She received a Bachelor of Architecture Degree from Kansas State University, Masters in Business Administration from the University of Maryland, and Doctorate of Business Administration from University of Phoenix. Gayle spent her architectural career working on the design and construction of retail stores. For 15 years, Gayle served as Senior Vice President of Property Develop for a global retail company based in Paris. This position took her to countries around the world to handle all aspects of opening and remodeling retail stores for luxury goods. As part of the position, Gayle was responsible for emergency response and continuity planning. She continues to work in the field of emergency response and continuity planning as a consultant for her previous employer as well as for governmental agencies
