Chief Deputy Attorney General overseeing a staff of 75 lawyers and 50 staff.


Bill left the A.G.'s office to become the Chief Deputy City Attorney for Environmental Affairs in Reno and later Deputy City Manager for the City of Sparks. Bill is a retired environmental attorney. He spent the last 13 years of his career working for Reno and Sparks in the areas of water and wastewater law. Bill was a key player in the creation and approval of the Water Conservation Agreement of 1994 and the Water Quality Settlement Agreement of 1996.

In 2000 and 2001, Bill led a team of local government professionals and consultants in the purchase of the water supply business of Sierra Pacific Power Co. and the subsequent establishment of the Truckee Meadows Water Authority.


Following his retirement in November, 2001, for two years Bill was the producer and host of 23 educational television programs about northern Nevada water issues and their effect on people's everyday lives.

Currently, Bill is the chairman of the Griffin-Santini Memorial Endowment committee. This group raises funds to assist the UNR debate team in producing students and future leaders who excel in oral communication and logical thinking. Funds raised support scholarships, team travel and coaching. He also is the vice president of Great Basin Land and Water, a non-profit corporation which assists local governments and Native American tribes in purchasing Western lands and water rights.

IMPROVE

disease surveillance systems to detect any poliovirus in a person or the environment

more than 150,000 health workers to go door to door to find every child
