


- Addressed a significant problem or need in the local community (international service projects, no matter how worthy, are not eligible for this award)

IRA Charitable Rollover

The law that allows you to make a tax-free gift from your individual retirement account (IRA) directly to charity has been reinstated and made permanent! Known as the IRA charitable rollover, this law no longer has an expiration date so you are free to make annual gifts to The Rotary Foundation from your IRA this year and well into the future.

The recently reinstated law allows individuals 70½ and older the ability to transfer up to \$100,000 from their individual retirement accounts directly to a qualified charitable organization without being subject to federal income taxes on the distribution.

Are you eligible?

- You must be at least age 70½ or older at the time of the gift.
- You may transfer up to \$100,000 directly from your IRA. This opportunity applies only to IRAs and not other types of retirement plans.
- You may transfer the funds outright to one or more qualified charities.
- The legislation does not permit direct transfers to charitable trusts, donor advised funds, charitable gift annuities or supporting organizations.

An IRA charitable rollover gift can satisfy all or part of your minimum distribution requirement, and is a great way to meet your Paul Harris Society goal through a gift to the Annual Fund!

Supplies for Bwindi

The Rotary Club of Grass Valley has agreed to apply for a Global Grant to continue the expansion of services at the Bwindi Hospital in Uganda.

District 5190 has been incredibly generous in its support of the work at the Bwindi Hospital. The results speak for themselves. From using the branches of a tree as IV poles to the modern facility now in use, District 5190 has played the lead role. We have dramatically reduced infant and maternal mortality rates, lowered the prevalence of diarrhea in children, and markedly diminished rates of mother to child transmission of HIV. More importantly, we have helped establish a school of nursing, which will lead the way toward a healthier future. We now have the chance to further expand services.

The complex has the expertise to perform complicated elective orthopedic and gynecological cases thanks to medical teams sent by Switzerland, Austria, and the U.S. They now have the needed space in a postoperative surgical ward for the needed follow-up, due to a generous donation. What they lack is the equipment to support this new service. They need specialized beds, ventilators, incubators, monitors and other supplies to support this new ward. And while they have a nursing school, they still need more locally trained public health nursing instructors.

This Global grant will have two facets: one, collect the needed equipment, load a shipping container, and ship it to Uganda; two, offer scholarships leading to a Masters in Nursing Science for two Ugandan nurses who will return to teach at the Bwindi nursing school.

The good news is that all this equipment is here in the U.S. and waiting to be shipped. All we need is the container.

Additionally, there are local students who have the basic nursing skills who want to move on to advanced training. The Rotary Club of Grass Valley and Scott Kellerman MD have agreed to lead this effort.

Our preliminary budget is \$30,000, we need the help of other clubs to raise this amount.

to next year's District Grants

We are just a couple of months away from the deadline to close out 2015-2016 District Service Grants, March 31st.

The next Grant milestone will be the District Scholarship Applications due to the District Scholarship Committee on April 15th (tax day). Clubs wanting to apply for a District Scholarship should be reviewing their candidates and then make out one application to be turned in by the deadline. If the club applies for a District Scholarship, it should be shown on the Club Spending Plan that is due on April 30th. 2016-17 Spending plans can be turned in any time to the District Rotary Foundation Chair. All the supporting instructions and documentation is located on District5190.org/Foundation/ global-and-district-scholarships. The Spending Plan is at District5190.org/ Foundation/Grants.

Club Foundation Chairs should brief their Club Board about next year's Grant opportunities for 2016-17. The plan should include either getting their club qualified or keeping their club qualified. It is anticipating there will be similar amount for District Grants next year. Actual District Service Grants and District Scholarship will be announced in May.
