and graduated from Kamehameha School (KS). She is a graduate of the Hastings College of Law, University of California. Since 1987, she has been a founding partner of the law firm now known as Bays Lung Rose Voss. She has served on the Board of Directors of Central Pacific Bank, Hawaiian Airlines, Hawaiian Electric Company, and the Gentry Companies. She also has served as a Commissioner to the State of Hawaii Department of Hawaiian Homelands. Crystal is active in the community. Her community service includes serving as a Trustee of the The Nature Conservancy; a Board Member of the Blue Planet Foundation; a Board Member of Child and Family Services; a member of the Board of Advisors to the Chief Executive of Kamehameha Schools; a member of the Advisory Board of Assets School; a member of the Advisory Board of Catholic Charities; a Board Member of the Boys and Girls Club of Hawai'i; a member of the Circuit Court Civil Rules Committee for the First Circuit Court, State of Hawai'i; a Hearing Committee Member of the Disciplinary Board of the Hawai'i Supreme Court. Previously, Ms. Rose has served as the Secretary and Treasurer of the Native Hawaiian Chamber of Commerce; and a member of the State of Hawai'i Board of Engineers, Architects, Surveyors and Landscape Architects. Rick concluded his introduction by relating an amusing anecdote when in their early time together he was working with heavy equipment and lost track of time and ending up having to pick her up from the airport in a large commercial truck with a massive trailer. – (thank God he was so endearingly cute or they may not have ever lasted as a

**Crystal** started her presentation in Hawaiian and thereafter continued in English to share about Kamehameha Schools and the legacy of Bernice Pauahi Bishop. She then introduced a compelling short video about hopes and dreams of Kamehameha Schools' students, alumni and beneficiaries.

**Crystal** continued with slides that highlighted: What they do, who they are, and Kamehameha Schools' response to COVID. Their intended impact is: by operating world-class Hawaiian schools and engaging with communities to transform educational systems, to raise 'ōiwi leaders

who are empowered and unified, and who will solve the issues of our people and communities, all within an enterprise that is globally competitive in each of its business lines.

KS directly provide education to 5431 K-12 on 3 campuses and 1618 students in 29 Pre-schools on Hawaii, Maui and Oahu. 81% of their students receive financial aid.

The Trust as well funds more than campus-based programs as they provide 5714 Scholarships to non-KS schools and serve 12750 students in other programs. In their community engagement, KS has investments in 44181 Participant learners and families and they partner with 103 businesses and organizations.

The trust manages 10% of the land in Hawaii with 189k acres are in Conservation. KS produces behind only HECO in the state. 20% of Hawaii's watershed acreage is on KS Lands. These lands host 192 rare species; 1/2 of all rare species are on Kamehameha land. KS has 169k acres in Agriculture and produces 70% all coffee grown in Hawaii. They are well known for their 4715 acres of Commercial Development holding valued at more than \$3.7bil.

To perform their mission KS uses \$10.7 in Financial Assets and a \$14.4Bil endowment.

During her lifetime Bernice Pauahi Bishop witnessed devastation in Hawaiian Population, Culture, Health Language, and Identity. Upon her passing on October 16, 1884, through Article 13 of her will, she established the Kamehameha Schools. This will, as its enduring legacy, provides, in relevant parts, that KS

- 1. operate two schools, one for boys, one for girls, with boarding and day students,
- 2. devote a portion of the budget to orphans and others in indigent circumstances,
- 3. give preference to Native Hawaiians, and
- 4. provide a good education in the common English branches, with instruction in morals and in such other useful knowledge as may tend to make good and industrious men and women.

Today her legacy continues and flourishes in Kamehameha Schools which is not just a school, or a land manager, or landlord but an integrated organization that has and will into the future well serve the needs of Hawaiian people

**Crystal** described how COVID has provided challenges and opportunities. KS's community partners have worked in the Hawaiian community throughout the state to direct resources and support that addressed the most critical needs created or exacerbated by COVID. Community response has been focused primarily in five area: Food Security; Mental Health and Safety; Community Wellbeing; and Recovering, Rebuilding, and Transitioning.

**Crystal** closed her presentation with another short video which, in Hawaiian and English, asked a series of questions that found KS's vision.

Some of the guestions **Crystal** responded to were:

**Bob Sigall** asked about recognition by KS of Princess Ruth's legacy which **Crystal** assured him she was a key feature of their educational programs.

**Alice Tucker** asked about expansion of KS programs to Kauai. **Crystal** indicated not brick and mortar but recently developed digital offerings provided increased opportunity.

**Reese Liggett** asked how KS has changed in terms of its beneficiary focus to which **Crystal** said that it had in the last decades moved much more from looking solely at their students to the entire Hawaiian community. **Erin Pauahi Auerbach** described how she was not a KS grad but had been a beneficiary of her namesake's legacy through KS's outreach programs.
