- Sent a check for \$250 to Falcon Booster Club for Falcon Fest.
- Hales Corners is requesting a second "welcome" sign since a previous sponsor is no longer able to cover the \$3000 cost. Our sign is near St Mary's. The new sign would be at Highway 100 and College. Agreed to forgo this opportunity.
- District 6270 is offering to match a club's reimbursements to its members for up to 20 clubs. Christianson requested that the Board reconsider its decision to reimburse only members \$100 toward their Tricon registration fees to include members' spouses who attend Tricon. Motion (Nolan, Nicholas) to reimburse a member and the spouse \$100 each toward the Tricon fees if they attend the event. Motion carried.
