Annual Dues - \$200.00 (billed \$50/quarter)

Meal Fees – Billed \$12/per meal

Contribution to the Ashland Rotary Foundation - \$60.00 (Billed \$15/quarter)

Club bills will be sent quarterly and addressed to the Corporate Executive and shall be the responsibility of the Corporate Executive and not the responsibility of the designees. If more than one member of the corporation attends a meeting, additional meal charges will be billed.

The Ashland Club encourages members to be present to engage in fellowship, conduct club business and to learn about the community through engaged speakers.

### **Club Projects and Activities:**

All corporate members and their families, are encouraged to generate ideas and participate in club projects including fundraisers, service projects and social events.

For over 100 years, the Rotary Foundation has been doing good in the world. From nearly eradicating Polio to funding playgrounds in northeast Ohio, the Foundation is the conduit to international and local projects. A pledge card will be sent to each member every year asking for a contribution.

### **Rotary International:**

The Corporate Member will be represented for purposes of Rotary International and other Rotary Club's by the Corporate Executive designee. The Rotary International membership will be held by the Corporate Executive designee and dues will be paid to Rotary International and District 6600 based on the Corporate Executive. The Corporate member will only be recognized internally by the Club and is not an official designation from Rotary International.

### **Club Participation:**

A Corporate Member may name three people as designees, of which one shall be designated as Corporate Executive Designee. All designees are encouraged to sit on Club committees. Only the Executive Designee is allowed to serve as Club officer. Other designees are encouraged to pursue a personal membership if they desire to serve as a Club officer. A Corporate Member may have one vote for Club elections and voting. The Corporate Executive Designee shall be the voting member but may assign the voting to a Corporate Designee.
