VOLUNTEERS

The Rotary Club welcomes volunteers to participate in the Club's activities and events, especially those from member families and households and also from the community. Volunteers must be six years of age or older and children under the age of 16 require adult supervision by a parent, guardian, or teacher while volunteering. Volunteers who bring any minor children with them while performing volunteer activities are solely responsible for their supervision.

All volunteers at any Rotary event or activity must sign a "VOLUNTEER WAIVER AND LIABILITY RELEASE" prior to their participation in the event or activity. Parents, guardians, or teachers must complete a form for each individual minor volunteer.

Volunteer relationships with Rotary may be terminated for reasons that may include, but are not limited to, harassment, stealing, unruly or disruptive conduct, and non-compliance with the waiver and release form above.

The "VOLUNTEER WAIVER AND LIABILITY RELEASE" form may be completed and signed electronically online prior to the event or activity, or signed in person prior to beginning as a volunteer at an event or activity.

VOLUNTEER WAIVER AND LIABILITY RELEASE ROTARY CLUB OF CORNING

As a VOLUNTEER of the Corning Rotary Club (hereby named Club), I recognize that I represent the Club to the public. I accept this responsibility and will conduct myself in a professional manner during my volunteer service.

I understand that some volunteer activities may pose of risk of serious injury or possibly death to me and involve the use of or exposure to tools and other equipment that may cause harm.

I understand and acknowledge that injuries may result during my volunteer activities not only from my own actions, but also may be caused by the negligence or actions of others. I voluntarily assume all of the risks of and accept personal responsibility for all damages and losses which may result during my activities as a volunteer for the Club. I hereby release, waive, discharge and covenant not to sue the Club or any of its directors, agents, representatives, successors, volunteers and assigns harmless from any and all loss, liability, expense or damages of any kind, or of any nature, caused by, resulting from, or related in any way to my volunteer activities for the Club.

I understand that if I bring any minor children with me while performing volunteer activities, I am solely responsible for their supervision and safety. I agree to indemnify and hold the Club and its directors, agents, representatives, successors and volunteers and assigns harmless from any or all loss, liability, expense of damages which any of them may incur as a result of personal injury, death or property damage sustained by any child accompanying me for volunteer activities.

Volunteers must be six years of age or older to volunteer and children under the age of 16 require adult supervision by a parent, guardian or teacher.

I give permission to the Club to use photographs, audio or video recordings of me performing volunteer work for the purpose of promoting the Club, as well as, to use of my image. Likeness or voice in their public communications and/or media without payment or compensation.

If this is a minor's account, I certify that I am the parent or legal guardian of the minor named on the account and hereby grant permission for him/her to participate as a volunteer with the Club by signing this waiver.

I HAVE CAREFULLY READ THIS VOLUNTEER AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS AND AGREE TO ABIDE BY THE STIPULATIONS SET FORTH IN THE VOLUNTEER AGREEMENT. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY, AND I AGREE TO ITS CONTENT WITH MY OWN FREE WILL.
