

YOUTH EXCHANGES

Are you interested in learning a new language or meeting new people? Rotary Youth Exchange is the opportunity of a lifetime for the more than 8,000 students who participate each year. By sharing your own culture and embracing a new one, you help foster global understanding—and learn a great deal about yourself and your home country in the process.

WHAT IS A ROTARY YOUTH EXCHANGE?

Youth Exchange is a study-abroad opportunity for young people who spend anywhere from a few weeks to a full year as an international student hosted by local Rotary clubs.

IS AN EXCHANGE RIGHT FOR ME?

Exchanges are for people ages 15–19 who:

- Have demonstrated leadership in their school and community
- Are flexible and willing to try new things
- Are open to cultural differences
- Can serve as an ambassador for their own country

HOW MUCH DOES IT COST?

Costs vary from country to country. Local Rotary clubs generously host students and provide room and board with a host family and a small monthly stipend. Participants are generally responsible for:

- Round-trip airfare
- Insurance
- Travel documents (such as passports and visas)
- Spending money, additional travel, and tour fees

HOW CAN I APPLY?

Contact your local Rotary club to see if it participates and to learn more about the types of programs offered, and specific application process required. Because the selection and orientation process can be lengthy, we suggest you apply 6-12 months before you plan to leave.

CAN I HOST AN EXCHANGE STUDENT?

Hosting an exchange student can be an incredibly rewarding experience for your family, providing an international experience without leaving home. Host families provide room and board and share their lives with exchange students, involving them in family, community, and cultural activities.

THE ROTARY FOUNDATION

Elisa DeJesús was the main speaker at the July 23rd meeting. She began her presentation by talking briefly about Rotary International President 2014-15 Gary C.K. Huang, Rotary Club of Taipei, Taiwan. She informed that President Huang is urging club members to Light Up Rotary by hosting a Rotary Day, continue our fight against polio, and increase club membership. He said: "Light Up Rotary is more than our theme. It is how we make a difference every day, in every club, and every country we serve."

She talked about the Rotary District 7120 Year 2013-2014 Giving to Rotary Foundation. The annual district goal was \$165,639. A total of \$188,000 was given, the highest level ever. A 100% of all clubs (69) participated including ours with \$23,000.

She also talked about why it is important to give to Rotary. Contributions to The Rotary Foundation make it possible for clubs to transform lives worldwide; there is an increased dependence upon District Designated Funds. In three years, fifty percent (50%) of what is raised is returned to our district to use for the clubs´ projects. Our club has benefited from the District Simplified Grants for scholarships to college-bound Latino students and, most recently, for school supplies for impoverished children.

In year 2013-2014 District 7120 had 34 clubs awarded District Simplified Grants totaling \$44,037; and \$78,400 in District Designated Funds are supporting ten Global Grants, eight of which have been approved and are being implemented and two are still in the consideration stage. For these ten grants, sixteen clubs have donated, or committed, a total of \$34,364 in cash donations. The total matching funds from The Rotary Foundation for these grants is \$95,682, and the total value of the ten grants is \$356,409 for the local district.

She also informed that as of the end of May 2014, the District 7120 Rotarians and clubs had donated \$44,137 for polio eradication and Governor Ellen donated \$20,000 of District Designated Fund to the cause. Polio eradication remains job number one priority for Rotary International, and we are doing our part. Our goal for this year is \$900. The goal for the Annual Funds is \$2300.

The first meeting of the Board of Directors of the RLRC was held on July 28th. After dinner, members were hard at work talking about budget, plans for the upcoming Dance to Health event, and numerous other topics of interest.

Of concern is the fact that several members who have expressed their interest in remaining as members of the club have not paid their dues in spite of numerous requests from the treasurer, Miriam Vázquez. Since the club must pay dues to the District and Rotary International based on the number of members reported as active, it is imperative that dues be paid on time.

It has been observed that many members do not wear the Rotary pin. It was decided that going forward, members who show up to the meetings and club events without the pin will be fined \$1.00. Don't be caught without the pin, your pocket will suffer!

A Foundation is born

Our dedicated, incomparable Miriam Vázquez has achieved in a very short time what has been a club dream for a long time. The Rochester Latino Rotary Foundation has been approved by the State of New York thanks to the work done by Miriam. Now, she is preparing the necessary documents to apply for taxexempt status.

The Bylaws and the Conflict of Interest Policy have been developed. The Board officers have been elected as follows: Chairperson, Antonia Scott; Chairperson Elect, Charol Ríos; Secretary, Elisa DeJesús. Miriam Vázquez, as Club Treasurer will be ex-officio member of the Foundation board.
