CONNECTING ROTARY AND FAMILIES IN OUR COMMUNITIES

The Rochester Latino Rotary Club has been involved in international projects even before it was formally chartered by Rotary International. The first project was the donation of funds to repair the leaking roof of a school in El Sauce, Nicaragua. This was followed by yearly donations of school supplies for the same school.

On October 1, 2014, Marta Rojas, Tim McMahon and Ashley Sullivan visited the club to give thanks for the help provided to the students. They also explained the different projects that are helping the population of El Sauce.

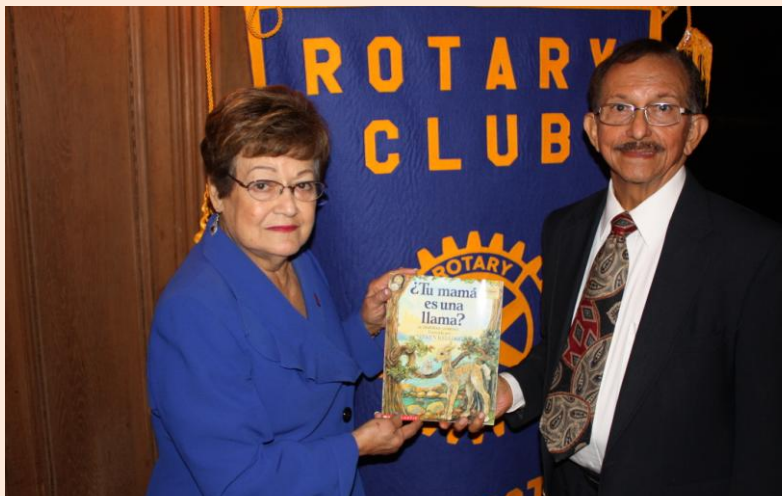
El Sauce is a town of about 8,000 inhabitants. Most of the people living there are very poor. They have a scholarship program that now covers 125 students in 8 schools, 2 of them in the town, 6 in the countryside. A scholarship consists of \$75 per year to provide a backpack, school supplies, uniform, shoes and basic medical supplies. The results show that the children who receive scholarships are the best students. Chosen children come from single parents or those being cared for by grandparents. The program also provides teaching materials to the teachers. The club is supporting children with payment for

Edwin Rivera

Abe Hernández introduced the guest speaker: Edwin Rivera, Sr., first Puerto Rican outside of New York City elected to public office in 1961 when he was elected Fifth Ward Constable at the age of 21. He later became the first Puerto Rican on the County Board of Supervisors. Mr. Rivera worked for the city as a community service representative for the Rochester City Manager from 1967-69. In 1968, Mr. Rivera was appointed by the Commonwealth of Puerto Rico as the Director of the Commonwealth's Migrant Advocacy Office in Rochester. Puerto Rican law 87 mandated this government agency to monitor and protect the employment and basic worker rights of domestic and farm laborers working outside of the island. The Rochester office was responsible for representing hundreds of Puerto Ricans who worked in food processing plants throughout Western New York. These companies also provided housing, which required diligent oversight by Mr. Rivera and the Migration Division.

Mr. Rivera spoke about his personal and professional experience in Rochester. He started his involvement in the community in the early 1960 as a young man interested in working for a better community.

As a Board of Supervisors representative, he successfully fought the County to move its food distribution center to downtown so that people didn't have to go to Westfall Road. He also fought the Board of Election for the right to vote. Voters had to take a test, which prevented many people, especially Hispanics who did not know the English language, for registering and voting. He took the case to the federal court and won. The case is known as María López versus County Board of Elections Case.

He also established the first Hispanic community newspaper called La Voz del Pueblo. Mr. Rivera worked with a group of other Puerto Ricans pioneers to establish the Ibero-American Action League. He served as the first chairman of the board. He talked about the role that the Catholic Church played in the development of this institution. Ibero was a project of the Hispanic Apostolate established by the church. Eventually, the agency had to go solo in order to be funded by the government.

In 1969, Mr. Rivera was selected by the US Department of Justice, Community Relations Service as the lead representative and relocated to Buffalo in 1970. Beginning in 1971, he worked for the US Department of Defense and then Department of Housing and Urban Development until 1978 when he was transferred to Puerto Rico to become the director of the US Department of Labor's Caribbean office of Federal Contract Compliance where he retired in 2003.

Mr. Rivera finished by expressing concern for the disintegration of the family. It is his position that we must focus on keeping the family together for the sake of our children. Our children need a strong family to grow emotionally healthy.

The meeting was attended by Esq. Maritza Buitrago, Salvador Casiano, Edwin Rivera Cintrón, Berardo Jurado, Ricardo Martínez, Miriam Mirando-Jurado, Father L. Tracy, and Edwin Rivera Jr. in addition to several club members. Mr. Rivera is a highly respected individual whose contributions to the community continue to yield positive influence on Latinos and non-Latinos alike.

Tim McMahon accompanied Marta and Ashley to the meeting. Among the projects in El Sauce is the building of community wells. So far they have built wells in 5 rural communities and a total of 150 persons have benefitted from these wells. The families benefiting from the well help to do the work: digging and cementing the sides with bricks.

There is a project for poor, single women to make piñatas that are used in all kinds of celebrations. First the women are taught how to make a piñata and then they can start their own small business.

Another project is microloans. This project is also for very poor women. These are loans of \$100 with a 1% interest rate that have to be paid back in one year. So far, 20 women are benefitting from these loans. Businesses established so far include: corn and cacao products, replacement parts for bicycles (bikes are the main way of transportation), used clothes and cosmetics.

Another important project is school building. Existing schools were very poor and made from wood with leaking walls and roofs. In the raining season, the rain came through the walls and inundated the room. Now they are building schools with walls of bricks held together with cement and a sturdy roof. Also tables and chairs are provided as well as school supplies. Even the teacher will have her own desk and chair.

TO PROTECT PROGRESS, THE WORLD HEALTH ORGANIZATION DECLARES SPREAD OF POLIO AS PUBLIC HEALTH EMERGENCY



Rotary supports the WHO Director-General's [recommendations](#) that describe polio as a public health emergency of international concern, including the request that countries that are actively exporting the wild poliovirus (and all polio-endemic countries) ensure that all of their residents and long-term travelers are immunized against the disease before travel.

This is a positive step needed to safeguard the remarkable progress the world has made toward ending polio forever, because we know that outbreaks will continue to occur until we can stop polio at the source: the remaining endemic countries.

With our partners, as well as health ministries, governments, and others, Rotary remains committed to a polio-free world.



Archie Panjabi is a British TV and film actor renowned for her performances in *East Is East*, *Bend It Like Beckham* and *The Good Wife*, for which she won an Emmy. She is a polio eradication ambassador for Rotary International and works with Amnesty International on their Stop Violence Against Women campaign. She has stated the following: "I am happy to report that today polio is 99% gone, down from about 350,000

cases a year in the 1980s to barely 400 in 2013. With India now free of the disease, only three countries remain polio-endemic: Nigeria, Afghanistan and Pakistan. We must ramp up our efforts in the endemic countries, because from them polio can re-emerge to infect children in places where it had been stopped, such as we saw [last year in Syria](#) and the Horn of Africa. If we were to relax our guard – decide, say, that the world could live with a few hundred polio cases a year and cease our mass vaccinations in at-risk countries – experts tell us polio could rebound with a vengeance, infecting thousands of children a year."

World Polio Day was held on October 24.
