Introduction

This special Bulletin contains some brief historical, club activity and financial information about the Rotary Club of Roseville Chase Inc.

It is not intended to be the history of the Club's activities, but to bring together some of the principle aspects of the Club. The documents concerning the Club's formation, are difficult to read as they are taken from copies of the originals.

The information on the pages containing financial figures has been extracted from the Annual Audited Accounts of the Club, the Annual General Meeting minutes and Board meeting minutes, and should be reasonably accurate.

The last audited accounts were for the year 2018/2019, and the preliminary figures to June of 2019/2020 (though not audited nor final upon merger of the Club) have been included in these financial pages. The figures include non-cash items e.g. depreciation, loss on sale of assets, cost of inventory (shirts, apron given away) etc. i.e. Balance Sheet.

In earlier years some donations and expenses were met from the No. 1 Administration Account, and in the figures in this document those amounts are not included in the No. 2 Charity Account so as to balance bank accounts.

Pages 39 - 40 summarise all the Income and Expenses of the Administration No 1 Account and disclose the costs of running the club, meeting and other collections, fellowship activities and non-charitable functions since inception.

The information regarding the Charity No. 2 Account sets out the following;

- Pages 41 - 42; The various fund raising activities of the Club showing the Gross Receipts, the Gross Costs and Outgoings incurred in raising that income, and the net funds available from each of those activities.
- Pages 43- 48; The various projects and purposes to which the Charity Account funds have been applied, grouped in the various avenues of service.

The photos and information of the inbound Rotary Exchange Students (pages 51-53) are taken from their "business cards" and in some instances are not as clear as desirable.

Since Chartering on 24 April 1990, the Club has had a total of 124 members. There were 22 members as at 30 June 2020, and 102 former members. The list of past members of the Club (Pages 63 - 65) indicates the years of service they gave to the Club and to the ideals of Rotary.

The proposed club is to be sponsored by the Rotary Club of Northbridge which will look after both the organisation and costs of formation.

District 968 Representatives present were PDG Buster Pye and PP Tom Gait who assist in Club Extension. Rotarians from the Northbridge club were Pres. Graham Goodfellow, Ross Alexander, Bruce Austin, John Buttenshaw, Bob Hendy, Geoff Verco and Malcolm Tompson.

Malcolm opened the meeting and introduced Buster Pye, who talked about the history of Rotary from its inception in 1905 to its current international and local activities such as Rotary International scholarships and Polio Plus which will rid the world of Polio myelitis by the year 2000. He also discussed the structure of Rotary at District and Club levels and some of the activities in Club, Community, International, Vocational and Youth Services. As an example, Youth Service is an exciting and fulfilling area, especially the International Youth Exchange Awards, where some 9000 students around the world each year live with host families in other countries for twelve months.

Tom Gait spoke on the procedure of forming a new club. A minimum of 25 members must be found to form a Provisional

Club which can then function with the usual weekly meetings and its own officials, assisted as necessary by the Northbridge Club. Following approval by Rotary International the club will be chartered in a couple of months.

Geoff Verco told us of his experience as the Charter (first) President of the Rotary Club of Canterbury, Melbourne. In that club none of the charter members had any previous experience in Rotary and it was very much the case of the blind leading the blind. Nevertheless, the club has been successful and Geoff regrets that he was forced to move to Sydney and leave his club. (He has since contributed much to the Northbridge Club.)

Graham Goodfellow emphasised the importance of fellowship in Rotary and making new business and personal friends through it. Not only are the occasional social outings great but the weekly meetings are great too. The usual difficulty "I haven't got time to belong to Rotary" evaporates on joining as it is a welcome respite at the end of a work day. Rotary is for busy people.

Questions followed after which Malcolm Tompson asked for a show of hands from those wishing to join the new club. They are:



Journey of the Club

The Rotary Club of Roseville Chase has been in existence since 24 April 1990.

Its initial formation had the support and encouragement of the Northbridge Rotary Club and its District Governor's Special Representative Malcolm Tompson. The first Interest meeting was held on 20 November 1989 (see pages 4 and 5).

It was started by a group of like-minded friends with genuine interests in actively giving something back to the community and having a lot of fun in the process. That culture of fun remained at the heart of the club throughout its existence.

The club had commenced provisional meetings at the Castle Cove Country Club, and held its Organisation Meeting on 18 April 1990, at which Stuart Frith was elected President and Richard Wilmott elected Vice-President.

In 1990, at least 25 members were required to form a Rotary Club which the club had – though it has been suggested that a couple of people were not aware they were even members. But the test was passed. Charter member listed on page 12.

Ultimately the Rotary Club of Lindfield became the sponsoring Rotary Club, and with whom the Rotary Club of Roseville Chase would share Rotary club "territories". The Club's Charter was granted on 24 April 1990, and the Club was presented with its Charter by District Governor Gordon Rowe, and Charter Members inducted at a Presentation Dinner held on 28 May 1990.

The Club was registered as Club No. 27149 by Rotary International originally in District 968, which subsequently became District 9680.

As from 1 July 2013, District 9680 became 9685, with the restructuring of the previous three Districts in the Sydney metropolitan area (Districts 9750, 9680 and 9690), to form two Districts i.e. one north of the Harbour (District 9685) and one south of the Harbour, (District 9675).

With a membership that was ageing, and a significant difficulty in attracting new members, the activities of the Club became contracted. The pressures of current life seem to impose much greater demands and commitments on the time available to potential younger members. There was a gradual decline in the Club's membership and ability to adequately fulfill the ideals and objectives of Rotary which culminated in the decision by the club to hand its Charter back to Rotary International, wind up as an Incorporated Association in NSW, and merge with the Chatswood Rotary Club, to become The Chatswood Roseville Rotary Club Inc, effective as from 1 July 2020.

Twenty-One (21) of the twenty-two (22) members of the Club on 30 June 2020 elected to transfer to the merged Club upon its commencement on 1 July 2020.





The Emblem of The Rotary Club of Roseville Chase The Crimson Rosella

The Club's most respected and recognisable emblem was the "Crimson Rosella" in flight. It's affectionately sometimes referred to as "the legless parrot", but that's wrong and a little disparaging, as you seldom see a bird's legs when it's in flight.

Neither is the Club's Emblem a rainbow lorikeet, galah, cockatoo or parakeet.

Crimson Rosellas live in East and South East Australia. They are predominantly a bright red and blue, but can occasionally be yellow and green as well.

In the Roseville Chase (Echo Point) area there are Crimson Rosellas which are red and blue. They are very predominant and prolific in this area.

In the Club's Charter year there was a member, Murray Van, who was a very talented artist and creative advertising guru, and it was Murray's role to develop the club's emblem.

Murray used the red and blue Crimson Rosella and developed the Club's emblem which reflected the identity of the Roseville Chase Rotary Club with the particular Crimson Rosella found in the Roseville Chase/Castle Cove area.

That's essentially the reason the red and blue Crimson Rosella was adopted as the Club's emblem.

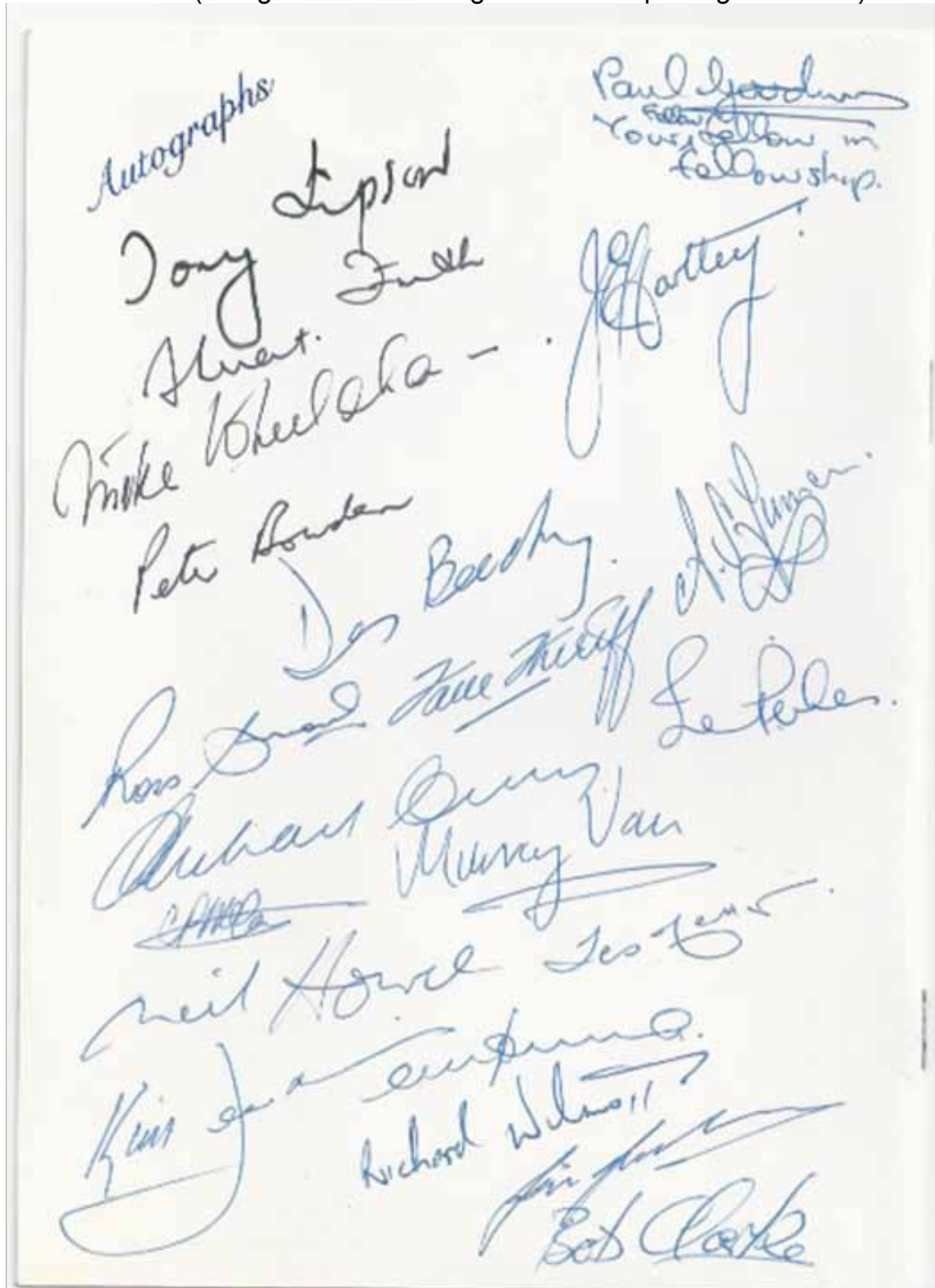

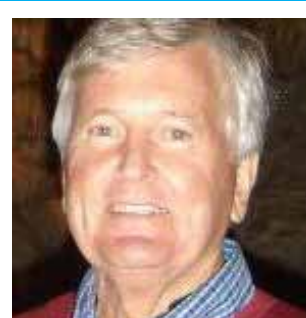

The recognition of a person as a Paul Harris Fellow is The Rotary Foundation's way of expressing its appreciation for a substantial contribution to its humanitarian and educational programs. It is named after the founder, Paul Harris, a Chicago lawyer who started Rotary International with three business associates in 1905.

Rotarians often designate a Paul Harris Fellow as a tribute to a person whose life demonstrates a shared purpose with the objectives of the Rotary Foundation. It recognised people for their devotion to the ideal of goodwill, peace and understanding. It is the goal of Rotarians the world over, and one that every Paul Harris Fellow clearly shares.



Some Major Projects of Roseville Chase Rotary Club Inc.

The first Project – Centenary of Rotary International 23 February 2005 Echo Point Picnic Shelters.



During the 1994/5 year, when Trevor Holman was President, Bob Clarke and Ross Symons held the initial discussions with the Ku-ring-gai Council on the prospects of the Club developing some community or playground at the Echo Point Park. At that early stage the Council was in the process of developing a plan of management for the community land.

This ongoing process went on for several years, until PP Stuart Frith revised the idea and commenced the planning process for a community facility which would co-incide with the Centenary of Rotary International in February 2005.

One of the most beautiful areas of Roseville Chase is the upper reaches of Middle Harbour. Nestling on the southern shores of the reach and just east of the Roseville Bridge is a magnificent park, Echo Point Park. This park is a community icon and had been the site of the Roseville Baths which were demolished in the late 1960's. Those baths, from historic photographs held by Ku-ring-gai Council show a magnificent federation style grandstand on the site of the park and overlooking the baths.

At the time of the Centenary of Rotary, the club was looking to identify a project which would stand the test of time, would provide a community need and give the club the opportunity to be involved in a major "hands on" project.

It was quickly identified that the park, notwithstanding a very high utilization, did not have a major picnic and barbecue facility at the water's edge. The club entered discussions with Ku-ring-gai Council to gauge its support and obtained very enthusiastic Council support with offers to assist where ever possible. One of the major areas of assistance the Council identified was the opportunity of putting the project forward to obtain a grant from the New South Wales Government under the Department of Planning. The Council and the Club were successful and the Club



obtained a grant of \$20,000 and this, together with \$25,000 the club had raised over the previous three years, provided a budget of \$45,000.

One of the key capabilities of Rotary is to be able to mobilize the professional skills and contacts of the Club members. In this regard the Club had within its ranks a structural engineer, two electrical engineers, an architect, a senior local government manager, lawyers, accountants and members with contacts with a wide range of local businesses. As such the Club was able to garner the following additional support:

- Free supply of construction equipment from a major equipment hire company
- Significant discounts on hardware and supplies from a major hardware chain
- Supervision by a local builder (son of a club member)
- Supply of bulk concrete at no cost
- Roofing installation at no cost

The planning for the project commenced in 2003 and one of the key issues was to ensure the design was sympathetic to the site and maintained a heritage link to the old grandstand that had stood on the site. The Club completed its design, the Council included it in its development plans, granted development approval and then procurement of the kits that would make up the structure, the seating and tables to be included in the shelter and the gas barbecue was put in place by the Club.

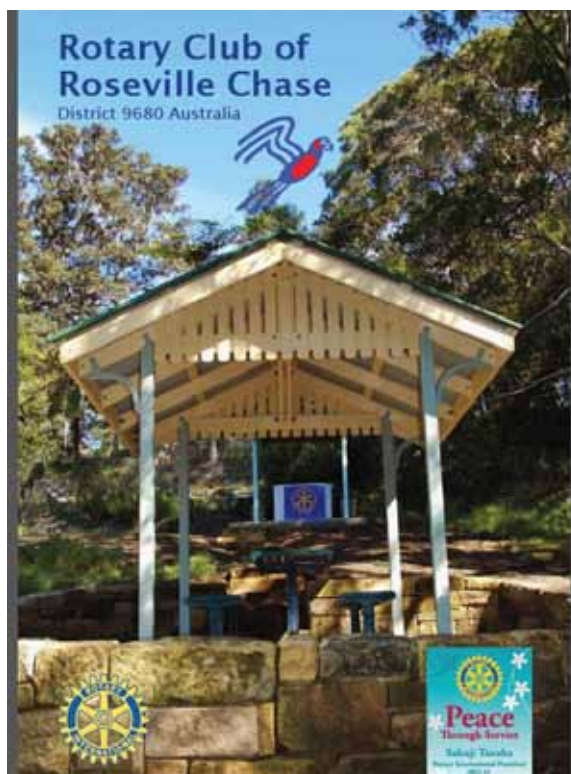
This took the Club until the last quarter of 2005 when construction was to commence. Then over six Saturdays over 10 weeks, November 2005 – January 2006, the Club built the facility. This included site layout, digging of foundations, pouring of foundations, erection of the kits, installation of seating and barbecue, painting and finally site clear up. During this time members had to move over 5 tonnes of equipment and supplies down to the site (which due to the complete lack of vehicular access meant getting equipment in by crane), mobilize the Club's work force and then finally remove six skips of excess soil, rock and waste materials.

The facility was officially opened in February 2006 by the local Ku-ring-gai Council member and on the site now stands a very impressive plaque recognizing the Rotary Club of Roseville Chase and the Centenary of Rotary. Since 2006 the project has proven so successful that the Council now runs a booking service for use of the facility.

Second project - 20th Anniversary of Roseville Chase Rotary Club 24 April 2010.



As the Club approached its 20th anniversary of its foundation on 24 April 1990 the Club wished to celebrate this landmark by undertaking the construction of a further community project and decided that another shelter and barbecue complex at Echo Point Park would be an ideal project.

Notwithstanding the success of the first project the Club was mindful that, due to the topography, access for members of the community with physical disabilities to that facility was extremely difficult. Consequently the Club resolved that the anniversary project would include in its design, full wheel chair accessibility to assist the total community in its enjoyment of the proposed facility.

During the previous project the Club had established a very close relationship with Ku-ring-gai Council and its officers in its landscaping section. In discussions with Council it soon became obvious that the Club had a good meeting of minds and soon thereafter Council staff provided the survey plans of the site together with its design thoughts on the project. Council did a great job, having seen the Club's proposed plans and the linkage to established pathways in the park and the upgrading to wheelchair access, the Council had then taken the concept a step further to include circular sandstone retaining walls, enhanced linkage to further pathways in the park and substantial replanting within the garden areas. The Club was delighted with the overall plan and resolved to adopt it.

The Club's estimate for the project (excluding Council's works) was \$20,000



and this made no allowance for the free people power that the Club would provide during the construction phase. The Club then contacted the local State MP member, Jonathan O'Dea, to investigate if there was the possibility for any government grants the Club could access. Following the Club's submission to NSW Department of Sport and Recreation it was granted \$7,500 for the project. In addition the Club received a grant from the Rotary Foundation of \$2,000.

Skills and equipment required to build the facility not necessarily available from within the Club's internal resources. Equipment was generously supplied at no cost by Kennard's Hire from its Artarmon branch.

The project also required some large reinforced concrete plinths. The reo and its placement, the supply, pouring and finishing of the concrete was provided by Mirvac, again, with much appreciation, at no cost to the Club.

The building skills required and the experience in construction was provided by Phil Cavanagh, a local builder and the son of one of the Club's members, David Cavanagh. Phil again made his valuable time available to the Club and his assistance in getting everything plumb and vertical was much very much appreciated by the Club.

And now the roof. As one of the Club's Rotarian team put it, "At our age, how can we get to that height and work"? Again local business, Chadwick Technologies, came to the Club's assistance, as they did on the Centenary Project, and erected all the roof sheeting again at no cost to the Club. Party Time Hire was always available moving construction equipment and picking up barbecues when the Club needed assistance.

The stonework, landscaping and new timber walkways was provided by the Council which added significantly to the aesthetics of the project.

The Club members provided their Saturday mornings and their sweat and blisters in achieving the overall result. The Club shifted 100 tonnes of dirt, laid over 30 metres of electrical conduit and cabling, moved, assembled and erected over 3 tonnes of components to form the shelters and barbecue and shifted and compacted 9 tonnes of decorative granite to form and construct the wheelchair access path.

Third Major Project - Children's Play Park; Corner Malga Avenue, Griffith



Avenue and Babbage Road, Roseville Chase.

The 25th Anniversary of the Charter of the Rotary Club was 24 April 2015.

Discussions with Ku-ring-gai Council were held by PP Stuart Frith at which some possible projects were raised.

The Council suggested that the Club consider a children's playground as the local area has a major changing demographic with a lot of new young families moving into and now in the area, and the local area had no real play area for children.

After much consideration the Malga/Griffith Avenue, Babbage Road site was selected for the reasons that it was;

- A good location for access from all areas of Roseville Chase and East Roseville.
- Had reasonable street parking available in Griffith Ave;
- A leafy site allowing good landscaping for a very interesting play area.
- Had good access for plant, equipment and storage of construction materials.

In undertaking the construction of the Playground, the Club and the Ku-ring-gai Council agreed that;

- Playground equipment to be purchased from an established and Council approved supplier.
- The supplier was to provide conceptual layout to the Club and Council's satisfaction
- The erection of all foundation works, would be undertaken by the supplier for liability, compliance with Australian Standards and certification requirements.



- The Council would, at no cost, provide the Development Application, construction drawings, construction fencing, any tree clearing and on going maintenance.
- Members would provide labour to build pads and complete “soft fall” areas.

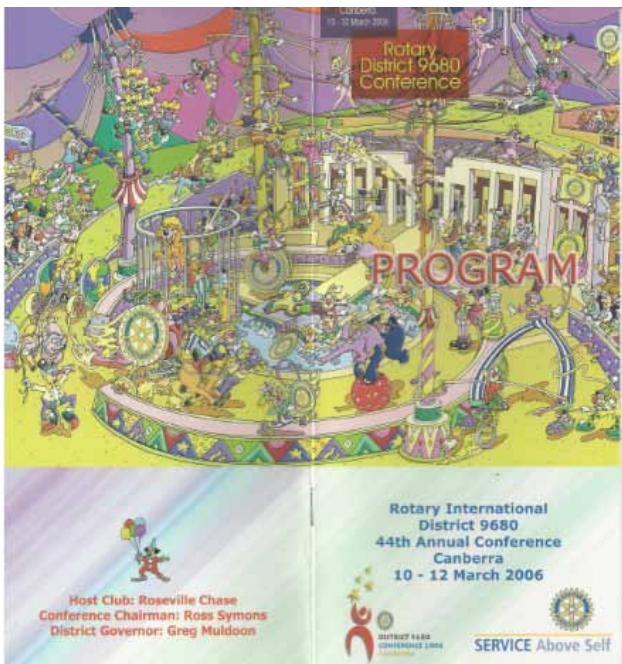

SOME BRIEF NOTES FROM THE LAST 30 YEARS

(Not in any order of time or importance)

Some details about the club's major projects are on pages 23 to 28, and on pages 29 and 30 there are a number of images of some of the organisations and charities which the club has assisted or been associated with. The details of expenditure on the various avenues of service also provide the complete list of beneficiaries of the club's financial efforts in all areas of service.

Following are a few items of "interesting" information about the club's activities.

- The President's Award was first introduced and presented by PP Greg Muldoon, at the change over dinner in June 1993, and awarded to (the Late) Bob Clarke.
- Early fund Raising ;
 - 1st activity was the Begonia and Azalea sales at the East Roseville Community Centre. Net funds were \$581, from total sales of \$1,502
 - Cow Lotto netted \$6,620 over a couple of years. However "Daisy" the cow died shortly after the second stage. There were also questions about the appropriateness of this sort of "game" at the Willoughby Family Fun Fair.
 - Krispy Kreme sales started to generate some income but the club was "embarrassed" out of the project as it was said to not promote healthy living.
- The Club became an Incorporated Association on 2 July 1990.
- Over the life of the club there have been four (4) honorary auditors;
 - Peter Blythe - Rotarian of the Sydney Rotary Club
 - Robert Boulter- of Robert Boulter Partners Pty Ltd
 - James Murchinson - of Murchinson Services
 - Robert Chalmers - R J Chambers Co.
- "Stock Aid", a Committee comprising the late Geoff Young, John Hammond and Chris McCulloch organised a visit to Merriwa in the Upper Hunter in 1994/95. The area was experiencing a devastating drought. 24 members and partners, and 60 Roseville College parents from the Musical Review staged a version of "Priscilla Queen of the Desert". This built a relationship with Merriwa and its community and some school student exchanges.
- The Club has been involved in staging a District Conference and 4 District Assemblies;
 - District Conference in Canberra 10-12 March 2006 for incoming DGE



Greg Muldoon. 33 members and 28 partners attended the Conference as hosts. About 1,000 Rotarians attended the Conference. The organising Committee was greatly assisted by the late Ron Tacchi, and John Melville.

- District Assembly May 1993, for DGE Graham Goodfellow, at the Marroo Conference Centre, Kurrajong.
- District Assembly May 2000, for DGE Michael van Heeswyk, at the Charles Sturt University, Bathurst.
- District Assembly May 2001, for DGE Harold Sharp, at the Sydney Convention Centre, Darling Harbour, Sydney.
- District Assembly May 2007, assisting Chatswood Rotary Club for DGE Monica Saville, Sydney Convention Centre, Darling Harbour, Sydney.
- 2005 successfully sponsored of Kelly Nicholls for a 2 year Rotary Peace Scholarship to Bradford University, West Yorkshire, England.
- 2000 successfully sponsored Hermione Hall as an Ambassadorial Scholar to study water purification at the Colorado School of Mines, USA.
- During Cliff Garrett's year as president, 2006/07, the club moved meeting venue to the Roseville Golf Club. Membership at the start of the year was 46, and at the end of his Presidency was 50.
- Tragedy struck the club on 8 April, 1996, with the sudden death of Charter Member Dr Tony Lipson. Tony is remembered as an exuberant vibrant outgoing person with a hearty laugh, and also that little black zip purse containing his fine money at each meeting.
A seat was erected in Echo Point, but after the first seat was "stolen", Tony Hill cemented iron straps deep in the ground and welded all nuts and bolts on the replacement seat. (See photo page 36)
- Membership over the life of the club started in 1990 with 26, rising to 62 in 2009, but declining ever since to the current 22 members at June 2020. Growth up to 2009 was recognised by District awards in 2001/2 when Duncan Whiley was President; in 2006/7 when Cliff Garrett was President, and in 2008/9 when Warren McGurgan was President.
- The late Helmut Buss, as Vocational Service Director, introduced the Quiet Achiever Award for unselfish service to the club in 2002/03. President Bob Warland presented the first award on 30 June 2003 to Arthur Marshall. After Bob Clarke's sad passing, the Award was subsequently renamed the "Bob Clarke Quiet Achiever Award" on 1 July 2014 by Jade Catherall during her Presidency (2013/14).



- Our wine sales in 2000 were successful despite the red wine being labelled “**CABINET Merlot**”, even after being prior checked by over 6 members.
- Involvement with Sydney City Mission started in 1999 (after an address by Phil Campion) when members began driving for the Fairlight Branch to AA meetings, driving “beats” around Manly and Queenscliff beachfronts and delivering donated bread (Gianfornaia Bakery) to Mission and detox centres in the City. A change in management saw this involvement cease in 2000.
- Community Service awards have been made to 59 citizens for their unselfish and voluntary efforts in the community (Refer pages 54 to 56) .
- Our involvement with District Clubs charging people to walk through the Harbour Tunnel on 12 December 1999 was a total disaster. Poor weather resulted in a total failure and District Clubs were “levied” to cover the loss. Our Club’s contribution was \$500.
- Vocational/Pride of Workmanship awards have been made to 89 people (Refer pages 57 to 61).
- Fun Runs through Castle Cove commenced on 29 July 2012 through the efforts of Duncan Campbell.
- Our involvement with Bunnings BBQ’s started during 2010/11 thanks to Peter Lefmann’s persistence and negotiations with Bunnings.
- An Indigenous Medical Project was initiated by Ted Anderson during the 2000/01 year. The project was based on an initial scheme by Mitcham Rotary Club in South Australia, and enabled recipients to study medicine at the University of Newcastle, in anticipation of their return to their communities after qualification. The project became a District project, and the club received a District award in 2001/02.
- An interesting club visit in 2007 was to see the Royal Coach being built by James Frecklington in Manly. The coach eventually went to the Royal Mews at Buckingham Palace. (See photo page 36.)
- The club organisation was restructures in 2008/2009 with a reduction in the number of Directors from 8 to 5.
- Rotary “Grace” was replaced with Rotary “Thanks” by Nick Brooke during his Presidency in 2010/11.
- During Will Rogers Presidency (2011/12), there were changes to the



meeting format; No “Rotary Thanks”, National Anthem only on special occasions e.g. DG Visit; President’s chain only worn on special occasions and at the President’s discretion.

- The club’s first Strategic Plan was initiated by a task force headed by Stuart Frith (whatever happened to this?).
- Following an address by Rotarian Roger Norman (Turramurra Club), John Chinn, with assistance of the late Bob Clarke and Ross Symons, championed the graffiti removal project in 2009, resulting in a grant in February 2010 of \$4,000 from Ku-ring-gai Council and the loan of a high pressure water sprayer. The graffiti trailer was purchased and stored gratis ever since at Storage King Chatswood. In the early days 18 members volunteered to clean public infrastructure and some private premises which made donations to the club. The project still functions today.
- During Cliff Garrett’s presidency (2006/07) 15 members and partners travelled to Trangie for a drought relief concert. A partly sponsored BBQ was provided for 400 locals, and 300 donated gifts given to the community. All food for the BBQ was purchased locally. This led to a student exchange for year 11 and 12 students, and mock interviews for jobs and job application preparation.
- Meeting Bulletins have been produced for every meeting, and despite endeavours to change to a “News Sheet” for other than formal meetings, and use of online ClubRunner publications, the members elected during 2012/13 to revert to the hard copy Bulletin of today.
- The many social functions, too many to list. Here are a few selections;
 - Winning the dress up as Baywatch at the Sydney International Convention
 - The Sunshine Shennanigans Performance at the 2001 District Assembly
 - Cow Girls and Boys dress up for the 1999 District Conference held in Tamworth
 - The Doctors and Nurses Night, McABBA night, Chicago Night and more
 - Wine bottling in Bob Clarke’s warehouse (Cliff Garrett claims more wine was spilt on the floor than bottled),
 - Clay pigeon shooting at Merriwa and attending the Merriwa races
 - Pittwater yachting race challenge
 - Jazz in the gardens, and Twilight Concerts at Taronga Zoo.
 - AND many many more - all fun nights and events.
- Sponsoring Laurette Chao as a GSE team member to North Florida, USA from 14 April to 24 May 2000.



- Julian Gregory was Team Leader for the GSE team to Lone Star State and Oklahoma, April 2011. The team included Sophia Kim, who was sponsored by the Club.
- Ian Garrard was Team Leader for the GSE team to District 2440, Turkey in April/May 2013.
- Some International programs;
 - The Club hosted a District dinner for the Argentinian GSE team, during 1996/97
 - The Club hosted a Dinner for the GSE Wheelchair team from Arizona, USA, during 2008/09. The philosophy of the team members was "I can do whatever you can do"
 - The Club accommodated the GSE Team from Germany, District 1900, and assisted with transport to selected vocational sites.
 - in 2001/02 the Club collected 40 cartons of books and sent them to *Sagatoka Rotary Club* for distribution to under privileged people.
 - During 2004/05 and 2005/06, the club collected 10 cartons of books and sent them to the *Parikrma Home for Orphans*, Bangalore, India.
 - During 2005/06 the Club collected spectacles from optometrists shops and members and sent them overseas under the *Forsight Australia* program.
- Some Rotary Foundation programs involving grants;
 - The Milch Cow Project during 2007/08, under which the Club purchased and donated 21 milch cows (buffalo) to the Vinukonda village in Andhra Pradesh, India.
 - Under the Biogas Plant, Mumbai India project, the club in conjunction with the Bombay Metropolitan Rotary Club, constructed 40 biogas plants for families in a remote tribal village.
- The Timor Leste Connection; The club has been involved with 4 major projects in Timor Leste, with financial contributions;
 - *Manufahi Teacher Training and Resource Centre*, Same. Financial contribution with Northbridge Rotary Club. Centre opened January 2010.
 - *Friends of Maliano , Odomau*. School toilet block and water reticulation, again in conjunction with Northbridge Rotary Club.
 - *Teachers for Timor* project. Club provided financial assistance for the employment of teachers during 2007/08 and 2008/09.
 - *Ermera Water and Sanitation project*. Financial contribution 2019/2020.
 - *Olokasa School Ossu*, Water and Sanitation Hygiene project with Chatswood Rotary Club.
- Some other International projects include;
 - Rotary Volunteers, a RAWCS program, where 2 members and partners took part in refurbishing the Lenake Hospital, building another hospital and school in Vanuatu in 2006/07



- *Uganda Water Supply and Sanitation Global Grant Project*. The club contributed to this project steered by the Rotary Clubs of Texas, USA and Calgary, Canada, and involved 10 Rotary Districts.
- *Rotary Oceanic Medical Aid for Children (RAWCS)*. The club has financially contributed to programs which enables children with horrific facial disfigurement, either at birth or by accident, to be brought to Australia for life changing surgery.
- *Interplast*. Financial assistance enables medical teams to travel to Asian countries to provide consultations and operation services for things like cleft palates, and tumor removal operations.




