- 1. Rotarian member must work with a proposed member to fill out the Membership Proposal and Application. (page 2 of brochure)
- 2. Rotarian member must sign and date the application, then submit it to the President or Secretary.
- 3. Board reviews application and votes on whether to approve the membership.
- 4. If Board vote is successful, the secretary will post the name of the prospective member to the full membership for a 10 day comment period.
- 5. After a successful comment period. member will introduce proposed member as new member at a meeting and new member will be presented with the new member packet.
- 6. New members will be invited to provide classification talk at a future meeting.
- 7. New members are invited to attend annual *Fireside Chat* as a new member orientation.
- 8. Rotarian who presented the proposed member shall serve as a mentor for the new member if desired.
