END POLIO NOW





Bob Rogers reported (using slides to back him up) that no new wild polio cases have shown up. The last reported cases were in January, and they were in Afghanistan and Pakistan. Reporting from Afghanistan may be a little difficult this year. Rotary 5150 - Marin, SF, etc. is sponsoring a French river cruise to benefit polio eradication next May. The flyer is appended after the Closing Bell.



Mike Ferguson introduced the program with a speech about his recollection of what was happening to others during WWII and the lack of information available to the public such as the internment camps for the people of Japanese descent. **Mike** explained that we need to remember so we don't repeat.



The second introduction came from **Nao Noguchi**. **Nao** explained the unique background of <u>Henry Kaku</u> and how he and his family made it back to the US. Henry is part of GIRI (Giving Back, Going forward.) The Sonoma Country Japanese American Citizens League. He is part of their oral history group.



Henry Kaku is a third generation Japanese American. His entire family was incarcerated during WWII for 4 years. At the end of the War, they were deported and had their US Citizenship taken away, because Henry's Father spoke out against being sent to prison. When Henry was born in Japan, he was Stateless because the US Citizenship of his parents had been revoked. He became a US Citizen in 1956 when his family was reinstated as US Citizens. Henry graduated from SJSU with a degree in Psychology. He was a High School teacher/counselor as well as a Human Resource Director in Banking for 30 years. Currently, Henry is a Substitute Teacher and Martial Arts and Origami Instructor in Petaluma.

Henry explained that Anti-Asian sentiment has been part of the American Culture since the first Asians Came to the United States. Asians have experienced hatred from when they were first brought over to help build the Transcontinental Railroad system in the 1860's to the current day association with COVID. In America the "Melting Pot" refers to the White Europeans who immigrated to this country, NOT to those of Color. The many examples of discrimination and hatred include: the 1890's the Anti-Asian Exclusion act, the banning of Asians from coming to America in the 1920's, anti-Asian violence in the 1980's leading to the killing of an Asian man because the auto industry had to lay off workers in Detroit, violence against Asians after the 9/11 destruction of the Twin Towers, and now because of COVID, violence against Asians has increased to over 9,000 acts of violence against Asian in 2020.







But the most outrageous act against Asians occurred during WWII when 120,000 Japanese Americans were sent to Internment camps. Some 75,000 were Americans born in the United States. Henry's family were among the few who protested being incarcerated. His father who was serving in the US Army before the War began was kicked out of the Army and sent home to be sent to be incarcerated. They spoke out against how they were being

treated, being in prison, losing their livelihood and all possessions, having all their civil rights taken away, and having NO recourse. Henry's father was separated from his

mother, sister (age 3) and brother (age 6 mos.) and sent to a POW prison in North Dakota for over a year.

Then to top it off after the War had ended, in March 1946, the family was sent to Portland Oregon, their US Citizenship was taken away and they were deported to Japan. Henry's entire family born and raised in America became Stateless. He was born in 1948 in Japan and for the first 8 years of his life was Stateless.



In 1956 after his parents hired an attorney in San Francisco, where he took his family's case to the Superior Court, the Judge declared that the US government did not have the right to take their US Citizenship away and thus they were able to come home.

These stories of unjust acts against minorities in this country which have continued for 100's of years, need to be told. It must stop. We need to learn from our past mistakes and end discrimination.


Sue Engle managed the margarita table and served them around. Some actually swam in the pool or played Corn Hole. Most sat and chatted and had a great time.


Dr. Evans started his journey as a 16 year old volunteer, walking from village to village in Central America vaccinating young children for polio, smallpox and measles.
