



## SEBASTOPOL ROTARY EDUCATION FOUNDATION

From a tiny acorn, the mighty SREF fund has grown to over 1.1 million dollars today. The Board carefully spends a certain small portion each year. SREF is also offering Paul Harris points for all donations over \$100 that are made this year.

## MAJOR PROJECT INITIATIVE

**Jack Blasco** took the microphone to discuss the vision the Club has for a Major Project. He pointed out that Learn to Swim, Financial Literacy Training, the Crab Feed, Overcoming Obstacles Scholarships, and Mark Sell Teacher Grants originated in this club and have become some of our signature projects. However, at one time we didn't do any of these things. A Rotarian saw an unmet need in the community and came up with an idea for how to meet that need.



The goal of the Major Projects Committee is to proactively identify unmet needs in the community and come up with new major project ideas, instead of just waiting for them to bubble up. Although we don't have funds to adopt a new project this year, the Committee is coming up with a menu of project ideas that could be adopted in the future. A major project has to meet a significant unmet community need and provide Rotarians an opportunity to work together. It should be attractive to non-Rotarians as well. So **Jack Blasco** and **Aleia Coate** are co-chairing the exploratory committee and ask for your input. Project idea forms were left on the tables, and a version you can complete on your computer will be emailed to all club members.

She has since won other World Championship crowns.

**Andrea** lives in Santa Rosa and grew up in West County. She is currently the director of wine development at Coppola. She has done stints at other wineries as well. But how did she come to logging sports? Many years ago, as a freshman at Cal Poly SLO (Go Mustangs) she was encouraged to either take an academic section in forestry or try out for the logging sports team. Yes, the Team. She demonstrated her skill with a chain saw and quickly made the squad.



From there, the rest is history.

After graduation, she realized that she enjoyed the sports which include bow saw, log rolling, chopping stuff up, and throwing the axe, among others. She found that she could continue to compete, first as a novice,



and eventually as a professional. She traveled to various competitions and was often victorious. A high point was the World Champion Axe Throwing trophy that she won in 2006.

She can split a bottle cap at twenty paces. She showed her axe and her hatchet but didn't give a demonstration. **Gene Nelson** said that he brought an apple along in case she went looking for a volunteer but we had to be content with checking out her gear. It was a truly fantastic and entertaining program.

## AFTER THE BELL - SREF UPDATE

After our meeting concluded SREF President Scott Briggs sent the following information to all club members by email.

For the benefit of those who could not make today's Club Meeting, here is a summary of my SREF presentation:

Our SREF Board of Trustees is actively pursuing ways to augment our SREF funding base, in part to offset financial losses experienced during these tough economic times, but mainly to increase SREF's ability to financially support both our Club's education-related programs and SREF's independent funding efforts. Current SREF programs include direct financial support of our Club's educational activities, and SREF's Teacher of the Year program, SREF's continued support of the Construction Corp's West County Chapter (which provides direct trade training and job placement to students attending Analy High School), and SREF's funding of a much-needed, second mental health wellness class at Analy High School.

For the benefit of newer Club members, SREF is a 501c3 non-profit foundation whose Board of Trustees (drawn from our Club membership) manage what one can roughly think of as Sebastopol Rotary Club's "savings account"...i.e., those monies given as tax-deductible gifts over the past three decades to an ever-growing, permanent fund to support our Club's educational activities. In contrast, using this same analogy our Club's Board of Directors effectively manages our Club's "checking account," an account which grows and wanes each year from Club fund raisers and Club operating expenses and programs. SREF's bylaws strictly limit SREF expenditures to a portion of interest earned on investment, thus protecting the fund's corpus. In practice this has translated to annual SREF expenditures equaling about 4-5% of SREF's current assets.

This year's SREF Board, impacted by the ongoing economic downturn that has reduced SREF's ability to fund programs, is now focused on increasing SREF's funding base. SREF Board Trustee Jim Pacatte spearheaded our efforts by making a \$5000 donation. Jim also appealed to Club Member Frank Mayhew for additional help, which has resulted a Mayhew stock donation worth about \$36,000. But importantly, both of these donors want their generous donations to inspire other Club members to donate. So these two gentleman have offered one additional and very significant incentive to potential donors. Specifically, financial donations to SREF do not traditionally count towards Rotary's Paul Harris Awards program. So Jim and Frank have agreed to donate Paul Harris credits they each have received, as a result of major previous donations to Rotary International, to any Club Member making a donation of \$100 or more to SREF this December, 2022. Each new donation will earn both dollar-for-dollar Paul Harris credit and the tax benefits that come with a donation!

By day's end today, members Van Gorder, Given, Rodella, Carter, and Briggs all agreed to follow Jim and Frank's example by making additional SREF donations. We sincerely hope that you too will consider making a SREF donation. Take this

unique opportunity to gain Paul Harris credit for your SREF donation, and help us to build SREF's, and our Club's, financial strength. Thank you very much,

## **AFTER THE BELL - MAJOR PROJECT INITIATIVE UPDATE**



After our meeting was concluded Major Project Committee Co-Chairs Aleia Coate and Jack Blasco sent the following information to all club members by email.

This summarizes the information about our major project initiative that was presented at our club meeting today. We hope you take a few minutes to read about the initiative and use the form attached to our email sent on Friday December 2 to send us your major project ideas.

What do learn to swim, financial literacy education for high school students, overcoming obstacles, teacher grants, the crab feed all have in common? They are all signature programs for our club, but at one time we didn't do any of those things. Then a Rotarian saw a need in the community, had a great idea how to address that need, and a new program was born for our club.

We know that there are a lot of unmet needs in our community, and we want our club to stay relevant and attract new members. So this year instead of just waiting for the next big idea to bubble to the surface we're actively trying to seek them out. We're actively looking for ideas for our next major project.

What do we mean by a major project?

- It meets a significant unmet community need
- A project that our club can "own", increasing our visibility in the community
- Provides an opportunity for Rotarians to work together
- Is explicable to donors: when we tell them what we are doing, they immediately get why we need their money, and why it is a good use of that money
- Attracts non-Rotarians to participate and potentially become members.

Unfortunately we don't have enough money to do another major project this year, but we're developing a menu of major project ideas that will hopefully inspire future presidents and their boards to do something great.
