



## Rotary Club of Lancaster South

### Basic Information

**Fiscal/Rotary Year** – The Rotary fiscal year is July 1 to June 30.

**Dues** – Annual Dues \$200.00. Dues can be paid on the Club’s website by clicking on the “Donate to Club” button and selecting “Annual Club Dues” or by making a check payable to the “Rotary Club of Lancaster South” and mailing it to the Club Treasurer – see address in the sidebar below.

**Club Meetings** – Bi-weekly meetings (2nd and 4th Wednesday mornings) start at 7:30 a.m. and end promptly at 8:30 a.m. The Club currently meets at Meadia Heights Golf Club, 402 Golf Road, Lancaster PA 17602. If Club members miss a meeting, they can do a “Make Up” by attending another Rotary Club meeting or by attending a Rotary event. “Make Up” cards are available for visiting Rotarians.

**Attendance** – Upon arrival at a Club meeting, a greeter will be at the door to welcome you. Place your initials beside your name on the attendance sheet. Put your weekly breakfast fee (currently \$15) in the money box and pick up your badge.

**Breakfast** – Breakfast is available at approximately 7:15 a.m. Help yourself to the breakfast buffet and sit wherever you want. Members are encouraged to sit at different places in the room to get to know more Rotarians.

**Happy Dollars** – Members are given opportunity to celebrate, remember special events, etc. with Happy Dollars during Club meetings. The money supports Club philanthropy initiatives.
