## **MARILYN DIAZ WALKER - TEAM LEADER**

Marilyn, is a Los Angeles native, who served 32 years with the Pasadena Police Department, retiring as a commander. In 2006, she became Sierra Madre, California's police chief and served through 2011. During her career, she worked in Vice-Narcotics, investigating prostitution, sex trafficking and drug crimes.

Jill is a dedicated law enforcement professional with 16 years experience serving the City of Los Angeles. She has worked in multiple specialized assignments, including Patrol, Narcotics, Special Problems Unit, Missing Persons, Internet Crimes Against Children (ICAC), and Human Trafficking Unit (HTU).

Russell served as prosecutor in Churchill County, NV; Chief Deputy District Attorney for Humboldt County; and was elected District Attorney of Humboldt County. After many years of service, was recruited by the Nevada Attorney General (AG) to be Criminal Chief. Russell created the Human Trafficking, Money Laundering and Cybercrime Units within the Nevada AG's Office to begin prosecuting this crime under the newly passed human trafficking law.
