#### PRESIDENT'S REPORT 2023 - 2024

#### INTRODUCTION

In reviewing the content provided for this report by the fantastic board members (aka the Brain's Trust) I was reminded of one challenge still ahead of me in what was to me, a fulfilling year, as President: "How do you fairly summarise, the good that was done in 2023 – 2024 to create hope?" The answer is with considerable difficulty. A good start would be with thanks, a recap on our strategy, before finishing with a description of the actual journey.

Firstly, my thanks. I have already acknowledged the Brains Trust members in the foreword to this report and take the opportunity to do so again and to also thank and acknowledge all our members who willingly gave what they could back to their communities and to the Club. That thanks must also extend to our partners and our families that support our Rotary membership and volunteer work. Without Margarita's support, I think that I would have been up that proverbial creek *sans* paddles.

This year the Club has had the good luck to have had a leadership team that would be the envy of most Rotary clubs. Our Brains Trust was bequeathed to me from Past President Peter Smith and in turn, with minimal turnover, this Brains Trust is passed on to President-Elect Marilyn Barton. Our board was a collegial body whose harmonious operation ensured collaboration with appropriate consideration of the matters put before it. The professional and Rotary experience of the board enabled a *modus operandi* that freed up decision-making in the context of a plan. That plan required minimal amount direction to be given to the board members. Even that direction was focussed on strategy execution rather than the minutiae. That worked because of a fundamental Melville Rotary operating principle – unless someone takes accountability, then it doesn't happen. I was privileged enough to be the President under these circumstances and my hope is that Marilyn Barton will have that same privilege.

#### STRATEGY EXECUTION

Our plan for 2023 – 2024 was our road map and I am pleased to report the detailed outcomes against that plan at Annex A in this Annual Report. The plan was developed in response to a 2023 membership survey. The survey results suggested some fine tuning was needed in respect of membership experience and the impact of our club's work in our community. This was helpful as it allowed a strategically focus on the Club Services and the Membership and Public Relations domains, leaving the operational delivery to our Avenues of Service Committees. The graphs and stand-alone pages elsewhere in this Annual Report tell the story! Some of the data is:

- The presentation of eight (8) Community based Paul Harris Fellowships.
- Melville Rotarians gave 1573 hours of our time to our communities. This is valued at \$75,700.
- Our cash contributions to our charitable causes totalled \$87,100.
- The average meeting attendance was 17 members and increasing visitor numbers.
- Our leaders met with elected members of the Commonwealth and State Parliaments as well as the Mayor and several Councillors from the City of Melville.
- ♦ We fully or partially achieved 87% of the steps to success that comprised the 10 elements of the 2023 2024 Annual Plan.

Because of last and this year's programmes, our net membership increased with the addition of Dale Cole, Trevor Ridgwell and David Jamieson as club members and the General Manager of the South of

Perth Yacht Club as an Honorary member. As of 24 June 2024, there are 4 prospective members in the pipeline. Unfortunately, the club lost, our Past President Reverend Howard MacCallum who passed away in March 2024. The club laments the loss of Howard whose life epitomised Service Above Self in his ministry, military, and Rotary capacities.

Did everything go to plan in this year? Of course not. In February 2024 the Board agreed that we could no longer support the Aboriginal Education Scholarship due to it being supplanted by Commonwealth Scholarships. Further both sponsored students did not complete their teaching degrees.

As well, after our terrific success with the Queens' Silver Jubilee Tree-Planting, Melville Rotary was left with the task of watering the newly planted trees for two summer periods – the first of which extended into May 2024. However, did this difficulty deter us? No. We stepped up to the plate, watered, and ensure the survival of some of the recently planted trees. Two fabulous examples of turning a negative into a positive were then executed under the leadership of our Director Community and Environment and the President-Elect. They were:

- ♦ The presentation of research results by students from Santa Maria College and Bruce Ivers (two of our tree-planting co-collaborators) was attended 65 people including local politicians, City of Melville Councillors and senior City of Melville officers including the CEO. The 27 March 2024 meeting was one of the largest hosted by the Club in recent years.
- That large meeting provided Marilyn Barton and me with the opportunity for face-to-face meetings with Sam Lim MHR, Kim Giddens MLA and the City of Melville Mayor Katy Mair and City of Melville CEO Gail Bowman. This in turn heightened our profile and impact in the community. Marilyn's actions have provided us with a platform to communicate the Magic of Rotary in future years. Our recognition by fellow Melville Cockburn Chamber of Commerce and Industry members at a recent function was remarkable.

During 2023 – 2024 unplanned activities also presented some great opportunities to bring hope. Two events stand out:

- ◆ The unfortunate demise of the Broome Rotary Club saw Melville Rotary establish a relationship with the Shire of Broome backed Broome Circle with a view to maintaining a Rotary presence in the town. The relationship was welcomed and consummated with the donation of sewing machines to a Broome Circle to teach sewing to first nations peoples by making clothes for people who otherwise could not afford them. Liaison has also occurred local schools. This sets us up for facilitating Rotary experiences in Broome as well as scope for future Melville projects in the Community and Environment and Youth Services space.
- Our Cruising Butterflies project taking to the water for the first time since COVID disrupted our equilibrium. What a fabulous day that made everybody smile and feel good! In collaboration with the South of Perth Yacht Club members and staff, Applecross Rotary Club, and the weather Gods ably co-ordinated by Community and Environment allowed 200 disabled people and their carers to have fabulous 90 minutes on the water cruising around Melville Water.

Having dealt with the strategic matters, it is now the time to look at the highlights from our Services' Committees whose reports elsewhere in this Annual Report contain greater detail. I will confess to have used a little artificial intelligence to extract the following from the reports that the relevant directors submitted. So here we go.

#### **SERVICE DELIVERY**

Club Services (PDG Marilyn Barton)

This team wasted no time in making its impact, through improved co-ordination, on the Club as follows:

 Our Sergeant at Arms, Greg Walkington, was outstanding in getting the meetings organised and he picked up many 2023 – 2024 plan matters to improve meetings for our membership so that we were entertained, challenged, and made to contribute.

- As a club we finalised the decisions pertaining to our meeting venue and times. This decision reduced the cost of Rotary and provided opportunity for growth by remaining a lunch club.
- Graham Wheeler maintaining arguably the best speaker programme in Rotary WA. We had so many fabulous and thought-provoking speakers which arguably increased our appreciation of a variety of subjects.
- Running a fabulous President's Soiree at the Ballard's residence a low cost and well-timed function with a second to none view. It was attended by most members and partners and the collegiality was enjoyed by all.
- ♦ Kareena Ballard and John Mackay ensured that our Markets operated during the extended trading hours leading up to Christmas. The fact that neither the Melville Plaza Vendors nor the Market suffered means that should extended hours become the norm, our Markets (which have operated for 41 years) will continue. This gives Melville Rotary financial certainty which is the envy of many Rotary clubs in WA as well as providing the firm base for the financial results provided elsewhere.
- ♦ Our constitution was updated by PDG Ed McKinnon and will be put out to members during 2024 2025 for member approval.
- ♦ Holding a purely fellowship (and relaxing) meeting at our first meeting in January 2024 that reflected the holiday spirit.

#### Community and Environment (Ian Williams and Charles Waterton)

Abetted by pretty much every member, this team made a pretty big impact during the year. Consider:

- ♦ Tree planting and watering Need I say more! Alas after the long summer drought only 15% of the planted saplings survived until the first rains arrived in late-May 2024.
- Cruising Butterflies another big day with big outcomes.
- The Art Show. Organised by James and Tracey-Anne Morris with assistance of David and Pam Porter. It was successful and provided an opportunity for artists to exhibit their work, with 112 artists exhibiting 326 paintings. This year's show also provided the platform for Art Online which sees the art show become virtual for 51 weeks. Art Online will provide another long-term revenue stream.
- Many substantial donations to various community groups and organisations., all of which is doing good and bringing hope.

#### International and Foundation (Leigh Smith)

This committee brought a lot of hope during and put into action doing good on an international scale as well organising a well-attended and thoroughly enjoyable Club Christmas function. Not only did the Committee oversee a comprehensive donation programme to various Rotary/Rotary Foundation aligned projects, but they also facilitated:

- Strengthening our partnership with the Borderless Friendship Orphanage in Chiang Dao Thailand. This included a visit to the orphanage in March 2024 and personal fundraising to donate a twin-cab utility vehicle for transportation.
- Purchasing microscopes and donating them to a Bali orphanage as well as the Borderless Friendship school.

#### Membership and Publicity (David Porter and James Morris)

The Membership and Publicity Team provided the bedrock for Melville Rotary's successes this year. This was done by:

- Increasing membership, improving member experience, and increase public awareness of the Club and Rotary in general. This was done by facilitating the presentations of community-based Paul Harris Fellowships, where possible in the place that the recipient serves, in front of their peers.
- Inducting new active members Dale Cole, David Jamieson, and Trevor Ridgwell, as well as honorary members Michael Sassella and David Timmel from local community groups.

- Supporting existing members by promoting a reduction in annual dues, advertising members' businesses on the Club website, joining the Melville Cockburn Chamber of Commerce and Industry, and funding IT support for club technology.
- Focussing on public image via storytelling initiatives, promoting Rotary projects in the local community, strengthening ties with local organizations, and exploring opportunities to reintroduce Rotary programs in Broome.

#### Vocational Services (David Hewitt supported by Greg Walkington)

This small but energetic team boxed above its weight to deliver the following events:

- ♦ The Pride of Workmanship Award to Sophie Vowles at the Melville City Hockey Club for her work at the Hockey Club.
- Ensuring that members gave 5-minute thumbnails on their personal journeys and career highlights. We got to know more about Ed McKinnon, Dale Cole, James Morris, David Hewitt, and Trevor Ridgwell.
- Maintaining support for the 4 Way Test with Marilyn Kench representing the Club and District at the District and State finals.
- Maintaining, with considerable difficulty, connections with All Saints College and Leeming Senior High School to assist them with vocational programmes.
- Vocational Visits and Social events in our locality, namely:
  - o A tour of the Azelia Ley Homestead in Spearwood followed by a lunch at the Carrington Tavern.
  - o A social electronic darts night followed by a meal at the Norfolk Hotel.
  - Celebrating the Rotary Birthday at Tompkins on Swan when members of Melville, Applecross, Attadale, Booragoon, and Victoria Park Rotary Clubs met for collegiality in the best Paul Harris spirit.

#### Youth Services (Ross Ballard)

Youth with the benefit of hindsight had a difficult year in part due the loss of contacts in schools that in turn reduced their ability to find suitable applicants for their programmes. Having said this, they did not let difficulty deter them and funded the following:

- ♦ Maia Ravenscroft's attendance at the National Science Youth Forum. Her presentation at our 24 June 24 meeting was well received as it provided insights into what the Forum covers.
- Lakhshmideep Jeelaga's journey with the Leeuwin Sailing Foundation.
- Mary Del Poweta's attendance at RYLA. Mary has expressed and interest in joining our club and has occasionally assisted with the Markets.
- An attendee at Camp opportunity, sponsorship of the Robert Porter Award at All Saints college, YMCA's Remote Indigenous Youth Kokoda Expedition and the North Lake Senior College Breakfast Programme.

While some doors remained closed, Youth Services opened others by establishing connections with Broome schools via Broome Circle, and with the City of Melville to publicise Melville Rotary youth related awards and programmes throughout the City of Melville. Melville Rotary was also asked by DG 9423 Governor Ineke Oliver to be the lead contact for Rotary WA in respect to the re-vamped Leeuwin Sail Training Association.

#### **CONCLUSION**

To conclude. All I can say is thank-you to everyone who did good in their communities, whether it be locally, nationally, or internationally. You brought hope! You have your own reasons for being a Melville Rotarian; but it is evident from the collective performance documented in the Annual report, that you each adhere to the Rotary Four Way Test and that you strive to meet the objectives of Rotary. As the Magic of Rotary turns me into a feather duster, I thank you for the honour being your President in 2023 – 2024 and *por fin muchas gracias a mi esposa magnifica y te amo mucho – Margarita*.

#### ROTARY MELVILLE TREASURERS REPORT 2023 – 2024

#### 1.0 SUMMARY

The Board adopted a conservative Budget forecasting expenditure of \$156670 and a small surplus of \$1830.

An updated Budget was adopted in February showing an increase in project expenditure by \$20000 due to the improved operations of the weekly Melville Markets.

Whist we are not at the end of the financial year a surplus is expected. Our term deposit of \$ 126316 is also expected to return an interest payment of over \$3000 that will be used to reduce membership costs.

#### 2.0 FINANCIAL PERFORMANCE

A summary of financial statements as at 31 May 2024 is attached. Final statements will be presented at the AGM following audit. Helen Langlois has done an excellent job in maintaining our accounts and will continue to support our club.

The Board adopted a small surplus budget in June 2023. This was revised in February 2024 following better than expected performance in market income, rationalisation of market expenditure and increased bank interest on the term deposit. Club dues were set at \$340 with \$292 being for RI, District and RDU dues. A revised income of \$171221 and a revised expenditure of \$170714 was expected. The current accounts are in line with that expectation.

The Rotary Melville/Mineral Resources Aboriginal Education Scholarship ceased with the Club being refunded \$7500 in unexpended grant monies. MR \$15000 contribution was paid to ECU at their request.

The Administration costs remain a source of review to make it less costly for members on one hand but the need to maintain credibility of our club communications and Image on the other. Allowances were made for some paid IT support, Storytelling and Book keeping. The latter being allocated to the running of the Markets. On the income side offsets included the interest from the Term deposit and the proceeds of one Market held to raise funds to support the Club in doing its charity and volunteering work.

The revised expenditure budget allocated to Committees is summarised below:Community and Environment \$14500 + \$27500 grants + \$3000 Rotary Health + \$10500 extra
International and Foundation \$15000 + \$6000 Foundation + \$5950 extra
Youth \$13000 + \$4500 extra
Vocational \$1000
International Public Image \$3300

The use of the funds by each Committee is reported separately by the committee chairs.

#### 3.0 CLUB ACCOUNTS

The club continues to operate the following accounts with May 2024 balances of:-CBA Charity account \$56615 CBA Administration account \$19173 CBA Rotary Art Show account \$5810 BOQ Investment \$126316 BOQ Savings \$14

The CBA merchant account and therefore our Eftos facility was closed by the CBA without consultation. We now have a CBA Smart Mini payment tablet on the Art Show account and on the Administration account. The Club also has on line payment facilities for Pay Pal and Simplify on the Charity account.

Payments from accounts are set up by the Treasurer, initiated on line by Margaret River Bookkeeping and authorised online by the President. This has satisfied the Auditor for probity and provides clear governance. The Treasurer remains the administrator of all accounts.

In view of the number of accounts, respective Bank security initiatives and the considerable disruption to operations by frequent changes of account signatories the Board continues to agree to minimise changes to those signatories. All Accounts still require two parties to sign any transaction. I do not propose we change any current signatories unless those persons resign from the club or the Board dictates otherwise.

#### 4.0 AUDIT

An Audit Review of the Club accounts was undertaken by William Buck Advisory. A copy of the audit report is attached.

The 2022/23 audit report indicated that our club finances and operations were in good order. The management of market cash remains an issue but our records provide very good measures should a discrepancy occur.

#### 5.0 RETAINED FUNDS

The Club has commitments beyond each annual budget that others rely upon. If there were any prolonged disruption to our markets we would need to use retained funds. The Board has resolved to hold funds to cover one years basic operation and commitment. A minimum reserve fund balance of about \$62000 is still required.





#### Annual Report for the Rotary Club of Melville Club Service **Committee 2023-24**

The members of the Club Services Committee were PDG Marilyn Barton (Chair and President Elect), President Phillip Draber, PDG Ed McKinnon (Governance and Youth Protection), PDG David Barton (District Liaison), PP Kareena Ballad (markets), Janice Pounder (Webmaster and Bulletin), Greg Walkington (Sergeant), PP Graham Wheeler (speaker programme) and Ann Edgar. The committee met on a monthly basis throughout the year. The following is a synopsis of the work of the Club Services committee members.

#### Governance and Youth Protection: PDG Ed McKinnon

- Club Directory: A PDF copy of the Club Directory has been printed.
- Working with Children: Club member's names were collected and relevant paperwork completed and sent to District.
- Policies: The Finance Policy has been updated in conjunction with David Porter and the Awards Policy has been updated.
- The Club constitution has been updated.

#### Markets: PP Kareena Ballard.

The markets overall have done very well this year, especially in comparison with the previous year, and there have been some record attendances. Some of this may have been due to ongoing fine and sunny weather. Usually about \$3,000 in takings on a

fine day. The markets were closed for only two Sundays - Christmas Eve and New Years Eve

#### Issues discussed:

- The shopping Centre has been very good to work with
- One male will always be rostered on, especially if there are two females also rostered on, as it's good to have a male presence.
- Sellers should be reminded that they will be charged for any cars left in bays.
- Ways to manage difficult sellers include standing next to them and stop them from selling.
- The bottom spinner was replaced as it was chapped and marked.
- New Forms: were printed.
- Sponsorship from the coffee shop:
- The coffee shop to be approached to see if they will sponsor the forms. If they are agreeable, then we may need to put the coffee shop's logo on them
- Cleaners: they are paid \$600.00 per week. The shopping centre also pays them some money. The shopping centre to be asked to pay for them (or at least for some of their hours) to see if we can save some money.
- The short term licence expired on December 31st, 2023 and was renewed.
- A complaint about people smoking at the markets was received. Response "We have no legal status to do anything about it.".

#### Liaison with District 9423: PDG David Barton

- District 9465 was not wound up until well into 2024, due to the dispersal of District funds. But the 9465 Board resolved all outstanding issues and the district was finally wound up in April of this ear as was 9455.
- Council on Legislation: There were 26 proposals put up, and only six were adopted. These will be attached with the minutes. Work continues on all other legislation items.
- PR Seminar: Attended by PP David Porter, President Elect PDFG Marilyn Barton and PDG David Barton. Not a lot came out of it, except that David Porter presented our club on a very good light by sharing the development of our storytelling.
- Regionalisation pilot was approved by the board of Rotary International and the pilot will begin on July 1 2024, there will be changes to the way the districts operate. Things will be done on a National basis rather than a State basis. The role of the District Governor is being considered.
- Rotary Community Groups. One new structure being put in place is the new Groupings. There will be six Rotary Community Groups in WA as from the 1<sup>st</sup> July, 2024, and the Rotary Club of Melville is in Community Group One, along with Applecross, Attadale, Booragoon, Cockburn, Como, E-WA, Fremantle, Willetton, Mill Point and Victoria Park. Marilyn Barton attended a Group One Roary Community Group zoom meeting in March, 2024, along with the other President Elects for the group and focus of the meeting was about working collaboratively with other clubs.
- There will no longer be any Assistant District Governors, but these will be replaced by six Rotary Community Group Leaders. PDG David Barton has been appointed as the Rotary Community Leader group 1. David was also appointed to the National Zone membership Committee, which will be up and running

on 1<sup>st</sup> July, 2024. He attended a workshop weekend in Brisbane in April, 2024. He has also been appointed to the Zone Projects and Programmes Committee and as a Rotary Specialist.

#### Liaison with the South of Perth Yacht Club: PDG Marilyn Barton:

The Yacht club has been very accommodating to give the Rotary Club of Melville use of the Ballroom free of charge for its lunchtime meetings, and also allows members to bringing food from the outside for their lunches, as the Yacht club kitchens are closed on a Monday. Coffees and other drinks can be purchased, and water is provided on the tables.

#### **Property:**

A revised and simplified induction charge was introduced for welcoming new active members.

We have three new potential new members in Jennifer Spanbroek, Matthew Charlton and Louise Tomlin who have been invited to join and a new nominee in Paula Brensell.

We unfortunately lost Howard McCallum and many members attended his memorial service.

#### MEMBER SERVICES

The committee was mindful of supporting our existing members and did this by:-

- Promoting a reduction in annual dues through use of the proceeds of one market and the interest from the club term deposit for club administration.
- Advertising members' business on the Club web site as Rotary supporters.
- Joining the Melville Cockburn Chamber of Commerce and making their programmes and events available to members.
- Providing specialist IT support to members so they can better manage their Rotary information .

#### **PUBLIC IMAGE**

#### Story Telling

The committee continued with the story telling initiative to inform the local community about our club. Nicole Cox media and the committee produced stories on:-

The Markets remain our BEST opportunity to connect with the community and to invite involvement in our projects. The incoming committee should advance the use of the markets as a promotion tool.

#### Links With Local Groups

The Club has strengthened ties with several local community organisations through either support of joint projects or acknowledging their contributors (Heros) as either Honorary Members or Paul Harris Fellows. The latter being presented at the recipients local group. In particular the Club has developed working relationships with South of

Perth Yacht Club, Bicton Environmental Group, Melville City Hockey Club and Melville Men's Shed.

With the demise of Rotary in WA north of Geraldton the Club explored an opportunity to reintroduce Rotary programmes into Broome. A relationship was developed with a local not for profit volunteer co ordination group, Broome CIRCLE. Several projects have developed and Rotary WA has asked the Club to keep the initiative alive and promote it to the broader Rotary family. The ultimate aim is to establish a local satellite group who can deal with the local interface under the guidance of our Club.

#### SOCIAL MEDIA

James and Janice have collaborated to improve our understanding and use of our social media platforms. Training sessions have been held on ClubRunner and our Web site. The club also has Facebook and Instagram that are not well used except by the managers of the Markets and the Art Show.

# 2023/24 ANNUAL REPORT COMMUNITY AND ENVIRONMENT COMMITTEE ROTARY CLUB OF MELVILLE

This year has been very busy but, in retrospective, also very successful. This was assisted in no small part by RCM's healthy financial status.

CEC has contributed to many projects, with a combined budget of \$55,000 over the year and those completed are listed below. The major project undertaken was the Queen's Jubilee tree planting at Point Walter/Deep Water Point with a total expenditure over the year of \$14,500

The other major project was the Aboriginal Education scholarship which, regrettably, was withdrawn during the year after an expenditure of \$15,000.

The projects CEC assisted with during the 2023/24 Rotary year were:

Aboriginal Education Scholarship \$15,000 from Mineral Resources Australia

Point Walter Tree planting:

Queens Jubilee Grant \$7,500;

 Broome CIRCLE sewing machines \$2335

Sailability \$2,000 (RCM also provided volunteers to SoPYC)

Total \$54,225

Following the planting by students of Santa Maria college, The Queen Elizabeth 2<sup>nd</sup> Jubilee Tree Planting programme work has involved regular (fortnightly) watering of the planted seedlings. This has been successfully continued, with assistance of volunteers from the community (Thanks, Melville Council) and from the Bicton Environmental Group. Over 400 volunteer hours were invested. The rate of seedling survival was very encouraging until the hot spell we had in February/March, when a large

number of seedlings succumbed to the heat. The current survival rate is about 15%. This has now been supplemented by a further 300 trees planted by students of CBC college

The Aboriginal Education Scholarship was awarded to two recipients identified by Edith Cowan University. The first completed her first semester but then deferred her studies after she fell pregnant. Subsequently she then withdrew from her course because of family issues.

The second student, Joshua Dalton, completed the first semester of the teaching course but then decided to transfer to Commerce. RCM had specifically wanted to support Aboriginal students undertaking a teaching degree and, when Josh decided to move to Commerce, the question of continuing Josh's support in his new study direction came to question. This happened at the same time as the Federal Government announced that it would be awarding scholarships to up to 1000 Aboriginal students undertaking university courses. As the value of these latter scholarships was \$10,000 pa, compared with the RCM \$5,000 pa scholarship, it was decided that RCM would cease offering these scholarships. (MRA decided to continue supporting Joshua's studies in commerce). ECU was advised of RCM's decision and regretfully acquiesced.

The annual RCM Art Show was successfully organised, primarily by James and Tracey-Anne Morris, with considerable assistance from David and Pam Porter. This annual event continues to provide a great opportunity for artists to exhibit their work and is very well received by the community. At the time of writing there are 112 Artists exhibiting 326 paintings.

This has been yet another year where many projects have been successfully undertaken. I would like to personally acknowledge the efforts of RCM members, which have contributed to the successful completion of these projects and to the significant contribution that has been made to our community.

The Rotary Club of Melville International Committee is dedicated to fostering international understanding and supporting global initiatives. This year, we focused our efforts on strengthening our partnership with the Borderless Friendship Orphanage in Chiang Dao, Thailand.

#### March 2024 Visit to Borderless Friendship Orphanage:

A delegation led by Rotarian PP Leigh Smith and including Alison Gal, Brent Cooper, Yuka Sakia, Geoff Parker, and Stephanie Edwards, visited the Borderless Friendship Orphanage in March 2024. This visit was a highlight of the year, allowing us to connect directly with the children we sponsor and the wonderful staff who care for them.

In addition the March delegation donated computers, telephones and transported a large amount of shoes from Perth to be distributed amongst the children.

#### **Building Relationships and Sharing Skills:**

- Alison Gal conducted workshops on deportment, makeup application, and mural painting.
   The children actively participated and enjoyed the creative sessions, adding a splash of color to one of the orphanage facilities.
- Yuka Sakia enriched the children's culinary skills by teaching them the art of making sushi

  potential source of income by selling sushi to soccer teams that play at the orphanage
  complex.

#### **Supporting the program:**

In late June of 2023 Murray & Chris Meaton, Marilyn Kench and a past president of Melville, Doug Minchin also visited the orphanages. They, through their personal donations and very enthusiastic fundraising, purchased a new twin cab utility vehicle to transport the children and supplies. The cost was around \$45,000. Our club via the International committee donated \$6,000 to assist with the purchase, Murray & Chris donated \$5,000 & Doug Minchin donated \$10,000, Lorel & Tony donated \$5000 and the balance was raised via the Royal Perth Golf Club members through Doug's relentless enthusiasm

#### **Looking Forward:**

The International Committee is committed to building upon the strong foundation established during this visit. We are actively exploring further ways to support the orphanage, such as providing educational resources and or vocational training opportunities.

#### **Support for schools:**

The International Committee ordered 130 Microscopes from Rotary International at a cost of \$1950.

David & Marilyn Barton donated 30 microscopes to an orphanage in Bali and the balance of 100 were presented by Leigh Smith to the Borderless Friendship School in Chiang Dao Thailand.

David Hewitt is overseas for the Month of May, and it is yet to be known if Rotary Club of Melville is to proceed with this proposal. I see this may be a developing student program in Rotary Year 2024/2025.

Peter Smith has been in contact with a Broome school lady, and it may be possible for local Youth to nominate for the Leeuwin Adventure Sailing Ship and expand their interest on a Leadership Development program. Funding would be allocated to the air travel of a person to Perth and accommodation cost to be on board the Sailing Ship.

Funding to an amount of \$6,000 is awaiting a Broome response and it may be that there is a possible schools interest, for a student to be nominated soon for this program.

James Morris confirmed that his youth interest in Rugby Works Program P2s was subject to local school principals who over time showed a lack of interest in this community sporting support program. He reported that in your year no further action was taken to promote external program for local youth development.

On a brighter side we have a Philippine student Ms Mary Del Poweto – RYLA Camp attendee and she presented a very well performed overview, as to her personal experience at a Melville Rotary Luncheon Meeting. Mary Del Poweto has partly assisted with the Tree Watering Project and is keen to be involved in the Melville Rotary Art Show in June 2024.

As Director I come to the end of the Rotary Year 2023/24, and you will take over as Director Youth Committee in Rotary Year 2024/25. My role in the two-year Directorship of Youth comes to an end. I have enjoyed the support you and other members provide in a year, for which a schools youth interest in Rotary Camps and community events has evolved.

#### Notes to the Accounts

#### SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

These financial statements are a "Special Purpose Financial Report" prepared solely for the Board and Members of the Rotary Club of Melville to enable compliance with the Bylaws and Constitution of the Rotary Club of Melville and the Charitable Collections Act (1946).

The Board of Directors of the Rotary Club of Melville has determined that the Rotary Club is not a reporting entity and therefore, as there is no requirement to apply Accounting Standards and other mandatory professional reporting requirements (Urgent Issues Group Consensus Views) in the preparation and presentation of these statements none have been adopted.

The Charitable Collections Act (1946) requires financial reporting within six months of the end of each financial year "which clearly shows the various types of charitable collections received and the manner in which these funds have been dealt with".

The statements are prepared on an accrual basis from the records of the Rotary Club of Melville. They are based on historical costs and going concern assumptions and do not take into account changing monetary values. The accounting policies have been consistently applied, unless otherwise stated.

### Statement by the Treasurer

Monies received from Club functions, bays and Upper Spinner are a significant source of revenue for the Association The Association has determined that it is impracticable to establish control over the collection of the abovementioned income prior to entry into its financial records. Accordingly, as the evidence available to us regarding the abovementioned income was limited, our review procedures with respect to the abovementioned income had to be restricted to the amounts recorded in the financial records. We therefore are unable to express a conclusion whether cash receipts from the above mentioned income of the Association recorded are complete.

### **Emphasis of Matter - Basis of Accounting**

We draw attention to Note 1 to the financial report, which describes the basis of accounting. The financial report has been prepared for the purpose of fulfilling the Association's financial reporting responsibilities under the Bylaws and Constitution of the Rotary Club of Melville (Inc) and the Charitable Collections Act (1946). As a result, the financial report may not be suitable for another purpose. Our conclusion is not modified in respect of this matter.

#### **Other Matters**

The financial report of the Association for the year ended 30 June 2022, were audited by a predecessor auditing firm whose opinion, dated 14 December 2022 was qualified.

A review is substantially less in scope than an audit conducted in accordance with Australian Auditing Standards and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in an audit.
