


January is Rotary Awareness Month

Legal Department - *How private is your property...*

Several laws allow properties to be entered without the owners' consent.

Your home may be your castle but it is not a fortress. In some circumstances, police, emergency services and utilities employees have the power to enter your property without your consent.

Indeed, access to your property may be more open than you imagined, as Acting Police Sergeant Sharon Darcy points out. "Anyone has the right to walk up to a front door and knock on the door."

Revoking the implied licence to enter is a simple matter, according to property lawyer Darren Eliau of Evans Ellis Law. He says displaying a "Do not enter" sign, "such as those available from any \$2 shop", is sufficient to prohibit entry.

"There's no actual convention at law that says there is a certain wording that you must say. It's not governed by any statute. It's just what's reasonable.

'Do not enter', 'Do not trespass', 'No canvassers', 'No hawkers' — those types of things," Mr Eliau says.

If there is no sign, a verbal request to leave revokes a person's right to enter your property. Again, there is no exact wording and a vernacular indication will suffice.

Someone who has been asked to leave a property should not assume that, just because they are not hurting anybody, a shouting match is acceptable. It is not.

Mr Eliaou says the usual position in law, in which a party needs to show loss before they can sue, does not apply.

"Trespass is a bit different. It is what's called actionable per se — actionable just because you did it. You don't need to prove a loss or damage," he says.

Nor should a visitor deviate from their intended lawful purpose. A plumber is not entitled to pick flowers; that is trespass.

Tenants have the power to restrict access to the properties they occupy. "The tenant can exclude the rest of the world," Mr Eliaou says. "Just as we all can. That's the right of the tenant. They live in their rented place as if it's their place."

The community expects that essential services, including the protection of our health and safety, should be available to everyone. To supply these services, providers sometimes need to access a property without an owner's consent. In these cases, laws often enhance the service provider's rights of access.

The general manager for customer and community at Sydney Water for example, says: "We have the power to go on to properties, through the Water Industry Act, to access meters. We read the meter once a quarter. We also do meter exchanges."

Utility is not the only category of easement. Rights of way, carriage and support also entitle people other than the property owner to use the land.

A complex area of law, property owners are not always aware of the easements that affect them.

Acting Sergeant Darcy says the circumstances that allow police to enter a property are clear. "We've got powers without warrant and powers to enter with warrant. There's also another, which is an officer's authority to search for stolen goods.

"So there are three different types of powers of entry to property that police can use. They all relate to criminal offences."

Section 459A of the Crimes Act 1958 is an example of a statute that gives police power of entry without warrant. The section covers circumstances in which police have knowledge that a person who has committed an offence (indictable to five or more years of jail in Victoria) is inside. Police can enter that property to make an arrest.

Police also have the power to enter without warrant to stop a disturbance of the peace. Should police officers be standing at the front door and hear a fracas within, they are allowed to enter.

"We have a power to enter to stop that breach of the peace," Acting Sergeant Darcy says. "We can only remain on the premises as long as that breach is occurring. Once that breach of the peace is finished and everything is under control, we have no right to remain on the premises."

Since 2003, anti-terrorism laws have also given police the legal authority to enter a property without warrant.

Many laws are administered locally and all councils have various powers of entry under different acts of Parliament.

"These acts specify how that power is to be exercised, even if a search warrant has been obtained," says Glen Eira City Council director of community relations, Paul Burke. The duty to remedy "nuisance" under the Public Health and Wellbeing Act falls to council-appointed environmental health officers, who have the right to enter a private house if the "nuisance" is deemed "a risk to public health or offensive".

Rights of entry vary under different acts. The Domestic Animals Act 1994, for instance, stipulates that the power of entry is to the land and non-residential buildings only - not to the actual building of residence.

The RSPCA gains its powers of entry from the relatively recent Animals Legislation (Responsible Ownership) Act 2001.

Since 2004, surveyors have a right to access land without the owner's consent. Again, the terms are specific. The surveyor must hold a surveyor's licence and access is permitted only when the completion of a survey is dependent on access.

Ambulance officers have no enacted rights of entry. Their right to enter is drawn from common law. The legal justification stems from the necessity to preserve life.




They did this and had a great time. However, with their hangovers and tiredness, they overslept all day






What is Rotary?
