# **Gateway Rotary Club**

## **Service Committee Strategy**

### **Background**

Gateway Rotary receives many requests each year to support non-profit community organizations or to sponsor a variety of community events. Each request has its merits, but Gateway Rotary requires a set of criteria for evaluating, and supporting, or declining requests.

### **Objective**

Establish a set of criteria for determining if requests for support align with Gateway Rotary club's vision, values, and program objectives.

### **Overall Service Project Focus**

Gateway Rotary Club Service Projects shall focus on providing direct education services to youth in the community and/or support to children of military families who have had a parent killed or injured during active service to our country.

Gateway Rotary Club Service Projects are long-term efforts that take place on a quarterly basis for about 4 hours at a time. Projects should create, provide, and enable positive health, education, mentoring, and lifestyle activities and choices for youth, and especially at-risk youth.

Service Projects shall provide opportunities for every club member to volunteer, be present, and participate in activities that meet the objectives of Rotary.

### **Overall Sponsorship Focus**

Gateway Rotary Club shall focus on supporting and promoting youth programs in Thurston County, supporting children in Thurston County who have lost a parent in military service to our country, and supporting International public health projects identified by Rotary International.

Gateway Rotary shall support programs that provide and enable positive health, education, mentoring, and lifestyle activities and choices as well as services and activities that provide direct care and support for youth that are socially and economically disadvantaged.

## **Gateway Rotary Club Service Committee Strategy**

***Requests that address the Overall Sponsorship Focus shall meet the following criteria:***

- Provide a clear description of the program and activities
- Provide results and outcomes that are measurable and can be evaluated
- Demonstrate fiscal and management capabilities proportionate to the request
- Demonstrate broad-based community support
- Demonstrate competent and qualified, board members, qualified staff, and /or committed volunteers
- Demonstrate that the activity or program is beneficial to a substantial segment of the community
- Demonstrate that the amount of the contribution is reasonable and justified
- Provide meaningful public recognition of Gateway Rotary's support and/or sponsorship
- Enable and encourage group or individual Gateway Rotary club member involvement.

***Requests and support restrictions include, but are not limited to, the following:***

- Alumni drives
- Memberships
- Memorial funds
- Travel, tourism, or tours
- Professional sporting events or athletes
- Organizations based outside of the United States
- Religious organizations for purposes not related to health and wellness
- Organizations that practice discrimination on the basis of age, political affiliation, race, national origin, ethnicity, gender, disability, sexual orientation or religious beliefs
