



FRIDAY JUNE 14TH AND SATURDAY JUNE 15TH

On Friday June 14th on Paper Mill Island and Saturday June 15th at Mercer Park, Baldwinsville Rotary will be holding our annual Seneca Rivers Days. This family and community event will provide a means for you to sell your merchandise, promote your activities, create public awareness of programs and goals, and raise funds for your projects. Fund raising could involve the sale of goods or food, and games. The following restrictions apply.

- ~ No alcoholic beverages
- ~ No games of chance or raffles (THIS WILL BE STRICTLY ENFORCED)
- ~ We attempt to limit the sale of any one item to one vendor only (to avoid competition between vendors), so early registration is advisable.
- ~ No fee for an information-only booth for non-profit organizations
- ~ \$15 fee for a non-profit selling non-food items, per day
- ~ \$25 fee for all other non-food vendors, per day
- ~ \$150 fee for food vendors on Saturday
- ~ \$200 fee for food vendors on Friday
- ~ \$300 fee for food vendors who participate both Friday & Saturday

Space allotted will be approximately 12 feet wide by 12 feet deep per vendor. Those needing additional space will be accommodated if space is available and <u>prior arrangements have been</u> made. If multiple spaces are requested, the above fees apply. Limited electricity is available. Request early if you will need it. You supply the cord.

Reservations will be available on a first come first served basis; we reserve the right to decline participation. Placement of all Vendors will be at the discretion of the Baldwinsville Rotary. Registration fee is refundable if proposed participation is not approved, but not refundable if participant cancels.

On Friday Set-up begins at 3:00pm and must be done before 5pm. Tear down will be after the fireworks finish, around 11pm.

On Saturday Set-up begins at 7:30am; vehicles must be out of the park by 9:00am. Take down cannot begin until 5pm, after the duck race has finished and must be completed by 6:00pm

ALL REGISTRATION W/FEES MUST BE RECEIVED BY ROTARY BY MAY 19TH. NO PERSONAL CHECKS WILL BE ACCEPTED AFTER THAT DATE

Participants must provide: tent, table, and chairs if required. Provide NYS Sales Tax Certificate if required.

Food Vendors-Pepsi products only allowed for beverage sale

Food Vendors must also provide;

*Special temporary permit from Onondaga County Health Department for this specific event.

*Certificate of Insurance-minimum of one million dollar liability, naming the Rotary Club of Baldwinsville as an additional insured. No permit or certificate, no participation.
