Rotarians who attended the Grants Sessions at the District Assemblies will remember the Community Building Partnership Program (CBPP) grants. The NSW Government is investing in infrastructure projects that deliver positive social, environmental and recreational outcomes, while promoting community participation, inclusion and cohesion. There is between \$300,000 and \$400,000 available in each State Electorate.

The 2019 round opens 9.00am on Monday 2 September and closes at 5.00pm on Friday 27 September.
