Membership Dues Amounts


Dues that include pre-paid meals are \$80/month. This includes the weekly meals at our Thursday meeting.

Dues that do not include pre-paid meals are \$30/month.

This is designed for members who cannot regularly attend Thursday meetings but will be involved with service projects, volunteer/work events and socials. When you are able to come to a Thursday meeting bring a meal or buy the lunch for \$15.

Donor membership dues are \$110+/month, with any amount over \$80/month being tax deductible. This level is designed for members who are able to contribute more to help fund our club and the many projects we support each year. This is separate from donations that members may make monthly to the Rotary Foundation (<https://www.rotary.org/en/foundation-build>) and PolioPlus (<https://www.rotary.org/en/plus-polioplus>).

DIRECT PAYMENT PLAN/ACH

We are pleased to be able to offer you the Direct Payment Plan/ACH. You can have your Rotary dues paid automatically from your checking or savings account every month. You won't have to change your present banking relationship to take advantage of this service.

The Direct Payment Plan will help you in several ways.

- It saves time – fewer checks to write and it saves postage!
- Easier on your monthly budget to pay monthly rather than quarterly or yearly
- Saves the Club money, especially if you were previously paying by credit card
- Helps meet your commitment in a convenient and timely manner – even if you're on vacation or out of town
- It's easy to sign up for, easy to change or cancel

Here's how the Direct Payment Plan/ACH works:

You authorize monthly dues to be paid from your checking or savings account. A payment in the amount of your dues will be made automatically on or about the 5th of every month. The authority you give to charge your account will remain in effect until you notify us in writing to terminate the authorization. If the amount of your payment changes, we will notify you at least 10 days before the payment date.
