

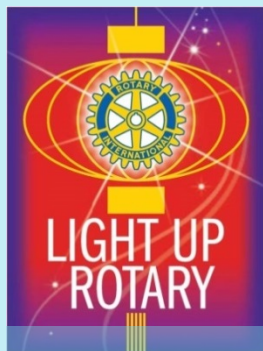

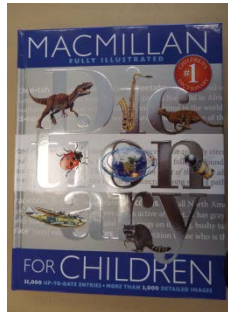

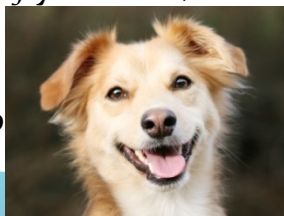

SPEAKER OF THE WEEK

CLUB BUSINESS

Instead of Club Assembly, we are going over the by-laws of the club because current practice does not always follow the by-laws.

Rich Hale : will work on this. It has been wrong for the President to choose his/her Board. **Dean Henricks** also said that electing the Treasurer and Secretary positions are a separate process.

Article I Election of Directors and Officers

Section 1 - At a special meeting, no later than October fifteenth, a nominating committee, consisting of all of the available past presidents, shall prepare a proposed slate of nominees for president-elect, vice-president, and the number of directors at large needed to fill the available slots on the board of directors for the ensuing Rotary year.

Justin Whitsell said he thought the President Elect was the Vice President. **Dean Henricks** said that sometimes the Vice President became the President Elect by not always. There are potentially 10 Board Members: Past President, President, President Elect, Secretary, Treasurer, Vice President and Avenues of Service folks) **Scott Nygard** and **Dean Henricks** were "elected" to work on the by-laws. Anyone who wants to help is more than welcome.

Section 3 - Vice-President. It shall be the duty of the vice-president to preside at meetings of the club and board in the absence of the president and to perform such other duties as ordinarily pertain to the office of vice-president.

Christi Woodards reports that the language regarding Treasurer duties is weak and there are only basic key points in the manual. She suggests adding that the Treasurer collects dues and fees, reports the state of the club's finances monthly, balances monthly, prepares an annual budget, and helps prepare his/her successor for the tasks. (**Christi** also said that we have gone to Sage credit card processors. She will prepare an invoice through the website or she will bring a swiper thing to use with her phone at lunches, but she will not take credit card numbers over the phone, etc. This will reduce the chances of fraud/hacking and also eliminate personal liability.)

It shall be the duty of the treasurer to have custody of all funds, accounting for same to the club annually and at any other time upon demand by the board, and to perform such other duties as pertain to the office of treasurer. Upon retirement from office, the treasurer shall turn over to the incoming treasurer or to the president all funds, books of accounts, or any other club property.

SPEAKER OF THE WEEK CONTINUED

Laura Powell discussed the meeting day that is written in the by-law. It was suggested that it be changed to whatever time is deemed by the Board rather than change it to Wednesdays and possibly changing it again in the future.

Section 1 - Annual Meeting. An annual meeting of this club shall be held on the first Monday of December in each year, at which time the election of officers and directors to serve for the ensuing year shall take place.

Section 2 - The regular weekly meetings of this club shall be held on Mondays at 12:15 PM.

Ray Riehle discussed the information on leaves of absence. He said in the past it was approved, usually without a reason. Ray would like each leave to have a valid reason and have the application signed by the Membership Chair or President. The expectation is that the person will not be at the weekly lunches (although they can attend the other events) so they cannot use the leave as a way to get out of the time and money investment that it takes to attend the lunches. The limits set for the duration of a leave and how many a member can have is to be discussed.

Article IX Leave of Absence

Upon written application to the board, setting forth good and sufficient cause, leave of absence may be granted excusing a member from attending the meetings of the club for a specified length of time. Such leave of absence does operate to prevent a forfeiture of membership; it does not operate to give the club credit for the member's attendance. Unless the member attends a regular meeting of some other club, the excused member must be recorded as absent, except that absence authorized under the provisions of Article VIII, Section 2(b) of the standard Rotary club constitution is not computed in the attendance record of the club.
