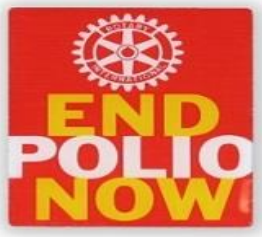

## HIGHLIGHTS OF THIS WEEK'S PROGRAM

PP **David Stone** introduced **Shelli Bolsover**, Certified Safety Specialist.

**Shelli Bolsover** has one of the most fun and fulfilling jobs in the universe. She works both behind a desk and in the field to keep people alive and whole. She is currently a Corporate Safety Specialist at Pacific Gas and Electric Company but she has represented bargaining unit mechanics as their union elected Safety Person at United Airlines all the way to Manager in the PG&E Safety Department. **Shelli** has a Master's Degree in Business Administration, a Bachelors in Industrial Technology and is a Certified Safety Specialist. In her spare time she is a Rio Linda Lion, teaches at the University of Davis Extension and with her wonderful husband, adopted and raised 5-kids. She is here to talk about Safety in the Utility Industry.

### Safety in the Utility Industry We Have Come a Long Way

#### Worker and Employer Responses

- Workers and firms responded to these dangers in a number of ways. Some workers simply left jobs they felt were too dangerous, and risky jobs may have had to offer higher pay to attract workers.
- life and accident insurance companies expanded, and some workers purchased insurance or set aside savings to offset the income risks from death or injury.
- Some unions and fraternal organizations also offered their members insurance.
- Railroads and some mines also developed hospital and insurance plans to care for injured workers.

### Safety in the Utility Industry We Have Come a Long Way Workers' Compensation Laws

- in 1910, New York became the first state to pass a workmen's compensation law.
- Instead of requiring injured workers to sue for damages in court and prove the employer was negligent, the new law automatically compensated all injuries at a fixed rate.
- Compensation appealed to businesses because it made costs more predictable and reduced labor strife.
- To reformers and unions it promised greater and more certain benefits.

### Safety in the Utility Industry We Have Come a Long Way Occupational Safety & Health Act (OSHA) - 1970

- Develop and enforce job safety standards
- Monitor job-related illnesses and injuries
- Provide research to solve occupational safety and health problems

The primary focus of safety practice is to prevent incidents and accidents that may lead to injuries, illnesses, damage to property and equipment, or harm to the environment. Many companies have combined safety, health, and environmental matters into a

single department.

- Track safety metrics as required by law and for good accountability in the company.
- Open new avenues of revenue

### Why You Might Want to Hire a Safety Professional

- OSHA hit Kaiser Foundation Hospitals with nearly \$150,000 in fines for willful violations. Inspectors found that custodial workers were at risk of being infected while removing waste from the hospital's collection box for used needles, "The box," state inspectors reported, "frequently overflowed with uncapped needles..."
- ExxonMobil received by far the largest fine totaling \$566,000 • including 12 serious and six willful citations — stemming from an investigation into an explosion at the company's Los Angeles County refinery in Torrance. Four workers were injured in the accident.
- The 35-year-old man died when the bulldozer he was operating near Big Sur

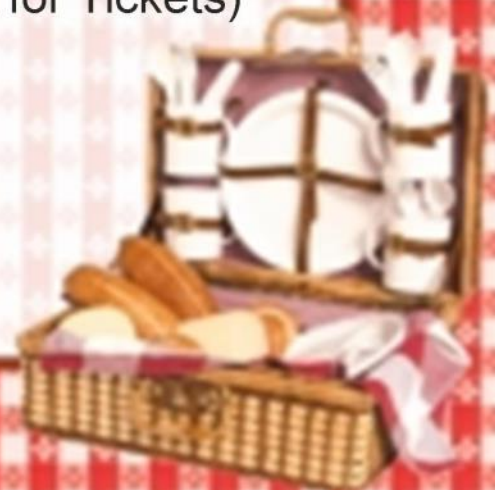

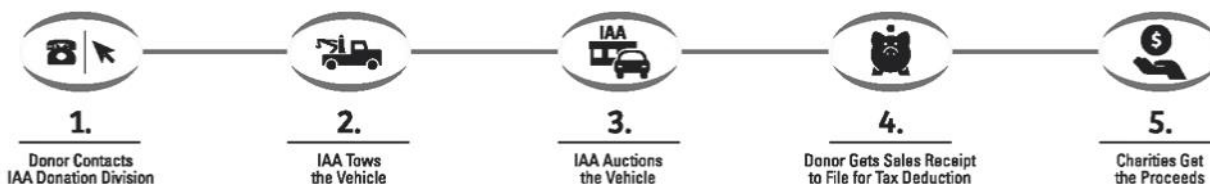
