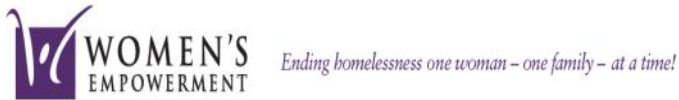
2018 District Conference

HIGHLIGHTS OF THIS WEEK'S PROGRAM

PE **Patrick Magnani** introduced **Ken Giannotti**, Senior Vice President, Leasing & Marketing at McClellan Business Park.

Ken has more than 25 years of commercial real estate experience including development, leasing, sales, acquisitions, lending and asset management. At McClellan Business Park since 2009, **Ken** has been responsible for leasing activities, including approximately 2.5 million square feet of new leases in approximately 175 transactions. He is also responsible for the company's marketing and public relations initiatives.

Prior to joining McClellan Park he ran the Stanford Ranch project in Rocklin, California. Prior to joining Stanford Ranch, **Ken** served from 1991-1998 as Western Regional Director for USF&G Realty Advisors Inc. where he was responsible for investing approximately \$100 million in real estate assets as well as asset management and pre-development of a \$200 million portfolio of equity real estate. He also worked for AMB Institutional Realty Advisors, Inc. for 1989 to 1991. From 1983 to 1989, served as Vice President for Metropolitan Life Insurance Company in development project manager and asset management team leader roles.

Ken began with a brief review of the history of **McClellan Air Force Base**

At its peak, McClellan Air Force Base was a significant economic engine and one of the largest employers in Sacramento, employing both civilian and military personnel. The base was the single largest industrial facility in Northern California, employing up to 26,000 people as it operated as a logistical depot for over 60 years. However, McClellan's future as a viable military base was abruptly brought to an end.

The end of an era; in 1995, it was announced that McClellan Air Force Base would be closed as part of the Base Realignment and Closure process. As a result, 11,600 jobs were lost. This was devastating to the local economy, resulting in a loss of \$1.5 billion annually. The announced closure of McClellan effectively paralyzed development throughout the North Highlands area, adding to fears of additional blight and higher crime. However, thanks to vital partnerships formed between the Air Force, Sacramento County and McClellan Business Park, the facility was not shuttered completely. A Hot Transfer concept was initiated where private businesses were brought into vacant buildings even prior to official closure. This critical transition process allowed McClellan to retain a minimum level of employment, and for growth to begin even prior to the base's official closing.

Revitalization

Eight years after the official closure, McClellan Air Force Base is now McClellan Business Park, a growing business enclave that hosts a diverse mix of companies spread across more than 8 million square feet of space of all types. This former military facility is now home to hundreds of private companies, as well as state, federal and local government agencies and has become a magnet for private investment.

A total of \$580 million dollars has been invested across the project in infrastructure and building improvements. This amount reflects direct investments of over \$208 million from tenants, \$280 million dollars from McClellan Business Park and \$88 million dollars in grants from several state and federal agencies, Office of Economic Adjustment, Economic Development Agency, and Environmental Services Cooperative Agreement. 230 tenants employ an expanding workforce estimated at 15,000 daily visitors;

companies include Surewest, Northrop Grumman, J.C. Penney, The USDA Wildfire Academy, Beutler Heat and Air, Regional Transit, California Department of Transportation, Cal Fire, The US Coast Guard, AAR ATICS, General Dynamics, XO Jets, Flight Options, Ozark Trucking, Patriot Rail, SMUD, Twin Rivers School District, Americorp and many more. 70% of McClellan Park's available space is currently occupied. This revitalization is the direct result of a successful partnership between Sacramento County and developer McClellan Business Park.

The Future

A healthy and prosperous McClellan Park means a vibrant and thriving North Highlands community. As one of the most successful conversions of a former military base in the country, McClellan Park has the entitlements to construct an additional 6,000,000 s.f. of new buildings, creating the potential to employ a workforce of 35,000 at full capacity. Because of the symbiotic relationship with Sacramento County, the Sacramento Housing and Redevelopment Agency, the United States Air Force, and the surrounding community of North Highlands, continued development of the Park will continue to bring jobs and is essential to improve the surrounding community in the essential areas of blight mitigation, infrastructure improvement and job growth. Further investment is paramount for the future growth and success of McClellan Park and the North Sacramento region.

MEMBERSHIP MOMENT

Asking your fellow members about people they know in the community who would be assets to the club is an important step in membership growth. Prospective members are likely to rely on the experiences and opinions of their friends, family, or colleagues when considering joining an organization like Rotary. Encourage others to invite prospective members to club meetings, service projects, and events so they can see how your club helps the community and provides opportunities to form connections and friendships. It may take a few conversations or several visits for prospective members to get a full understanding of Rotary and how they could benefit from membership. It's important to allow that time to make sure that it's a good fit for everyone involved.

OUTCOME Identifying prospective members and actively recruiting them will help your club:

- Develop a pool of potential candidates for membership
- Determine how to introduce prospective members to your club
- Get new members who are well vetted and more likely to stay

GETTING ORGANIZED Set aside time for members to complete the worksheet on page 3.3 at one of your club meetings. Typically, this exercise works best at the beginning of a Rotary year, when annual membership goals have just been set, or in March, when the incoming president is planning for the next Rotary year.

Clubs around the world approach member recruitment in very different ways. Customize this exercise to make it appropriate in your region.

Two out of every three prospective members who are referred by a Rotarian join Rotary. If

a prospect can't join your club but is interested in Rotary, help Rotary grow by referring him or her to another club.

3.2A PROSPECTIVE MEMBER EXERCISE

GETTING STARTED Ready to start? Here's how.

Step 1: Ask members to complete the Identifying Prospective Members Worksheet Explain the purpose of this exercise and how it relates to the assessments your club has already completed. Distribute the worksheet to club members and ask them to complete it. Compile the information from the worksheets and maintain a master list of prospects.

Step 2: Make an action plan Compile the names that were circled on the worksheets and make a plan to invite those people to a club meeting, service project, or social event. If you conducted classification and diversity assessments, refer to the list of groups you found to be underrepresented in your club. Your plan should specify who you'll invite, to what, who will invite them, and how they'll do so.

Step 3: Invite prospective members to a club event Invite the people you identified as qualified prospective members to attend an upcoming service project or meeting. Or host a special event where they can meet club members and learn about the club in a casual atmosphere. Make them feel welcome by having the club president or another leader greet them personally.

Step 4: Follow through

- Ask members who invited prospective members to contact their guests and report back on their interest in joining.
- Keep the worksheets and your compiled list for future recruiting efforts.
- Regularly go to My Rotary's Club Administration area to track membership leads gathered through Rotary's website.
- If you find people who are interested in Rotary and qualified for membership but not a good fit for your club, refer them to another club.

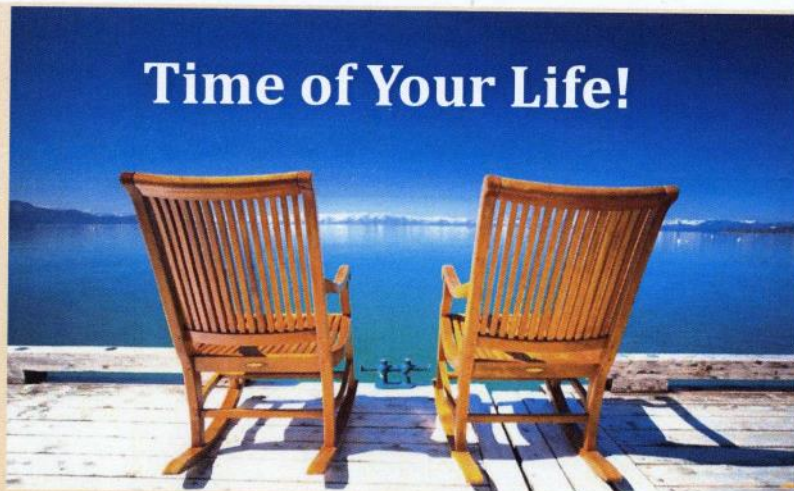

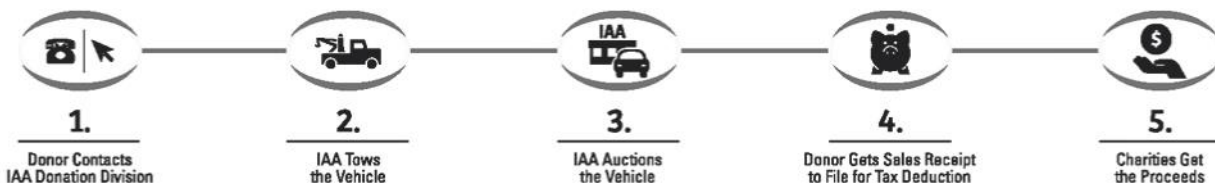
