

# HIGHLIGHTS OF THIS WEEK'S PROGRAM

Program Chair **Jordan Backhaus** introduced **Eric Eisenhammer** who was substituting for our original speaker — **John Cox.** They are with the organization Rescue California Educational Foundation Inc. (RCEF), a nonpartisan 501(c)(3) organization, concerning a fundamental reform to the legislative process in California that has the potential to transform the way legislation is considered and enacted in our state.

**Eric** is knowledgeable on a range of public policy issues and is talented in community outreach to diverse coalitions, web development and email and social networking marketing.

His experience includes work on numerous statewide proposition campaigns and advocacy efforts. **Eric** is also active in nonprofit organizations supporting job creation, economic development, human rights and drug-free youth.

**Eric** holds a master's degree in Public Policy and Administration from C.S.U. Sacramento and a Bachelor's in Business from C.S.U. Northridge.

**John Cox** and **Eric** both feel our present government is dysfunctional. Special interest groups hold too much sway and influence.

Average citizens are unknown to and unrepresented by their legislators.

Legislative districts are the largest in the nation by a huge factor:

♦ Assembly: 2,500,000 people

♦ Senate: 1,000,000 people

According to their research, California has the worst representations ratio in the U.S.

Winning big district elections takes big \$\$\$.

The average cost to win a Senate seat is \$1,100,000 and the cost to win an Assembly seat is \$837,000. The cost to win competitive seats is \$2,200,000.

The Legislature is captive to Special Interest Groups. Lobbyists actually write bills.

The problem is the structure:

- Huge districts which are unworkable.
- Cronyism.
- Corrupt System.

The solution: Uberize the Legislature

- Create smaller districts.
- Real accountability.

How it will work:

- Local campaigns. Anyone cam run.
- 12,000 locally elected citizen representatives.
- 120 go to Sacramento for hearings and drafting bills.
- 12,000 citizen reps vote up or down on legislation.
- In constant technological communications with constituents.
