HIGHLIGHTS OF THIS WEEK'S PROGRAM

Program Chair **Jordan Backhaus** introduced Sacramento County DA **Anne Marie Schubert**. **Anne Marie** is a career prosecutor with over 25 years of law enforcement experience. As the DA, she has prosecuted some of the area's most notorious and dangerous criminals—murderers, rapists and child molesters. She has also created innovative programs for the DA's Office focused on catching killers and criminals using DNA evidence, helping the children of our community by combatting truancy and honoring those citizens who have provided service to justice with the development of the annual Outstanding Citizens Awards. **Anne Marie** has received the Prosecutor of the Year Award and the POST ICI Instructor of the Year Award.

One of **Anne Marie's** passions is the pursuit of justice through forensic DNA evidence and cold case prosecution. She is nationally recognized as a forensic DNA expert.

Anne Marie was elected as Sacramento County's District Attorney in 2014 with the support of former District Attorney Jan Scully, Sheriff Scott Jones, law enforcement associations and crime victims' organizations

and sworn into office in January 2015.

Anne Marie started her presentation by stating that we are faced with a myriad of propositions on the November ballot and it is important to educate ourselves on them; and in particular, Proposition 57 and Proposition 64, before we cast our votes.

Proposition 57—The Public Safety and Rehabilitation Act of 2016. This public policy change is intended to affect the California Prison Population.

In 2009 and again in 2011, the federal government ordered California to reduce its prison population. The U.S. Supreme Court ruled that California's prisons were overcrowded and violated the eighth amendment. Prison numbers dropped after California voters approved Prop 47 in 2014 which reduced certain non-violent felonies to misdemeanors and gave more inmates a higher chance for parole consideration. Prop. 57 is also designed to lower prison populations.

During his first stint as Governor, Jerry Brown signed a bill that provided fixed penalties for many serious crimes and felonies, removing the option of parole for inmates convicted of such crimes. Governor Brown has stated that Proposition 57 was written to remove some of the harmful side effects of that bill.

Opponents, of which **Anne Marie** is one, feel the measure was poorly written. While the measure states that only "non-violent" criminals would be eligible for early release, in actuality persons who committed such crimes as rape of an intoxicated or unconscious person, assault with a deadly weapon, human trafficking involving a sex act with a minor, arson and other crimes of this degree of severity would be eligible for parole.

Proposition 57 permits the worst career criminals to be treated the same as first offenders discounting strong sentences imposed by a judge. It effectively overturns key provisions of Marsy's Law, Three Strikes and the Victims' Bill of Rights.

It gives the California Department of Corrections the authority to award credits for good behavior and places all these new privileges and rights for convicted criminals into the California Constitution, where they cannot be changed by the legislature.

Anne Marie cited an article which appeared in the *Sacramento Bee* in July that stated violent crime in California had increased by 10% for the first time since 2012.

The number of violent crimes reached 166,588 in 2015, about 15,000 more than the previous year. Aside from the small uptick four years ago, and a few earlier blips, violent crime has been on a steady decrease over the last two decades.

The new report said homicides increased 9.7 percent, robberies rose 8.5 percent and aggravated assaults were up 8 percent. Rapes increased 36 percent, to 12,793 from 9,397.

In Sacramento County, violent crime jumped nearly 11 percent, to 8,264 from 7,452.

Proposition 57 will do nothing to stop this trend. The initiative is driven by politics not by what's best for the public.

Anne Marie also mentioned Proposition 64 which legalizes marijuana for use by adults 21 and older. It imposes a tax on sales and cultivation. **Anne Marie** is opposed to this initiative as it contains troubling loopholes within the law and other issues.

Following her presentation, **Anne Marie** opened the meeting up to questions from the Rotarians and their guests.

President Dominic then asked **Anne Marie** to join him at the podium. He thanked her for her informative presentation and presented her with a check payable to the Sacramento Regional Family Justice Center which was the vision of her former boss Jan Scully.

Anne Marie was very appreciative of the donation and thanked us for our support for this vital resource for victims of violence.

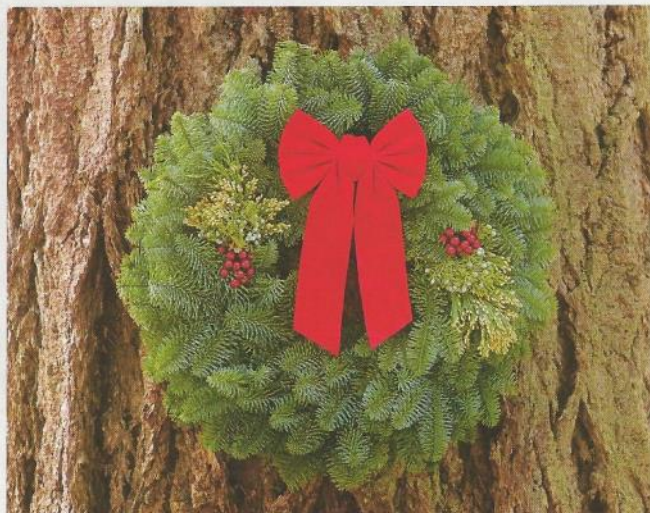

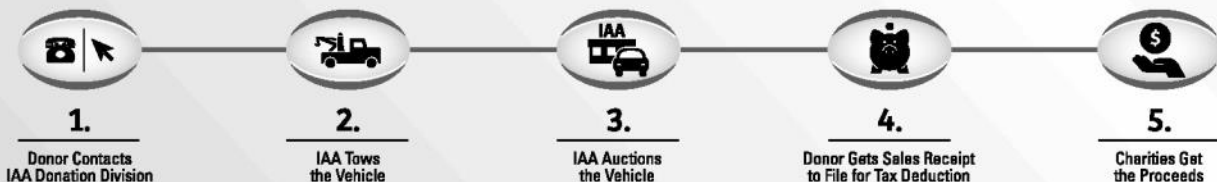
