## Project Overview

---

### Tell us a little about your project. What are the main objectives of the project, and who will benefit from it?

The project aims to set up a 3 bed hemodialysis centre at Mengo hospital, which is a private not for Profit

Hospital in Kampala Uganda, that was founded in 1897, and is a private not for profit establishment, owned by the Church Of Uganda. (Ownership documents are attached.) Mengo Hospital is located at Sir Albert Cook Road, Mengo hill road, Kampala.

Hemodialysis is a treatment to filter wastes and water from your blood, as your kidneys did when they were healthy. It's a treatment that takes over your kidney functions if those organs stop doing their job. It therefore helps in riding one's body of unwanted toxins, waste products and excess fluids by filtering the blood using a dialysis machine. Dialysis is the process of artificial waste removal from the human body in case of kidney failure.

The dialysis machine mixes and monitors the dialysate. Dialysate is the fluid that helps remove the unwanted waste products from one's blood. It also helps get one's electrolytes and minerals to their proper levels in the body. The machine also monitors the flow of one's blood while it is outside of the body. From time to time an alarm may go off, this is how the machine lets the attendant know that something needs to be checked.

The monthly cost of dialysis at the two government facilities where the services are offered averages \$200 to \$947 varying with the availability of consumables. Both centres combined can only offer maximum output of 441 sessions of hemodialysis per week against the unmet need of 120,000 sessions per week (These figures are even higher in the 6 private facilities where dialysis is provided).

The Rotary club of Kampala South will provide this facility at a subsidised cost so as to promote inclusion of various patients with chronic kidney disease, and also ensure sustainability of the facility. The project shall increase awareness on kidney disease and its risk factors, increase availability and affordability of dialysis, promote early detection of Kidney disease through routine screening, improve treatment outcomes and provide employment and training opportunities for health workers involved in kidney care.

Mengo Hospital has fully accepted to provide space for the dialysis centre project.

Project outcomes:

- 1- Reduced cases of kidney related complications
- 2- Increased awareness in the community on causes of kidney failure
- 3- Increased capacity in knowledge and handling of related cases
- 4- Increased access to specialised therapy for kidney diseases

#### Project planning

#### Describe the community needs that your project will address.

The project will address the Chronic kidney disease ailment. Kidney disease is now recognized as a major problem worldwide affecting people of all calibers and socioeconomic status. New borns, children, teenagers, mothers as a complication of pregnancy and child birth, the productive youths, middle aged and the senior. On a monthly basis, this hospital receives about 400 patients with kidney ailments that they are not in position to handle.

The country presently has only 50 dialysis nurses and 8 Doctors specialized in kidney care and teaching. This puts each of the nephrologists in charge of 5 million Ugandans and the Uganda Kidney Foundation (UKF) has since called upon, private and public players to help close this gap. The estimated number of patients needing Dialysis Services in the country is about 40,000 per month, as per the Kidney Foundation.

#### Project outcome:

- With the availability of a dialysis centre the capacity of the hospital will be increased thus reducing the backlog and queues of patients needing the service.
- With the intended community outreaches, there will be increased awareness of the causes and education on avoidance of kidney diseases.
- The training will help increase the number of nurses and doctors specialised in kidney care and teaching.

#### How did your project team identify these needs?

We were approached by Mengo Hospital, as per the attached letter. Our club felt concerned and sent a team of members to the hospital on a fact finding mission and also visited the Uganda Kidney Foundation to



establish the extent of the need across the country and how it is being addressed by the different hospitals.

The community needs assessment was done by our club members, a Mengo hospital team, Kiruddu hospital team and The Uganda Kidney Foundation as per the attached community needs assessment results.

### **How were members of the benefiting community involved in finding solutions?**

Through a meeting of the hospital administration, doctors and the patients the following were suggested:

- An establishment of a dialysis centre at the hospital to reduce the burden of the queues of waiting patients.
- Specialised training of nephrologist and nurses to increase capacity and care within the hospital and at large.
- Conduct community outreaches to sensitive the public on prevention, care and support of patients with kidney disease.

### **How were community members involved in planning the project?**

The hospital agreed to provide and participate in the following ways:

- Provide space to house the dialysis centre with capacity for future expansion
- They will provide security for the dialysis centre
- They will provide a biomedical engineer to conduct routine maintenance
- They will provide and remunerate professional staff to run the centre
- They will participate and provide logistics (vehicles and outdoor audio equipment) to enhance effective outreaches
- They will organise and participate in scheduled routine monitoring and evaluation activities.
- The patients will make a token contribution towards the operational costs of the centre.

#### **Briefly describe the other initiatives and how they relate to this project.**

- The hospital currently has one dialysis machine yet they have over 400 (four hundred) patients per month thus putting severe strain on the unit.

- They have only one full time nephrologist who can only handle 5 - 8 patients a day.
- They do not currently conduct community sensitisation outreaches to support the community in understanding the prevention, care and support of kidney disease.

**Please describe the training, community outreach, or educational programs this project will include.**

- The training will consist of knowledge transfer from the equipment suppliers for running and maintaining of the equipment, the supplier of the equipment has consented to provide training on equipment operations and maintenance. The transfer of knowledge will also include transfer of knowledge and oversight and mentorship from the professionals who include Dr. Daniel Ssekikubo Kiggundu (CVs attached). This will also involve annual reviews and refresher training.
- We plan to conduct regular community outreach activities aimed at sensitising the community on the prevention, care and support of kidney disease. Educational materials shall be prominently displayed at the Dialysis centre and community outreach sites, propagating and educating community about how to keep kidneys healthy and take preventive measures.
- The project will also involve commemoration of the World Kidney Day on 11th March of every year as a signature activity to raise awareness among the public and an opportunity to update the community on developments.

**How were these needs identified?**

- A training needs assessment was conducted by interviewing patients and doctors at Mengo Hospital Renal Clinic coupled with consultations with The Uganda Kidney Foundation. The current statistics on alcohol and substance abuse in the country further support the findings, coupled by poor feeding and lack of adequate exercise. The prevalence of conditions that predispose to kidney disease is high in Uganda standing at 26.4% for hypertension, 2.9% for diabetes, 18.6% for overweight, 3.9% for obesity and sickle cell anaemia in children (3,000,000 people) Guwatudde et al 2015

**What incentives (for example, monetary compensation, awards, certification, or publicity), will you use, if any, to encourage community members to participate in the project?**

- The project will provide discounted rates for use of the services of the centre.
- Reduction of client waiting time for medical attention and services at the dialysis centre will inevitably motivate and increase patient and community attendance.
- The trainings and mentorship programs as a method of skills building are a strong incentive for the medical workers.
- We shall provide certificates and awards participant members the medical workers and community leaders involved.
- The outreaches are treated as activities and social events for members of the community.

- The beneficiary of the project, Mengo Hospital has a governance plan to operate, maintain and run this project. This department is headed by Dr. Daniel Ssekikubo Kiggundu who is qualified and experienced in this area (CV earlier attached).
- This is one of the most established hospitals in the region and has granted space for future expansion which makes the long term aspect more realistic.
- The hospital also has a fully employed a nephrologist and Maria Immaculate Nassali the Biomedical Engineer with CV attached.

### Authorizations & Legal Agreements

#### **Legal agreement**

Global Grant Agreement - to be authorized by the primary contacts and club presidents (or DRFC chairs if district-sponsored)

This Global Grant Agreement (Agreement) is entered into by The Rotary Foundation of Rotary International (TRF) and the grant sponsors (Sponsors). In consideration of receiving this Rotary Foundation Global Grant (Grant) from TRF, the Sponsors agree that:

1. All information contained in this application is, to the best of our knowledge, true and accurate.
2. We have read the Terms and Conditions for Rotary Foundation Global Grants (Terms and Conditions) and will adhere to all policies therein.
3. The Sponsors shall defend, indemnify, and hold harmless Rotary International (RI) and TRF, including their respective directors, trustees, officers, committee members, employees, agents, associate foundations and representatives (collectively Rotary), from and against all claims, including but not limited to claims of subrogation, demands, actions, damages, losses, costs, liabilities, expenses (including reasonable attorney's fees and other legal expenses), awards, judgments, and fines asserted against or recovered from Rotary arising out of any act, conduct, omission, negligence, misconduct, or unlawful act (or act contrary to any applicable governmental order or regulation) resulting directly or indirectly from a Sponsor's and/or participant's involvement in grant-funded activities, including all travel related to the grant.
4. The failure of the parties to comply with the terms of this Agreement due to an act of God, strike, government regulation, war, fire, riot, civil unrest, hurricane, earthquake, or other natural disasters, acts of public enemies, curtailment of transportation facilities, political upheavals, civil disorders, outbreak of infectious disease or illness, acts of terrorism, or any similar cause beyond the control of the parties shall not

be deemed a breach of this Agreement. In such an event, the Agreement shall be deemed terminated and the Sponsors shall refund to TRF all unexpended global grant funds within 30 days of termination.

5. TRF's entire responsibility is expressly limited to payment of the total financing amount. TRF does not assume any further responsibility in connection with this grant.

6. TRF reserves the right to cancel the grant and/or this Agreement without notice upon the failure of either or both of the Sponsors to abide by the terms set forth in this Agreement and the Terms and Conditions. Upon cancellation, TRF shall be entitled to a refund from the Sponsors of any global grant funds, including any interest earned, that have not been expended.

7. The laws of the State of Illinois, USA, without reference to its conflicts of laws principles, shall govern all matters arising out of or relating to this Agreement, including, without limitation, its interpretation, construction, performance, and enforcement.

8. Any legal action brought by either party against the other party arising out of or relating to this Agreement must be brought in either, the Circuit Court of Cook County, State of Illinois, USA or the Federal District Court for the Northern District of Illinois, USA. Each party consents to the exclusive jurisdiction of these courts, and their respective appellate courts for the purpose of such actions. Nothing herein prohibits a party that obtains a judgment in either of the designated courts from enforcing the judgment in any other court. Notwithstanding the foregoing, TRF may also bring legal action against Sponsors and/or individuals traveling on grant funds in any court with jurisdiction over them.

9. This Agreement binds and benefits the parties and their respective administrators, legal representatives, and permitted successors and assigns.

10. If any provision of this Agreement is determined to be illegal, invalid or unenforceable, the remaining provisions of this Agreement shall remain in full force and effect.

11. Sponsors may not assign any of their rights under this Agreement except with the prior written consent of TRF. Sponsors may not delegate any performance under this Agreement without the prior written consent of TRF. Any purported assignment of a Sponsor's rights or delegation of performance without TRF's prior written consent is void.

12. TRF may assign some or all of its rights under this Agreement to an associate foundation of TRF. TRF may delegate any performance under this Agreement to an associate foundation. Any other purported assignment of TRF's rights or delegation of performance without the Sponsors' prior written consent is void.

13. Sponsors will comply with all economic and trade sanctions, including those implemented by the Office of Foreign Assets Control (OFAC) of the United States Department of Treasury, and will ensure that they do not support or promote violence, terrorist activity or related training, or money laundering.
