## **Eligible Applicants:**

City of Santa Fe tax-exempt nonprofit organizations that provide services in the areas of education, social services, medical services, and environmental conservation may apply. An organization that is operating under the non-profit umbrella of another organization (acting as Fiscal Agent) may also apply, but a copy of the fiscal agency agreement must be provided with this application. No religious entities (except if the entity is serving as a Fiscal Agent for the applicant who is providing services in the Areas of Interest); no political or governmental entities. **All applicant organizations must have a sponsor who is a member of the Rotary Club of Santa Fe.** Organizations must be in good standing with the New Mexico Attorney General's Office.

Note that applicants may receive funding from this grant a maximum of 2 out of 3 years.
