RELEASE OF LIABILITY AND WAIVER OF CLAIMS AGREEMENT

In consideration for my participation in activities at the Rotary Club of Hattiesburg's Bike-A-Thon ("Bike-A-Thon") to be held November 1, 2014, at Longleaf Trace and Pride Field, University of Southern Mississippi, I hereby release, discharge and hold harmless the Extra Table, Robert St. John, New South Restaurant Group (e.g. Crescent City Grill, Tabella, Purple Parrot Café, Mahogany Bar, Branch), Rotary Club of Hattiesburg and its officers, directors, members, volunteers, employees, sponsors and agents (collectively "Rotary Club") from any claim, liability, responsibility, loss and damage for all personal injury, illness and property damage caused by or arising out of my participation in the Bike-A-Thon activities. I also agree that neither I nor my heirs or legal representatives will make a claim against, sue or file a complaint against the Rotary Club in connection with any of the matters covered by this Agreement.

- ⇒ The Bike-A-Thon activities takes place outdoors and includes bicycle riding, games, and other vigorous physical activities and therefore includes risks associated with bicycle accidents, falls, equipment failure and exposure to the elements. ***I understand the description of these risks is not complete and that unknown or unanticipated risks may result in injury, illness or death.***
- ⇒ I agree to hold Rotary International, Rotary Club of Hattiesburg, New South Restaurant Group (i.e. Robert St. John, Chairman/CEO) and its affiliates (e.g. Tabella's, Crescent City Grille, Branch, Mahogany Bar, Purple Parrot Café) and any of the aforementioned officers, employees, and volunteers all of whom will be known as "Rotary Club" for the purposes of this event harmless and indemnify it for any claim, liability or damage for personal injury, illness, or property damage that may occur or arise out of Bike-A-Thon activities.
- ⇒ I understand that this Agreement is intended to be as broad and inclusive as permitted by the laws of the State of Mississippi. If any part of this Agreement is found to be unenforceable, the remaining terms continue in full force and effect.
