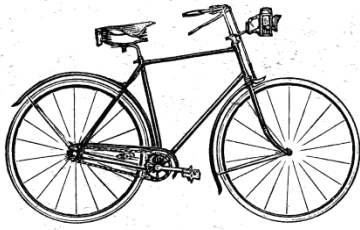

RELEASE OF LIABILITY AND WAIVER AGREEMENT
