LAST WEEK'S PROGRAM

David Senne introduced the guest speaker Rob Schultz, Director of Human Resources at Forrest General Hospital.

Rob began his presentation by showing members photos of the new Forrest General Hospital. The facility was constructed in the early 1950s and just recently underwent phase 9 of a construction project. Phase 9 included a new Emergency Room facility, new beds in the Intensive Care Unit, and a new labor and delivery facility.

Forrest General Hospital is the largest employer in the area. Including the almost 400 employees at the newly acquired Picayune hospital, Forrest General now employs 3,800 people. It is estimated that Forrest General gives back to the local economy \$356,400,000 annually. That includes \$86,400,000 that is written off or uncollected, payroll, and the capital campaign. The hospital serves one-half million people in a 17 county area.

Some of the new improvements at Forrest General include the relocation of the heliport pad. The helicopter is now stationed at the airport but uses the helipad for emergency deliveries. During Katrina the hospital was without normal water and electricity service for four days. Since that disaster, the hospital has installed four generators that will provide full electrical service to the hospital in the event of a power outage. Additionally, a 1,000 foot water well has been placed into service on the property. A new water tank will accompany the well within the next year.

The hospital has also totally renovated the 4th floor and turned it into a Family Birth Place. The facility has state-of-the art equipment and is a result of the many

recommendations and requests made by mothers over the years.

Additionally, the hospital has added a new scanning device, a picture archiving system that allows your physician to view x-rays and other scans from his personal computer at home or in his or her office. The hospital has also instituted a robotic pharmacy. The robot is supplied with prescriptions and then dispenses those medications by reading barcodes on the prescriptions. The object is to reduce the human error factor in medications. Also, satellite pharmacies have been added on each unit, making the availability of medications faster for patients. Another improvement in prescription safety is the institution of a computerized physician order energy system. This allows the doctors to enter medication prescriptions and orders directly into the system, eliminating the time and possible error of misreading orders.

A major improvement that is in the works at Forrest General is the development of a new neo-natal unit. Currently the hospital can handle only 8 neo-natal cases. The improvements will allow the treatment of up to 20 neo-natal patients and will also include a transport vehicle. Finally, Rob shared the hospital's plans to team up with the University of Southern Mississippi in a major study and prevention plan for diabetics. Mississippi's death rate is 11% higher than average. You are 30% more likely to have a heart condition in Mississippi than any other state in the union. Our state's stroke rate is 19% higher than the national average and adult diabetic cases are 36% more likely in Mississippi than the national average. Rob admonishes, We must do something about this growing problem, which is already having adverse financial impacts on state.
