Rotary honors Prime Minister Cameron for supporting a polio-free world

Rotary International has recognized David Cameron, prime minister of the United Kingdom, with its Polio Eradication Champion Award for his leadership and dedication to a polio-free world.

RI President Kalyan Banerjee presented the award to International Development Secretary Andrew Mitchell, who received it on the prime minister's behalf at a reception at the House of Commons on 14 March

The award is the highest honor Rotary presents to heads of state, health agency leaders, and others who have made significant contributions to the global polio eradication effort.



Maura McLaughlin gave club members a brief update on the PETS meeting held this past weekend. Maura encouraged club members to purchase at least two of the District's raffle tickets prior to this year's District Conference. Scott Hummel filled in for Tracie Fowler, March's program chair and introduced today's guest speaker. Claire Whittington. Claire is with the office of the Mississippi State Treasurer and oversees the state's college savings plans.

Claire reported that the MPACT college savings program now has approximately 30,000 participants. The fund is earning an average of about 7.5% annually, however it earned just over 21% this past year. The MPACT program allows you to lock in a college tuition price for your child as early as birth. College tuition rates are increasing at an average rate of 5.5% annually. The MPACT program allows you to purchase "semester hours" which can be used for tuition at a Mississippi community college or a state university in any combination.

The MACS college savings program currently has approximately 12,000 participants. MACS is a more traditional investment tool that currently offers three investment options. A fourth option is to be announced in the next few weeks. Investors can choose from a very conservative investment option, a moderate option or an aggressive option. Equal contributions must be made for each of the options chosen. MACS earnings and deposits can be used for any educational expense anywhere.

Both college savings programs in Mississippi are recognized by the Internal Revenue Service and gualify for a tax deduction. Earnings are tax deferred.


