LAST WEEK'S MEETING

Hayden Mitchell was introduced and asked to present the week's speaker, Forrest Thigpen, Executive Director of the Mississippi Center for Public Policy. Thigpen gave club members an overview of the Center's governing principles and related those to current events.

Principle One of the Center maintains that government exists to protect rights, not to create them. He used the current debate of health care as an example of the Center's questioned stance. He whether government should exist to provide health care. He noted that an assumption that the government has a right to provide health care is also an assumption that the government has the right to take whatever resources are needed in order to provide resources necessary to provide those benefits.

The Center's Principle Three states that "Just because a problem exists doesn't mean government should try and solve it." Thigpen suggested that a government that attempts to solve all problems is a government that may be attempting to create a dependency on government.

Principle Five states that, "Government has nothing to give anyone except what it first takes from someone else." Thispen says the Center attempts to teach this principal to elected officials hoping they will be more responsible when deciding on government spending programs.

Thigpen spent some time discussing Principle Four, which states, "Long-term and cumulative consequences should be considered more carefully than short-term benefits." He used an example of social programs that encourage individuals to remain unemployed and out of wedlock with children. He noted that the two most prominent ways in America to get out of poverty include getting a job and getting married.

Principle Seven discusses free enterprise rather than government as being the engine of personal economic prosperity. Thigpen noted that government can not create wealth; rather redistribute wealth.

Thigpen concluded his comments by noting Principal Ten, which states that, "Parents, not government, are responsible for the education and upbringing of their children." He stated that this was not necessarily promoting home schooling for all children, but was promoting the principle that parents are responsible for their children's education and should have as many options as possible to ensure that the children have a quality education.
