

INFORMATION ABOUT ROTARY PETS 2013

For Presidents-Elect (PE) and Presidents-Elect Nominee (PEN)

BREAKOUT SESSIONS

High-Country PETS breakout sessions are hands-on workshops, conducted by experienced discussion facilitators selected from all five participating districts. These sessions are designed to generate stimulating and informative discussions.

ROTARY "101"

During PETS you will attend a variety of sessions that will teach you about your presidential responsibilities and prepare you to run your Club during your presidential year. As Club president, you will also facilitate your Club's participation in a multitude of Rotary activities, oversee the education of your members about all Rotary has to offer, become the club's "go to" person for a wide variety of Rotary questions and become a Rotary ambassador to your community. This year's optional interactive Rotary 101 session will help you to become an expert in many facets of Rotary, speak knowledgably about Rotary to diverse audiences and provide you with resources to help you answer any questions that might arise in the future. This session is targeted at PEs, PENs, and spouses/ partners who wish to learn more basic information about Rotary. Check with your District to make sure attending will not interfere with a scheduled District session.

DRESS

Casual attire is appropriate for all daytime sessions and meals. Business attire is appropriate for all evening receptions and meals.

REGISTRATION Registration will open by December 1st and will be done on-line: go to your district website and click on "REGISTER for PETS." Please complete the on-line form and follow the payment instructions. Note that registration must be completed by January 31, 2013. REGISTRATION FEE

The \$360.00 registration fee includes tuition, course materials, all breakout sessions and five meals (dinner on Friday, all meals on Saturday and breakfast on Sunday). The registration for partners/ spouses is \$175 and includes all meals and the opportunity to network and learn with other partners. For Presidents-Elect ONLY: You will not be charged for registration as it will be paid by your club or district.

Hotel room charges are not included in the registration fee (see following section).

HOTEL ROOM (Booking required by February 6. 2013 for rate and availability)

You are expected to reserve your own hotel room with the Marriott by calling 1-800-266-9432. Ask for the Rotary PETS rate and you should expect a rate of \$102 per night plus tax. All PEs and PENs are encouraged to stay at the hotel to meet and share with other PEs and PENs. Double occupancy is \$51.00 plus tax for each person. If you choose not to stay at the hotel, your PETS registration fee will be \$462.00 to help cover room block commitments.

Special Note: It is normal practice for Rotary Clubs (or Districts) to pay the registration fee and to reimburse 2 nights shared-room hotel fees for their Presidents-Elect. If you bring your spouse, you will pay the partner registration fee (\$175) and the additional cost of the single room (\$51+ tax for each nights).

President-Elect Nominees are strongly encouraged to attend. Check with your club for possible assistance with the cost of attendance.

DENVER MARRIOTT TECH CENTER HOTEL: The hotel check-in time is 3:00 PM. (Official conference registration will begin at 4:30 PM.) There is a possibility that your room will be available earlier. If not, the hotel will store your luggage until your room is ready.



Those choices are the keys to a happy life for young and old alike, including four daily activities: carrying out a task with a purpose, participating in an activity with another person, engaging in relationships, and providing service to others.
