

Tish Berge is General Manager of Sweetwater Authority, a publicly owned water agency serving 200,000 customers with safe and reliable water in Chula Vista, National City, and Bonita.

Tish is very proud of the fact that since 1977, the agency has supplied water with 100% compliance in quality, not a blemish on a record going back 42 years!

Even though this has been a wet year, the Sweetwater dam is only half full. They may need to buy water in

2020.

One-third of all income is used to keep the infrastructure of pipes and plants and connections up to date as much as possible. A current program to flush pipes of accumulated minerals is in a three year program using trucks with special filtering processes stationed between two connections of pipe and capturing the water without loss. Thy are also using public bonds to selectively replace the worst of the over one hundred miles of aged pipes.

They are developing a Community involvement program that will have a Citizen Advisory Board. More details are forthcoming.

Family Membership Policy (adopted 11/27/18)

- a. An existing member's spouse, partner, or adult child under age 26 is eligible to join the club under a "Family Membership." For this policy, the existing member is known as the index member.
- b. The index member must be a full dues-paying member of the club.
- c. The family member will be charged \$90 per quarter, unless changed by action of the board.
- d. Initiation costs and red badge requirements for the family member are waived.
- e. The family member will be charged at the door for any club fees associated with meals, events, etc.
- f. Dues, meals and fees paid on behalf of the index member are not transferable to a family member.
- g. A family member is considered a full member of the club, and may hold office.
- h. A family member is encouraged to attend meetings, but has no minimum attendance requirement.
- i. A family member is challenged to support the club and RI foundations, and activities.
- j. If the index member terminates membership in the club, a remaining family member must pay the full cost of membership at the start of the next quarter or terminate their membership.
