STEPHANIE said the YMCA has \$185,000 in scholarships.

PRES CHUCK introduced our speaker, DEANNA LORSON, and told us that she lives in Oceanside's Henie Hills, has worked for 2 years as the Oceanside Assistant City Manager, has 3 cats (Striper, Prince, and Bella), and 2 kids in Tri City Christian High School.


DEANNA delegated Fire Chief RICK ROBINSON to be her "Human Clicker" to man the controls of the PowerPoint presentation which described the Focus of the City of Oceanside as:

<u>Quality of Life in Oceanside</u> – It's a great place to live, do business, raise a family, and retire. Residents favor quality of life and quality of city services.

The city has identified urgent needs that must be met to make our city even better.

<u>Protecting Our City and Residents</u> – The cost of public safety increases every year, and Oceanside receives no state funding for public safety, so the city needs additional resources to maintain safety and provide adequate police

officers, firefighters, paramedics, and lifeguards.



<u>Repairing and Maintaining Neighborhood Streets</u> – Improving local streets, sidewalks, and essential infrastructure is needed to keep Oceanside safe. Making necessary improvements to our streets and repairing potholes also ensures that our streets and sidewalks enhance and complement rather than detract from our beautiful natural environment.

<u>Local Funding For Local Services</u> – To fund these improvements, the City is considering a one-half cent sales tax measure for the November 2018 ballot to ensure adequate police response to 911 emergencies, reduce gang activity, and drug related crimes. The City also wants to provide enough firefighters, paramedics, and lifeguards to respond to 911 calls. Oceanside wants to be able to maintain streets and sidewalks, repair public infrastructure, and keep public areas clean and free of graffiti.

<u>Strict Fiscal Accountability</u> – All money raised by the proposed measure would remain in Oceanside, and could not be taken away by the state. The measure would require citizens' oversight and public audits. The sales tax measure is proposed to last for 7 years.

In response to a query about the downtown Fire Station #1, Chief RICK ROBINSON said his department needs to develop a new fire station for their long trucks to be able to turn around, as well as to serve as an Emergency OPS Center.


