knew the answer was not a member).



DAVID NYDEGGER was \$5 happy that he could score a program for today. (He must feel sorta snake bitten, because of









the seven speakers he had scheduled at various times for April, only three of them actually came through!)



DAVID then introduced our PROGRAM:

RICK WRIGHT is a third-generation Californian who has lived in Oceanside for most of his adult life. He first became interested in downtown revitalization as the owner of a retail store in downtown



Oceanside and was instrumental in transforming the Downtown Business Association into a designated Main Street Community in 2000. After serving in various volunteer capacities for Main Street Oceanside, he accepted the Executive Director position in 2009.

DAVID N. then apologized for scooting, but he has a 7 year old in a play – a talent show, and the 7 year-old is singing a Bob Marley song, so he had to leave before the program. So he left.

RICK started out by saying that Main Street Oceanside has the biggest geographical area and budget of any Main Street city in California. They have received some very small grants, but no direct government funds – and in spite of that their revenue was over \$1M this year. They have 5 full-time and 12 part-time employees.

RICK spent most of his 20 minutes describing the Nine Block Master Plan that was devised in 1991 in cooperation with the California Coastal Commission. Part of the area now is owned by the Southern Ute Indian tribe from Colorado who are interested in developing the downtown area.

The Coastal Commission required that the hotel rooms needed to be built before anything else can go in. Springhill Suites is now there (where Hello Betty restaurant is), so now they move forward to build other parts of the planned development. Block 18 is under construction now: Retail and residential (The plan is to rent the units out as apartments, but eventually they may be sold as condos). Apartments may be better than RICK originally thought, since at least they will be occupied, as opposed to condos which seem to be used as weekend getaways for the most part and are generally empty during the week.

Lot 23 (city owned surface parking) will be a public-private partnership to build a five story parking structure with residential units included (wrapped around the parking structure). While construction is going on, parking downtown will be a real problem.

The Southern Ute tribe is in discussions with the city about the other lots – they would like to increase the density, but the community has already decided on building height and density standards.

Next RICK touched on the planned Resort Hotel – (the famous, long in coming, onagain, off-again Resort Hotel): The block for that planned facility was cleared for development by eminent domain. They have removed all of the buildings except for the Top Gun house which will be moved (maybe) to one of the other lots. The Resort Hotel will have underground parking, be 6 stories high, with a 2600 sq ft restaurant. This project is still tied up in litigation (Corey Briggs), so it's hard to tell when (or if) any of this will happen.

JANET LACY asked – Is there any plan to repaint the Top Gun house to its original décor? The contractors who painted the Springhill Suites painted the house at the same time, so they just used the same paint as Springhill Suites. What about the mural – will the picture of Tom Cruise stay? That is uncertain, but RICK can't imagine that the structure will move very well. His guess is that in the end there will be a reproduction of the house that was in the movie rebuilt at some location downtown, but it would probably not be the actual original house.

The Wyndham Oceanside Resort is full all the time. They have 32 hotel rooms in addition to the timeshares. Once the other hotels are built they will convert those hotel rooms to timeshares as well, because operating such a limited hotel is an operational challenge.

Parking near the pier is going away, which will likely be an issue for beachgoers. Once the parking structure is completed it will add 200 more spaces compared to what's there now. The transit center is going to be redone which will also add more spaces, but the lack of parking in general will also hurt downtown businesses.

JANET also inquired – Is the one-way traffic on Mission working? YES. It has worked nicely, and people are managing to do the reverse angle parking. It isn't much different than parallel parking (VICKIE PROSSER laughed and commented: Yes it is!). RICK's view is that they're the same in that the people behind you have to figure out what you're doing. Reverse angle parking is being pushed by the bicycling community. DEAN ANDERSEN, as a cyclist, says he really likes it. You don't have to be worried about kids being hit by cars, since the sidewalks are wider.

Street furniture seems to be working out fine, and there haven't been problems. Diverting the eastbound traffic out via Seagaze Drive has actually sparked some economic development on that street which was kind of dead before.

RENEE then presented RICK with a Certificate for a donation in his name to Brother Benno's.


