
Master of Ceremonies," at least for the nonce.

PROGRAM

PP JIM introduced DEANNA LORSON who provided today's program.

DEANNA serves as Assistant City Manager for the City of Oceanside and leads the City's economic development team. She oversees the Development Services, Water Utilities and Public Works Departments, as well as the Economic Development and Information Technology divisions.

Prior to joining the City of Oceanside in February of 2016, DEANNA served as Assistant City Manager for the City of Riverside, where she led a variety of City Departments, primarily focused on economic development. Before becoming Assistant City Manager in 2011, she served as Development Director for the City of Riverside for two years, directing redevelopment; economic development & marketing; housing & neighborhoods; arts & culture; real property services; and capital projects.

DEANNA has thirty years of local government experience, beginning as an intern with the City of Redlands while a student at the University of Redlands. Upon

graduating with honors with a Bachelor of Arts in Business Administration and International Relations, she went to work for the City of Corona Planning Department. In 1994, DEANNA joined the Riverside County Economic Development Agency (EDA). During her fifteen years at EDA, she held a variety of positions including serving as Managing Director from 2007 to 2009. As Managing Director, DEANNA was responsible for daily operation of all of EDA's programs including economic development & marketing, redevelopment, community services, workforce development, aviation, housing, fair, museum, finance and administration.

DEANNA holds a Master of Public Administration from California State University, San Bernardino where she sat on the Program Advisory Board and served as an adjunct professor. She lives in Oceanside with her husband and two teenage daughters.

City of Oceanside Update

DEANNA started off with some Oceanside statistics, and then focused on new businesses going in all over town, among them The Fin, a new hotel downtown that took over from the old Dolphin hotel that closed in 2015. She was pleased to report that Oceanside now has 10 breweries and brew pubs! This is a partial list of some of the current projects taking shape in Oceanside:

- WINCO foods, an employee owned grocery store out of Boise
- Big Lots is going in where Ralph's used to be on Oceanside Blvd near I-5
- North Beach Promenade where a parking lot used to be near the pier
- Residential units downtown
- Many varied restaurants

- Airport office building
- SD Malkin Beach Resort

- Fairfield Inn and Suites
- Inns at Buena Vista Creek 3 hotels at Jefferson and Highway 78
- Restaurants (Dunkin Donuts, Blade 1936 and others)
- A new city project at the beach new beach restrooms and police building
- Housing construction 2,158 units pending!

Economic Development

- Business walk program a committee interviewed business owners to see what's working in Oceanside and what isn't
- Agritourism Oceanside to encourage agribusiness
- "Tis the season to shop local" campaign the 2016 campaign was successful, so that will held again the Saturday after Thanksgiving 2018

Questions:

RUDY – asked about art and culture in the city: that wasn't mentioned. DEANNA said that arts do contribute, but the focus of her presentation was on businesses and she pointed out that the city council has provided a matching fund grant for the arts.

DALE - What about setting aside open spaces? DEANNA said that El Corazon designates open spaces. There are quite a few open space areas, and any new project is required to contribute to open spaces and parks. The City is developing a parks master plan. The city's economic development plan also includes planning for funding for maintaining parks and open spaces.


MIKE CURTIN – what percentage of Oceanside is open space? DEANNA didn't know the answer to that but said she can find out.
