SPEAKER



JANET BLEDSOE LACY was then called to introduce today's speaker, one of her favorite people in the world, **Honorable Judge Michael Washington**. **Judge Washington** attended San Diego State and Cal Western School of Law. In 2013, Governor Jerry Brown appointed Judge Washington to the Superior Court. He now works at the Vista Court, and

JANET has had cases heard by him on many occasions. He thinks highly of her work ethic.

Judge Washington lived in Temecula for 15 years, then moved to San Marcos, and now lives in Oceanside (which he seems to like). He feels he shares many of Rotary's ideals as he says his life's mission is to try to serve others.



Less than 10 years ago, when he was serving as a public defense attorney, **Judge Washington** first went to Africa. He went to

help train attorneys and judges in Liberia, a West African country that had endured more than a decade of civil war and was working to rebuild its justice system. Prior to this trip, the Judge was not familiar with Liberia. Turns out it was formed by blacks in the U.S. that went back to Africa and started the country. If you google the flag of Liberia, you will find it looks much like the American flag, and their capital is Monrovia, named after President James Monroe, who was our president when their country was formed.

Liberia had a horrible electrical grid – and when electricity went off at the courthouse, it went off all over the country. Very few people had generators, so when the electricity was down, it was REALLY down. There was no army for security as they were attempting to rebuild their country. There was no way to keep track of who had been arrested or how long they had been in jail awaiting trial. There were no court reporters. Judges had to handwrite their notes when he was there the first time. And their filing system was handwritten papers in boxes stores in the judge's chambers - not a very easy way to keep things organized.

Many prisoners had been in jail longer than their sentences would've been for the crimes they committed, and their hearings had not even occurred yet. Because of such an inefficient system, many jailers (and indeed judges) accepted payoffs to let prisoners out of jail. It was a matter of taking care of their families that made the people accept bribes. Their pay was so low, any amount of money was welcome. It was an interesting time to be there – but the people were very eager to improve their justice system.

Judge Washington has been to Africa 19 times now – also the Caribbean and Asia. Most of these trips came as part of his volunteer work with Lawyers Without Borders, a nonprofit organization he credits with helping him "understand what it is to be a world citizen." This program sends volunteer legal professionals – from attorneys to state and federal judges – around the world to teach other legal professionals tricks of the trade. The organization also works with legislatures to help craft laws.

Africa looks to the U.S. as an example of how they think the legal system should work. Two quotes from attorneys that had given up high paying jobs to work for much lower pay for their government in Liberia struck a chord with Judge Washington. They were:

- 1) "This is a way for me to be of service to my country." and
- 2) A judge told him he "wanted people to see in him that there was justice in Liberia."

At that point, **Judge Washington** decided he too wanted to become a judge. He learned from the judges in Liberia that there is an impact that he could have that goes far beyond what happens in the courtroom.

Judge Washington is now on the MLK, Jr. Scholarship Selection Committee that has their get-together at the **LACY** home every year. He is also part of JustUs Partners Foundation, a 501©(3) charitable organization that makes a difference by raising and disbursing funds and presenting awards to local nonprofits whose programs bring hope and healing to underserved youth, families and communities. PP JIM SCHRODER shared that he has been in Africa nine times and although he does agree there is crime and corruption, he strongly feels it is because of a need to survive. They do something to survive – and then they get caught. It's bad all around. **Judge Washington** said there are so many stories of resilience. It is

inspiring. In Kenya, girls are not given the same advantages as boys, but a friend of his opened a school for girls and they are excelling. They are excelling - and sharing their knowledge with others.

ROGER VANDERWERKEN asked the Judge his thoughts on the American impeachment hearings. Judge Washington said he really isn't at liberty to get into the politics of things but stressed how important it is to stay aware and to follow what's going on. "Our strength is our engagement."



PREZ TERRI thanked **Judge Washington** for a very informative and well received speech and gifted him (and **Stephanie** too) with their choice of Cheetos or Chocolates. They both chose Chocolates! And **Judge Washington** chose the book <u>Gets a Break</u> to sign and be donated to one of our schools.
