


PROGRAM



PP RENEE RICHARDSON introduced our speaker PAUL CHO. As many of you know, I believe you need to attend our meeting to really enjoy the program. In this particular case, it was very true. Here are a few highlights of his presentation.

PAUL joined LifeArk SPC, a modular housing system company, as the Chief Financial Officer after serving as the COO/CFO of The Illumination Foundation, a non-profit which he co-founded 17 years ago to provide housing and healthcare services to the most vulnerable homeless population in Southern California. Prior to his non-profit work, he was an investment







private equity transactions in New York, Tokyo, Hong Kong, Singapore, and Seol. A graduate of Harvard University with a BA in Economics, Paul has a connection with Rotary, as a Rotary Internation Fellow in Japan in 1985.

At age 40, and after 15 years in investment banking with Goldman Sachs, PAUL left and moved his family to the Irvine area. At that time, he became aware of the poor facilities available for homeless families in Orange County. As a result, he started a non-profit organization to address the need of homeless families and particularly their children. They tried to help families being discharged from hospitals to find housing which, in 2007, was hard to do and extremely expensive. As a result, PAUL then joined LifeArk to try and resolve this issue.

With the use of plastic, up to 30% of which is recycled, LifeArk created a lightweight building block which can be converted easily into inexpensive housing.

The title LifeArk stems from its creator, a gentleman who developed housing for the indigenous people living along the banks of the Amazon River who routinely experience crises nearly 9 months every year due to a thirty-foot rise and fall of water levels. He created floating houses out of plastic which gave them permanent places to live. PAUL proposed applying this to our homeless problem in the U.S.,

going through all the vigorous permitting processes required, thus the name LifeArk for Noah's ark.

The building materials are plastic, similar to that which is approved for use on cutting boards. The building blocks consist of plastic shell outer walls with 6 inches of foam inside. This offers R40 insulation and makes them lightweight. Modules are constructed (8 ft by 8 ft by 10 ft) almost in a Lego

brick manner. The preformed modules can then be assembled to build the house. The homes are on a concrete pad and about 30 inches above the ground on pillars. This allows for easy electrical and plumbing connection.

After about 5 years, approval was achieved. With this completed, they constructed their first test facility in Los Angeles County during the pandemic, opening in 2022, and housing 18 individuals. This was their proof-of-concept project, costing about \$190,000 per unit all inclusive. This is in comparison to similar projects in Los Angles costing nearly \$600,000/unit. LifeArk provides the units, and the cities provide the site and manage the facility upon completion. Our speaker proceeded to answer numerous questions, explaining the multiple applications this concept has for housing for the homeless and possible other uses.

After checking with Madame Secretary RENEE and with the ringing of the club bell, Co-Pres PAUL WENDEE brought our meeting to a close.




FRIENDSHIP ACROSS THE BORDER

Saturday, they attended the Day of the Dead Celebration. Again a night of exchange and Fellowship!






ROTARIANS OUT AND ABOUT
